Pursuant to §21670.3, the San Diego County Regional Airport Authority serves as the Commission.

The indication of a recommended action does not indicate what action (if any) may be taken. *Please note that agenda items may be taken out of order.* If comments are made to the Commission without prior notice or are not listed on the Agenda, no specific answers or responses should be expected at this meeting pursuant to State law.

CONSISTENCY DETERMINATION SAN DIEGO INTERNATIONAL AIRPORT (SDIA) AIRPORT LAND USE COMPATIBILITY PLAN (ALUCP) April 21, 2016

Recommendation: Conditionally Consistent

CONSTRUCTION OF 25 ATTACHED RESIDENTIAL UNITS WITH LEASABLE COMMERCIAL SPACE AT 2466 FIRST AVENUE. CITY OF SAN DIEGO

<u>Description of Project</u>: Based on plans submitted to the ALUC, the project proposes the construction of two buildings of 3-stories each with underground parking for a total of 25 residential units and 6,200 square feet of leasable commercial space on a property of 0.69 acres. The application was deemed complete by ALUC staff on March 23, 2016.

Noise Contours: The proposed project is located within the 60-65 decibel Community Noise Equivalent Level (dB CNEL) noise contour. (See the attached map.) The ALUCP identifies commercial uses located within the 60-65 dB CNEL noise contour as compatible and residential uses as conditionally compatible with airport uses, provided that the residences are sound attenuated to 45 dB CNEL interior noise level.

<u>Airspace Protection Surfaces:</u> The height of the proposed project structures will be 50 feet above ground level. The proposed project is located outside the SDIA Threshold Siting Surface (TSS). The proposed project would be compatible with the ALUCP airspace protection surfaces, provided that the structures are marked and lighted in accordance with a determination of no hazard to air navigation issued by the Federal Aviation Administration (FAA).

<u>Safety Zones:</u> The proposed project is located within Safety Zone 3 Northeast – Uptown. The ALUCP identifies a mixture of residential and nonresidential uses located within Safety Zone 3 Northeast – Uptown as conditionally compatible with airport uses, provided that the 0.69 acre project site complies with a total intensity of 192 people, with a maximum of half (96 people) for the residential component. Using the 1.48 persons per household, 96 total residents would translate into a maximum allowance of 37 units, but the project only proposes 25 units, or 37 people total (at 1.48 people per unit). The project proposes 5,300 square feet of retail sales and 900 square feet of eating and drinking establishment. Using the use occupancy factors of 170 square feet per person for retail sales and 60 square feet per person for eating and drinking

establishment, the project would yield 31 retail occupants and 15 eating and drinking establishment occupants, for a total of 46 nonresidential occupants. The project thus proposes a total of 83 people (37 residents and 46 nonresidential occupants) on a property where 192 people would be allowed and therefore complies with the Safety Zone 3 Northeast – Uptown limitation.

Overflight Notification Area: The proposed project is located within the overflight notification area. The ALUCP requires that an overflight notification for new residential land uses be recorded with the County Recorder or other alternative method as approved by the ALUC.

Interests Disclosure: The property is owned by GLP Properties, Ltd of San Diego, whose agent is disclosed as Charles L. Goldberg. The developer is American National Investments, Inc. of San Diego, whose CEO and Chair of the Board is disclosed as Gina Champion-Cain. The architect is Carrier Johnson of San Diego. The civil engineer is Fuscoe Engineering, Inc. of San Diego. The landscape architect is GMP Landscape Architecture of San Diego. The traffic engineer is Urban Systems Associates, Inc. of San Diego. The environmental consultant is RECON Environmental, Inc. of San Diego.

<u>Recommendation</u>: Based on review of the materials submitted in connection with the proposed project and the policies in the SDIA ALUCP, staff recommends that the ALUC make the determination that the project is conditionally consistent with the SDIA ALUCP.

Conditions: 1) Sound attenuation to an interior noise level of 45 dB CNEL.

- 2) Marking and lighting of structures in accordance with FAA standards.
- 3) Recordation of an overflight notification with the County Recorder or other alternative method as approved by the ALUC.




RESOLUTION NO. 2016-0009 ALUC

A RESOLUTION OF THE AIRPORT LAND USE COMMISSION FOR SAN DIEGO COUNTY MAKING DETERMINATION THAT THE PROPOSED PROJECT: CONSTRUCTION OF 25 ATTACHED RESIDENTIAL **UNITS** WITH **LEASABLE** COMMERCIAL SPACE AT 2466 FIRST AVENUE, CITY OF SAN DIEGO, IS CONDITIONALLY CONSISTENT WITH THE DIEGO SAN INTERNATIONAL AIRPORT - AIRPORT LAND USE COMPATIBILITY PLAN.

WHEREAS, the Board of the San Diego County Regional Airport Authority, acting in its capacity as the Airport Land Use Commission (ALUC) for San Diego County, pursuant to §21670.3 of the California Public Utilities Code, was requested by the City of San Diego to determine the consistency of a proposed project: Construction of 25 Attached Residential Units with Leasable Commercial Space at 2466 First Avenue, City of San Diego, which is located within the Airport Influence Area (AIA) for the San Diego International Airport (SDIA) Airport Land Use Compatibility Plan (ALUCP), adopted and amended in 2014; and

WHEREAS, the plans submitted to the ALUC for the proposed project indicate that it would involve the construction of 25 attached residential units and leasable commercial space; and

WHEREAS, the proposed project would be located within the 60-65 decibel (dB) Community Noise Equivalent Level (CNEL) noise contour, and the ALUCP identifies commercial uses located within the 60-65 dB CNEL noise contour as compatible and residential uses as conditionally compatible with airport uses, provided that the residences are sound attenuated to 45 dB CNEL interior noise level; and

WHEREAS, the proposed project is located outside the SDIA Threshold Siting Surface (TSS) height restrictions and is would be compatible with the ALUCP airspace protection surfaces, provided that the structure is marked and lighted in accordance with a determination of no hazard to air navigation issued by the Federal Aviation Administration (FAA); and

WHEREAS, the proposed project is located within Safety Zone 3 Northeast – Uptown, and the ALUCP identifies mixed residential and nonresidential uses located within Safety Zone 3 Northeast – Uptown as conditionally compatible with airport uses, provided that the 0.69 acre project site complies with a total intensity of 192 people with a maximum of half that figure allowed for the residential component; and

WHEREAS, the proposed project is located within the overflight notification area, and the ALUCP requires recordation of an overflight notification with the County Recorder for new residential land uses or other alternative method as approved by the ALUC; and

WHEREAS, the ALUC has considered the information provided by staff, including information in the staff report and other relevant material regarding the project; and

WHEREAS, the ALUC has provided an opportunity for the City of San Diego and interested members of the public to present information regarding this matter:

NOW, THEREFORE, BE IT RESOLVED that the ALUC determines that the proposed project: Construction of 25 Attached Residential Units with Leasable Commercial Space at 2466 First Avenue, City of San Diego, is conditionally consistent with the SDIA ALUCP, which was adopted and amended in 2014, based upon the following facts and findings:

- (1) The proposed project involves the construction of 25 attached residential units and leasable commercial space.
- (2) The proposed project is located within the 60-65 dB CNEL noise contour. The ALUCP identifies commercial uses located within the 60-65 dB CNEL noise contour as compatible and residential uses as conditionally compatible with airport uses, provided that the residences are sound attenuated to 45 dB CNEL interior noise level. Therefore, as a condition of project approval, the residences must be sound attenuated to 45 dB CNEL interior noise level.
- (3) The proposed project is located outside the TSS. The proposed project would be compatible with the ALUCP airspace protection surfaces, provided that the structure is marked and lighted in accordance with a determination of no hazard to air navigation issued by the FAA. Therefore, as a condition of project approval, the structure shall be marked and lighted in accordance with FAA standards.
- (4) The proposed project is located within Safety Zone 3 Northeast Uptown. The ALUCP identifies a mixture of residential and nonresidential uses located within Safety Zone 3 Northeast Uptown as conditionally compatible with airport uses, provided that the 0.69 acre project complies with a total intensity of 192 people. The project proposes 83 total people.

- (5) The proposed project is located within the overflight notification area. The ALUCP requires recordation of an overflight notification with the County Recorder for new residential land uses or other alternative method as approved by the ALUC. Therefore, as a condition of project approval, an overflight notification shall be recorded with the County Recorder on each property containing a residential unit or other alternative method as approved by the ALUC.
- (6) Therefore, if the proposed project contains the above-required conditions, the proposed project would be consistent with the SDIA ALUCP.

BE IT FURTHER RESOLVED that the ALUC finds this determination is not a "project" as defined by the California Environmental Quality Act (CEQA), Cal. Pub. Res. Code §21065, and is not a "development" as defined by the California Coastal Act, Cal. Pub. Res. Code §30106.
