Pursuant to §21670.3, the San Diego County Regional Airport Authority serves as the Commission.

The indication of a recommended action does not indicate what action (if any) may be taken. *Please note that agenda items may be taken out of order.* If comments are made to the Commission without prior notice or are not listed on the Agenda, no specific answers or responses should be expected at this meeting pursuant to State law.

## Policy for Public Participation in Board, Airport Land Use Commission (ALUC), and Committee Meetings (Public Comment)

- 1) Persons wishing to address the Board, ALUC, and Committees shall complete a "Request to Speak" form prior to the initiation of the portion of the agenda containing the item to be addressed (e.g., Public Comment and General Items). Failure to complete a form shall not preclude testimony, if permission to address the Board is granted by the Chair.
- 2) The Public Comment Section at the beginning of the agenda is limited to eighteen (18) minutes and is reserved for persons wishing to address the Board, ALUC, and Committees on any matter for which another opportunity to speak is not provided on the Agenda, and on matters that are within the jurisdiction of the Board. A second Public Comment period is reserved for general public comment later in the meeting for those who could not be heard during the first Public Comment period.
- 3) Persons wishing to speak on specific items listed on the agenda will be afforded an opportunity to speak during the presentation of individual items. Persons wishing to speak on specific items should reserve their comments until the specific item is taken up by the Board, ALUC and Committees. Public comment on specific items is limited to twenty (20) minutes ten (10) minutes for those in favor and ten (10) minutes for those in opposition of an item. Each individual speaker will be allowed three (3) minutes, and applicants and groups will be allowed five (5) minutes.
- 4) If many persons have indicated a desire to address the Board, ALUC and Committees on the same issue, then the Chair may suggest that these persons consolidate their respective testimonies.

  Testimony by members of the public on any item shall be limited to three (3) minutes per individual speaker and five (5) minutes for applicants, groups and referring jurisdictions.
- 5) Pursuant to Authority Policy 1.33 (8), recognized groups must register with the Authority Clerk prior to the meeting.
- 6) After a public hearing or the public comment portion of the meeting has been closed, no person shall address the Board, ALUC, and Committees without first obtaining permission to do so.

Report of Land Use Actions Determined to be Consistent with Airport Land Use Compatibility Plans (ALUCPs)

Meeting Date: January 5, 2017

Pursuant to Airport Authority Policy 8.30, and acting in its delegated capacity as the Airport Land Use Commission (ALUC) for San Diego County, Airport Authority staff has determined that the following land use actions are consistent with their respective ALUCPs:

#### San Diego International Airport (SDIA) ALUCP

#### Golden Hill Community Plan Update & Rezones, City of San Diego

Deemed Complete & Consistent on December 14, 2016

<u>Description of Project</u>: The proposed project involves the update of a community plan with rezones that provide some increased density and intensity allowances, without any physical construction proposed.

Noise Contours: The proposed project is located within the 60-65 and 65-70 dB CNEL noise contours, but no physical construction is proposed. The City General Plan Noise Element and Municipal Code implement the sound attenuation and avigation easement requirements of the SDIA ALUCP as applicable for residential and nonresidential land uses, with the clarification that ALUCP standards apply when they are more restrictive.

<u>Airspace Protection Surfaces</u>: The proposed project is in compliance with the ALUCP airspace protection surfaces because there are no proposed increases in zoning height limits and no physical construction is proposed by the project.

<u>Safety Zones</u>: The proposed project is located outside all safety zones.

Overflight Notification: The proposed project is located within the overflight notification area. The City provides overflight notification to affected properties through the Airport Environs Overlay Zone (AEOZ), but no physical construction is proposed by this project.

#### **Brown Field Municipal Airport ALUCP**

#### San Ysidro Community Plan Update & Rezones, City of San Diego

Deemed Complete & Consistent on December 19, 2016.

<u>Description of Project</u>: The proposed project involves the update of a community plan with rezones that include changes to building height limits, without any physical construction proposed.

<u>Noise Contours</u>: The proposed project is located outside the 60-65 dB CNEL noise contour. The ALUCP identifies all uses located outside the 60-65 dB CNEL noise contour as compatible with airport uses.

<u>Airspace Protection Surfaces</u>: The proposed project is in compliance with the ALUCP airspace protection surfaces because the proposed increases in zoning height limits do not penetrate any airspace protection surfaces, and no physical construction is proposed by the project.

<u>Safety Zones</u>: The proposed project is located outside all safety zones.

<u>Overflight Notification</u>: The proposed project is located outside the overflight notification area.

## CONSTRUCTION OF 18 ATTACHED RESIDENTIAL UNITS AT 2603 DOVE STREET. CITY OF SAN DIEGO

<u>Description of Project</u>: Based on plans submitted to the ALUC, the project proposes the construction of 18 attached residential units in four levels on a property of 0.46 acres with an existing dwelling unit. The application was deemed complete by ALUC staff on December 15, 2016.

Noise Contours: The proposed project is located within the 65-70 decibel Community Noise Equivalent Level (dB CNEL) noise contour. (See the attached map.) The ALUCP identifies residential uses located within the 65-70 dB CNEL noise contour as conditionally compatible with airport uses, provided that the residences are sound attenuated to 45 dB CNEL interior noise level. The ALUCP requires that an avigation easement for aircraft noise and height be recorded with the County Recorder.

<u>Airspace Protection Surfaces:</u> The height of the proposed project structure will be 56 feet above ground level. The proposed project is located outside the SDIA Threshold Siting Surface (TSS). The proposed project is in compliance with the ALUCP airspace protection surfaces because a determination of no hazard to air navigation has been issued by the Federal Aviation Administration (FAA).

<u>Safety Zones:</u> The proposed project is located outside all Safety Zones.

Overflight Notification Area: The proposed project is located within the overflight notification area. The ALUCP requires that an overflight notification for new residential land uses be recorded with the County Recorder. However, in instances when an avigation easement is required, no additional overflight notification is required.

Interests Disclosure: The property is owned by Joseph Tonello of San Diego. The general contractor is InDev LLC, whose members are disclosed as Zacary Stover, Matthew Mellos, and Jonathan Hamby. The structural engineer is



Envision Engineering of La Jolla. The mechanical, electrical and plumbing engineer is Vander Veen Engineering of Temecula.

<u>Recommendation</u>: Based on review of the materials submitted in connection with the proposed project and the policies in the SDIA ALUCP, staff recommends that the ALUC make the determination that the project is conditionally consistent with the SDIA ALUCP.

<u>Conditions:</u> 1) Sound attenuation to an interior noise level of 45 dB CNEL. 2) Recordation of an avigation easement with the County Recorder.



#### RESOLUTION NO. 2017-0001 ALUC

A RESOLUTION OF THE AIRPORT LAND USE COMMISSION FOR SAN DIEGO COUNTY MAKING A DETERMINATION THAT THE PROPOSED PROJECT: CONSTRUCTION OF 18 ATTACHED RESIDENTIAL UNITS AT 2603 DOVE STREET, CITY OF SAN DIEGO, IS CONDITIONALLY CONSISTENT WITH THE SAN DIEGO INTERNATIONAL AIRPORT - AIRPORT LAND USE COMPATIBILITY PLAN.

WHEREAS, the Board of the San Diego County Regional Airport Authority, acting in its capacity as the Airport Land Use Commission (ALUC) for San Diego County, pursuant to §21670.3 of the California Public Utilities Code, was requested by the City of San Diego to determine the consistency of a proposed project: Construction of 18 Attached Residential Units at 2603 Dove Street, City of San Diego, which is located within the Airport Influence Area (AIA) for the San Diego International Airport (SDIA) Airport Land Use Compatibility Plan (ALUCP), adopted and amended in 2014; and

WHEREAS, the plans submitted to the ALUC for the proposed project indicate that it would involve the construction of 18 attached residential units; and

WHEREAS, the proposed project would be located within the 65-70 decibel (dB) Community Noise Equivalent Level (CNEL) noise contour, and the ALUCP identifies residential uses located within the 65-70 dB CNEL noise contour as conditionally compatible with airport uses, provided that the residences are sound attenuated to 45 dB CNEL interior noise level and that an avigation easement is recorded with the County Recorder; and

WHEREAS, the proposed project is located outside the SDIA Threshold Siting Surface (TSS) height restrictions and would be compatible with the ALUCP airspace protection surfaces because a determination of no hazard to air navigation has been issued by the Federal Aviation Administration (FAA); and

WHEREAS, the proposed project is located outside all Safety Zones; and

WHEREAS, the proposed project is located within the overflight notification area, and the ALUCP requires recordation of an overflight notification with the County Recorder for new residential land uses or other alternative method as approved by the ALUC, but does not require an additional overflight notification where an avigation easement is required; and

WHEREAS, the ALUC has considered the information provided by staff, including information in the staff report and other relevant material regarding the project; and

WHEREAS, the ALUC has provided an opportunity for the City of San Diego and interested members of the public to present information regarding this matter.

NOW, THEREFORE, BE IT RESOLVED that the ALUC determines that the proposed project: Construction of 18 Attached Residential Units at 2603 Dove Street, City of San Diego, is conditionally consistent with the SDIA ALUCP, which was adopted and amended in 2014, based upon the following facts and findings:

- (1) The proposed project involves the construction of 18 attached residential units.
- (2) The proposed project is located within the 65-70 dB CNEL noise contour. The ALUCP identifies residential uses located within the 65-70 dB CNEL noise contour as compatible with airport uses, provided that the residences are sound attenuated to 45 dB CNEL interior noise level and that an avigation easement is recorded with the County Recorder. Therefore, as a condition of project approval, the residence must be sound attenuated to 45 dB CNEL interior noise level and an avigation easement must be recorded with the County Recorder.
- (3) The proposed project is located outside the TSS. The proposed project is in compliance with the ALUCP airspace protection surfaces because a determination of no hazard to air navigation has been issued by the FAA.
- (4) The proposed project is located outside all Safety Zones.
- (5) The proposed project is located within the overflight notification area. The ALUCP requires recordation of an overflight notification with the County Recorder for new residential land uses or other alternative method as approved by the ALUC, but does not require an additional overflight notification where an avigation easement is required.
- (6) Therefore, if the proposed project contains the above-required conditions, the proposed project would be consistent with the SDIA ALUCP.

## CONSTRUCTION OF A GAS STATION WITH CONVENIENCE MARKET & AUTOMATED CAR WASH AT 2499 PACIFIC HIGHWAY, CITY OF SAN DIEGO

<u>Description of Project</u>: Based on plans submitted to the ALUC, the project proposes the construction of a gas station of two 3-pump islands with a convenience market of 3,110 square feet and an automated car wash of 900 square feet on a property of 0.45 acres. The application was deemed complete by ALUC staff on December 15, 2016.

Noise Contours: The proposed project is located within the 75+ decibel Community Noise Equivalent Level (dB CNEL) noise contour. (See the attached map.) The ALUCP identifies retail uses located within the 75+ dB CNEL noise contour as conditionally compatible with airport uses, provided that the buildings are sound attenuated to 50 dB CNEL interior noise level.

Airspace Protection Surfaces: The height of the proposed project structure will be 23 feet above ground level. The proposed project is located within the SDIA Threshold Siting Surface (TSS). The maximum allowable height for a project on this site is approximately 101 feet Above Ground Level (AGL), and the structure is approximately 23 feet AGL. Therefore, the project complies with the TSS. The proposed project would be compatible with the ALUCP airspace protection surfaces, provided that the structure is marked and lighted in accordance with a determination of no hazard to air navigation issued by the Federal Aviation Administration (FAA).

<u>Safety Zones:</u> The proposed project is located within Safety Zone 3 Southeast – Little Italy. The ALUCP identifies retail uses located within Safety Zone 3 Southeast – Little Italy as conditionally compatible with airport uses, provided that the project complies with an intensity of 732 people per acre at an occupancy factor of 170 square feet per person. The subject property of 0.45 acres would allow 329 total people, and the project proposes a 3,110 square foot convenience market, which, at 170 square foot per person, would yield 18 total people, and therefore complies with the Safety Zone 3 Southeast – Little Italy limitation (See attached map).

Overflight Notification Area: The proposed project is located within the overflight notification area, but does not involve any new residential use subject to overflight notification requirements.

<u>Interests Disclosure:</u> The property is owned by Orams Enterprises, Inc. of Lakeside, whose officers are disclosed as Khairi and Diane Mansour. The architect is Hagman Associates of San Diego. The consultant is Ronald Lacey of San Diego.

<u>Recommendation</u>: Based on review of the materials submitted in connection with the proposed project and the policies in the SDIA ALUCP, staff recommends that the ALUC make the determination that the project is conditionally consistent with the SDIA ALUCP.

<u>Conditions:</u> 1) Sound attenuation to an interior noise level of 50 dB CNEL. 2) Marking and lighting of structures in accordance with FAA design standards.




#### RESOLUTION NO. 2017-0002 ALUC

A RESOLUTION OF THE AIRPORT LAND USE COMMISSION FOR SAN DIEGO COUNTY MAKING A DETERMINATION THAT THE PROPOSED PROJECT: CONSTRUCTION OF A GAS STATION WITH CONVENIENCE MARKET & AUTOMATED CAR WASH AT 2499 PACIFIC HIGHWAY, CITY OF SAN DIEGO, IS CONDITIONALLY CONSISTENT WITH THE SAN DIEGO INTERNATIONAL AIRPORT - AIRPORT LAND USE COMPATIBILITY PLAN.

WHEREAS, the Board of the San Diego County Regional Airport Authority, acting in its capacity as the Airport Land Use Commission (ALUC) for San Diego County, pursuant to §21670.3 of the California Public Utilities Code, was requested by the City of San Diego to determine the consistency of a proposed project: Construction of a Gas Station with Convenience Market & Automated Car Wash at 2499 Pacific Highway, City of San Diego, which is located within the Airport Influence Area (AIA) for the San Diego International Airport (SDIA) Airport Land Use Compatibility Plan (ALUCP), adopted and amended in 2014; and

WHEREAS, the plans submitted to the ALUC for the proposed project indicate that it would involve the construction of a gas station with convenience market and automated car wash; and

WHEREAS, the proposed project would be located within the 75+ decibel (dB) Community Noise Equivalent Level (CNEL) noise contour, and the ALUCP identifies retail uses located within the 75+ dB CNEL noise contour as compatible with airport uses, provided that the buildings are sound attenuated to 50 dB CNEL interior noise level; and

WHEREAS, the proposed project is in compliance with the SDIA Threshold Siting Surface (TSS) height restrictions and would be compatible with the ALUCP airspace protection surfaces, provided that the structure is marked and lighted in accordance with a determination of no hazard to air navigation issued by the Federal Aviation Administration (FAA); and

WHEREAS, the proposed project is located within Safety Zone 3 Southeast – Little Italy, and the ALUCP identifies retail uses located within Safety Zone 3 Southeast – Little Italy as conditionally compatible with airport uses, provided that the project complies with an intensity of 732 people per acre; and Resolution No. 2017-0002 ALUC Page 2 of 3

WHEREAS, the proposed project is located within the overflight notification area, but does not involve any new residential use subject to overflight notification requirements; and

WHEREAS, the ALUC has considered the information provided by staff, including information in the staff report and other relevant material regarding the project; and

WHEREAS, the ALUC has provided an opportunity for the City of San Diego and interested members of the public to present information regarding this matter.

NOW, THEREFORE, BE IT RESOLVED that the ALUC determines that the proposed project: Construction of a Gas Station with Convenience Market & Automated Car Wash at 2499 Pacific Highway, City of San Diego, is conditionally consistent with the SDIA ALUCP, which was adopted and amended 2014, based upon the following facts and findings:

- (1) The proposed project involves the construction a gas station with convenience market and automated car wash.
- (2) The proposed project is located within the 75+ dB CNEL noise contour. The ALUCP identifies retail uses located within the 75+ dB CNEL noise contour as compatible with airport uses, provided that the buildings are sound attenuated to 50 dB CNEL interior noise level. Therefore, as a condition of project approval, the structures must be sound attenuated to 50 dB CNEL interior noise level.
- (3) The proposed project is located within the TSS. The maximum allowable height for a project on this site is approximately 101 feet Above Ground Level (AGL). The maximum height of the proposed project is approximately 23 feet AGL. The proposed project would be compatible with the ALUCP airspace protection surfaces, provided that the structure is marked and lighted in accordance with a determination of no hazard to air navigation issued by the FAA. Therefore, as a condition of project approval, the structure shall be marked and lighted in accordance with FAA procedures.
- (4) The proposed project is located within Safety Zone 3 Southeast Little Italy. The ALUCP identifies retail uses located within Safety Zone 3 Southeast Little Italy as conditionally compatible with airport uses, provided that the project complies with an intensity of 732 people per acre. The 0.45-acre project site would thus be limited to 329 total people, and the project proposes 18 total people.

- (5) The proposed project is located within the overflight notification area. The ALUCP requires recordation of an overflight notification with the County Recorder only for new residential land uses.
- (6) Therefore, if the proposed project contains the above-required conditions, the proposed project would be consistent with the SDIA ALUCP.

BE IT FURTHER RESOLVED that the ALUC finds this determination is not a "project" as defined by the California Environmental Quality Act (CEQA), Cal. Pub. Res. Code §21065, and is not a "development" as defined by the California Coastal Act, Cal. Pub. Res. Code §30106.
