Authorize the Rejection of the Claim of John Zabalza

#### **Recommendation:**

Adopt Resolution No. 2012-0003, authorizing the Rejection of the Claim of John Zabalza.

## **Background/Justification:**

On December 9, 2011, John Zabalza ("Zabalza") filed a claim (Attachment A) with the Authority alleging that on July 16, 2011, he fell as he rode an escalator in Terminal One at San Diego International Airport. Zabalza claims medical costs in the amount of two hundred thirteen dollars and ninety-five cents (\$213.95) as damages.

Zabalza alleges in his claim that on July 16, 2011, he fell as he rode an escalator near Southwest Airlines in Terminal One. The claimant states he fell backwards and rolled down the escalator, injuring his head and parts of his body. Claimant states he continues to suffer from pain to his head, neck, left arm and upper back with dizziness.

Zabalza's claim should be denied. An investigation into the incident revealed no unsafe condition of public property nor any notice of an unsafe or dangerous condition, nor is a dangerous condition alleged.
