## **Authorize the Rejection of the Claim of Joy Donathan**

#### **Recommendation:**

Adopt Resolution No. 2012-0036, authorizing the Rejection of the Claim of Joy Donathan.

#### **Background/Justification:**

On February 16, 2012, Joy Donathan ("Donathan") filed a claim with the Authority alleging that sometime between February 3 and February 6, 2012, her vehicle sustained overspray damage while it was parked in the short-term parking lot in front of Terminal One at San Diego International Airport. Donathan claims damages in an unknown amount to cover the cost of overspray removal from the painted finish of the vehicle.

Donathan alleges in her claim that sometime between February 3 and February 6, 2012, while her car was parked in the short-term parking lot in front of Terminal One, it sustained "overspray" of an unknown substance from an unknown source. Donathan has been unable to remove the "overspray" through regular car washing and seeks compensation to cover the cost of removal.

Donathan's claim should be denied. An investigation into the incident revealed no spraying of any kind was done by Authority or LPI employees in any of the lots at San Diego International Airport during the time Donathan states her car was parked. Donathan was unable to describe where her car was parked and did not provide additional information when requested to assist in the investigation. Further, no unsafe condition nor any notice to the Authority of an unsafe condition was discovered during the course of the investigation.
