Background/Justification:

On January 31, 2011, Guillermina Gandarilla ("Gandarilla") filed a claim with the Authority alleging that on January 30, 2011, she fell as she rode on an escalator in Terminal Two. Gandarilla claims an unknown amount of damages.

Gandarilla alleges in her claim that on January 30, 2011, she fell as she rode an escalator in Terminal Two. She states she left the airport without reporting the incident because she felt fine but awakened to some back pain the next day. The claim is silent with regard to compensation.

Gandarilla's claim should be denied. An investigation into the incident revealed no unsafe condition of public property nor any notice of an unsafe or dangerous condition. Further, no allegation of an unsafe or dangerous condition was asserted.
