In addition, the Board has been requested to appoint a representative to the San Diego Association of Governments (SANDAG) Transportation Committee and to the southern California Association of Governments (SCAG) Aviation Task Force.

Fiscal Impact:

State law limits compensation for Board Members to \$200 per day of service, with a maximum of eight (8) days per month. Funding to pay for Board Member attendance at meetings that qualify as a day of service is included in the FY 2011-2012 Budget.
