Subject:

May 2011 Legislative Report

Recommendation:

Adopt Resolution No. 2011-0053, approving the May 2011 Legislative Report.

Background/Justification:

The Legislative Advocacy Program Policy adopted by the Board on November 10, 2003, requires Authority staff to present the Board with monthly reports concerning the status of legislation with potential impact to the Authority. The May 2011 Legislative Report updates Board members on legislative activities that have taken place during the month of April. The Authority Board can give direction to staff on legislative issues contained in the attached Legislative Report (Attachment A).

State Legislative Action

Authority staff recommends the Board adopt a Watch position on AB 662, a Watch position on SB 619, and a Support position on SB 194.

As amended by Assemblymember Hueso on March 31, 2011, AB 662 now applies to the Airport Authority's role in the development of Airport Land Use Compatibility Plans.

SB 619 would exclude flight schools from some new private post-secondary school regulations.

SB 194 is an omnibus technical corrections bill clarifying that California airport owners/operators are not required to pay a fee for the recording of avigation easements.

Federal Legislative Action

Authority staff recommends the Board adopt a Watch position on H.R. 1586, the "Security Enhancement and Jobs Act of 2011." This legislation would require the Transportation Security Administration (TSA) to act on Screening Partnership Program applications received from airports within 120 days. The bill would also require the TSA to provide airports whose applications have been denied with additional information on the basis of the denial and recommendations for approving their applications.

On April 15th, the President signed into law H.R. 1473, a comprehensive appropriations bill, funding most federal programs through the remainder of the current 2011 fiscal year. Although this legislation reduced federal spending by approximately \$38 billion, the Airport Improvement Program (AIP) remained at its current annual funding level of \$3.5 billion.

Following the April 7th Senate passage of H.R. 658, the FAA Reauthorization Bill, House and Senate conferees are attempting to reconcile differences between their two versions of the bill. Among the issues to be resolved are the length of time covered by the bill and the annual AIP funding level.

On April 20th, U.S. Transportation Secretary LaHood announced the implementation of new rules for airlines requiring reimbursement of passenger baggage fees for lost bags, providing increased compensation to passengers involuntarily bumped from flights, establishing a four-hour tarmac delay limit for international flights and foreign airlines, and requiring additional disclosure of airline fees.

May 2011 Legislative Report

State Legislation

New or Amended Legislation

Legislation/Topic

State Budget

Background/Summary

Following the March passage of \$11.2 billion in budget reductions, there remains a state budget deficit totaling \$15 billion. Governor Brown continues to consider both additional cuts and a statewide ballot measure to extend several taxes currently in place.

The Governor is expected to release his "May Revise" of the state budget on May 13, 2011. This document will provide additional information concerning the potential for additional reductions to the state budget.

Anticipated Impact/Discussion

Although the Authority's legislative team does not expect current budget considerations to impact SDIA or the Authority, they will continue to monitor this issue to identify any potential impacts.

<u>Legislation/Topic</u> AB 662 (Hueso) – San Diego County Regional Airport Authority

Background/Summary

Currently, the Authority's Board acts as the Airport Land Use Commission for San Diego County and is responsible for the preparation, adoption, and amendment of airport land use compatibility plans for each airport in San Diego County.

This bill would alter the ALUC's role in the preparation, adoption, or amendment of an airport land use compatibility plan related to the City of Coronado.

Anticipated Impact/Discussion

Authority representatives have participated in meetings with Assemblymember Hueso and other interested parties to obtain additional information concerning the potential impact of this bill on the ALUC. Staff will continue to participate in additional discussions on this legislation and report back to the Board.

<u>Legislation/Topic</u> SB 194 (Committee) – Local Government: Omnibus Bill

Background/Summary

This bill is an omnibus technical corrections bill that clarifies that California airport owners/operators are not required to pay a fee for the recording of an avigation easement.

Anticipated Impact/Discussion

The legislation benefits the Authority by eliminating the potential collection of fees from the Authority for recording avigation easements required under the Quieter Home Program.

Legislation/Topic

SB 619 (Fuller) – Flight Schools and Private Postsecondary Education

Background/Summary

The California Private Postsecondary Education Act of 2009 provides for student protections and regulatory oversight of private postsecondary schools in the state. The act is enforced by the Bureau for Private Postsecondary Education within the Department of Consumer Affairs.

This bill would exempt from the act flight instructors and flight schools that provide flight instruction pursuant to Federal Aviation Administration regulations and meet specified criteria.

Anticipated Impact/Discussion

Without this legislation, flight schools could be adversely impacted by new regulations and many might have to close due to the new requirements of the California Private Postsecondary Act of 2009. The California Airports Council, of which the Authority is a member, supports this Legislation.

Legislation/Topic SB 446 (Dutton) – Ontario International Airport

Background/Summary

The bill states the intent of the Legislature to establish the Ontario International Airport Authority and to transfer management and operational control of Ontario Airport to the new Authority.

The bill was amended to also require that the new Authority, the City of Los Angeles, the City of Ontario, the County of San Bernardino, other local and regional agencies, and the Department of Transportation to-cooperate to develop effective surface transportation access to the-Ontario International Airport.

Anticipated Impact/Discussion

Although this "spot bill" has no direct impact on the Authority, staff will continue to monitor the bill and identify any potential impact to the Authority or SDIA.

Existing Legislation

<u>Legislation/Topic</u> AB 36 (Perea) – Federal Conformity of Income and Employment Taxes

Background/Summary

This bill amends California's Personal Income and Corporation Income Tax laws to conform with federal income tax laws following the passage of the federal Patient Protection and Affordable Care Act and the Health Care and Education Reconciliation Act of 2010. Specifically, this bill would allow individuals to exclude or deduct from their state taxable income the costs of extending health benefits to adult children under the age of 27.

Anticipated Impact/Discussion

This bill would allow Authority employees to exclude or deduct medical care expenses for adult dependents under 27 years old from their income.

<u>Legislation/Topic</u> AB 76 (Harkey) – High-Speed Rail

Background/Summary

On November 4, 2008, California voters passed Proposition 1A, the "Safe, Reliable High-Speed Passenger Train Bond Act for the 21st Century," authorizing the issuance of \$9.95 billion in general obligation bonds for a high-speed rail system. This bill would reduce the amount of high-speed rail general obligation debt to the amount under contract as of January 1, 2012.

Anticipated Impact/Discussion

Although this legislation would have no direct impact on the Authority or SDIA, it could affect the potential connection of high-speed rail to the San Diego region and SDIA.

- Position: Watch (4/7/11)

Legislation/Topic

AB 133 (Galgiani) – High-Speed Rail

Background/Summary

This bill would require that federal funds made available to the state for highspeed rail purposes be available for preliminary engineering, project-level environment work, mitigation, final design, and construction for the following four segments approved by the Federal Railroad Administration: San Francisco to San Jose; Merced to Fresno; Fresno to Bakersfield; and Los Angeles to Anaheim.

Anticipated Impact/Discussion

Although this legislation would have no direct impact on the Authority or SDIA, it could affect the potential connection of high-speed rail to the San Diego region and SDIA.

<u>Legislation/Topic</u> AB 385 (Harkey) – High-Speed Rail

Background/Summary

Existing law requires the High-Speed Rail Authority to approve and submit a detailed funding plan for the development and implementation of high-speed train service to the Director of Finance, a specified peer review group, and the Legislature's transportation and fiscal committees. This bill would require the High-Speed Rail Authority to also approve and submit an investment grade analysis to those entities.

Anticipated Impact/Discussion

Although this legislation would have no direct impact on the Authority or SDIA, it could affect the potential connection of high-speed rail to the San Diego region and SDIA.

Status: 3/25/11 – Referred to the Assembly Committee on Transportation

Position: Watch (4/7/11)

Legislation/Topic

AB 471 (Lowenthal) – High-Speed Rail: Inspector General

Background/Summary

This bill would create an office of the Inspector General within the High-Speed Rail Authority, and require the High-Speed Rail Authority to appoint an Inspector General, who would serve at the pleasure of the Authority. The Inspector General would be required to prepare specified reports and audits relating to high-speed rail.

Anticipated Impact/Discussion

Although this legislation would have no direct impact on the Authority or SDIA, it could affect the potential connection of high-speed rail to the San Diego region and SDIA.

Status: 3/3/11 – Referred to the Assembly Committee on Transportation

<u>Legislation/Topic</u> AB 492 (Galgiani) – High-Speed Rail Authority

Background/Summary

This bill would authorize the High-Speed Rail authority to consider, to the extent permitted by federal and state law, the creation of jobs in California when awarding major contracts or purchasing high-speed trains.

Anticipated Impact/Discussion

Although this legislation would have no direct impact on the Authority or SDIA, it could affect the potential connection of high-speed rail to the San Diego region and SDIA.

Status: 3/3/11 – Referred to the Assembly Committee on Transportation

Position: Support (4/7/11)

<u>Legislation/Topic</u> AB 615 (Lowenthal) – High-Speed Rail

Background/Summary

Existing law generally requires the approval of the Department of General Services before a state agency may acquire, hire, dispose of, or let real property. It also requires General Services to inventory most state-owned property, and establishes the process for leasing property acquired for highway use to former owners. This bill would enact authorizations, and exemptions relative to real property obtained for high-speed rail purposes by the High-Speed Rail Authority. The bill would also enact similar exceptions, authorizations and new provisions governing acquisition or disposal of right-of-way property by the Authority. In addition, this bill would exempt the High-Speed Rail Authority from obtaining approval from the Department of Finance and State Public Works Board before expanding funds from an appropriation for capital outlay purposes.

This bill would also provide that the High-Speed Rail Authority is the responsible agency for projects under its jurisdiction.

Anticipated Impact/Discussion

Although this legislation would have no direct impact on the Authority or SDIA, it could affect the potential connection of high-speed rail to the San Diego region and SDIA.

Status: 3/3/11 – Referred to the Assembly Committee on Transportation

AB 650 (Blumenfield) – Blue Ribbon Taskforce on Public Transportation

Background/Summary

This bill would establish the Blue Ribbon Task Force on Public Transportation for the 21st Century. The bill would require the task force to be comprised of 12 members jointly appointed by the Senate Committee on Rules and the Speaker of the Assembly by March 31, 2012.

The bill would also require the task force prepare a report to the Governor, the Legislature and several legislative committees on the current state of California's transit system, and the estimated cost and potential funding sources needed by March 31, 2013.

The bill would appropriate \$750,000 from the Public Transportation Account to the Department of Transportation to accomplish these purposes.

Anticipated Impact/Discussion

Although this bill would not have any direct impact on the Authority or SDIA, it could affect transit connections to SDIA.

Status: 4/12/11 – Approved by the Assembly Committee on Transportation by a vote of 9 to 1, and referred to the Assembly Committee on Appropriations

<u>Legislation/Topic</u> AB 1377 (Butler) – Peace Officers, Airport Law Enforcement

Background/Summary

Individuals employed as airport law enforcement officers are peace authorized to carry firearms only if he or she is so authorized by the peace officer's employing agency.

This bill would place an airport law enforcement officer regularly employed by the Los Angeles World Airports within a different category of peace officers with the authority to carry specified firearms. This bill would also make legislative findings and declarations concerning the necessity of a special statute for the City of Los Angeles relating to law enforcement at the Los Angeles International Airport.

Anticipated Impact/Discussion

This bill is only relative to Airport law enforcement officers at Los Angeles World Airports.

Status: 3/21/11 – Referred to the Committee on Public Safety

Legislation/Topic

AJR 3 (Dickinson) – Federal Taxation

Background/Summary

This resolution of the State Legislature would urge the U.S. Congress to extend the alternative minimum tax (AMT) holiday for private activity bonds. The American Recovery and Reinvestment Act of 2009 exempted airport private activity bonds (pab's) issued in 2009 and 2010 from the AMT, saving airports an estimated \$1 billion. This AMT exemption expired at the end of 2010.

This exemption is expected to save the Authority approximately \$45 million over the life of the bonds issued for the Green Build.

Anticipated Impact/Discussion

This bill is sponsored by the California Airports Council. If Congress were to extend the AMT exemption for PAB's, it would benefit the Authority financially by enabling the Authority to issues future bonds at a lower interest rate.

Status: 4/14/11 – Adopted by the Assembly and referred to the Senate

Position: Support (4/7/11)

SB 295 (Price) – Community College Site Acquisition

Background/Summary

This bill removes the current obligation of the community college districts to notify the Caltrans Division of Aeronautics before locating a new school, or adding an addition onto a present school located within two miles of an airport runway. It also removes the provision prohibiting the use of state funds for the school site or addition if the community college decides to overrule the recommendation by Caltrans not to site a school.

Anticipated Impact/Discussion

If a community college's proposal is located in SDIA's Airport Influence Area, they are required to submit an application for consistency pursuant to the provisions of the Public Utilities Code. However, this bill would remove the additional layer of notice when a community college attempts to develop near an airport.

Status: 2/24/11 – Referred to the Assembly Committee on Education

Position: Watch (4/7/11)

Legislation/Topic

SB 468 (Kehoe) – State Highways in the Coastal Zone

Background/Summary

This bill would impose additional requirements on the Department of Transportation for proposed capacity-increasing state highway projects located in the coastal zone. Included in the new requirements is the completion of mass transit prior to construction of the proposed highway project.

Anticipated Impact/Discussion

This bill could impact the proposal by Caltrans to widen Interstate 5, which could affect future travelers going to and from SDIA.

<u>Status:</u> 3/15/011 – Approved by the Senate Committee on Transportation and Housing by a vote of 5 to 3 and re-referred to the Committee

Legislation/Topic SB 517 (Lowenthal) – High-Speed Rail Authority

Background/Summary

This bill would place the High-Speed Rail Authority within the Business, Transportation and Housing (BTH) Agency, and provide for the BTH Secretary to serve on the authority as a nonvoting, member. The bill would also require the Secretary to propose an annual budget for the Authority.

The bill would require the members of the Authority appointed by the Governor to be appointed with the advice and consent of the Senate. This bill would vacate the current membership of the Authority and provide for the appointment or reappointment of members by January 31, 2012, under staggered terms.

This bill also would provide that the executive director is subject to appointment with the advice and consent of the Senate, and would enact various conflict-ofinterest provisions applicable to members of the authority and its staff.

Anticipated Impact/Discussion

Although this legislation would have no direct impact on the Authority or SDIA, it could affect the potential connection of high-speed rail to the San Diego region and SDIA.

<u>Status:</u> 3/3/11 – Referred to the Senate Committee on Transportation and Housing

Position: Watch (4/7/11)

<u>Legislation/Topic</u> SB 545 (Anderson) – Transportation

Background/Summary

Under existing law there are various transportation programs to develop and implement improvements to transportation systems. This bill would state the intent of the Legislature to enact legislation enabling the state to examine efficiency in administering solutions to California's transportation needs.

Anticipated Impact/Discussion

This "spot bill" states the Legislature's intent to possibly enact legislation in the future. Staff will monitor this bill as details are provided to identify any potential impacts to SDIA or other aviation planning or operations

<u>Legislation/Topic</u> SB 749 (Steinberg) – High-Speed Rail

Background/Summary

This bill would provide that the five High-Speed Rail Authority members appointed by the Governor are subject to the advice and consent of the Senate.

Anticipated Impact/Discussion

Although this legislation would have no direct impact on the Authority or SDIA, it could affect the potential connection of high-speed rail to the San Diego region and SDIA.

<u>Status:</u> 3/3/011 – Referred to the Senate Committee on Transportation and the Senate Committee on Rules

Position: Watch (4/7/11)

<u>Legislation/Topic</u> AB 31 (Beall) – High-Speed Rail and Local Master Planning

Background/Summary

This bill would establish the High-Speed Rail Local Master Plan Pilot Program, authorizing jurisdictions with an approved high-speed rail station to participate in the program. Participating jurisdictions may prepare and adopt a master plan for development in the areas surrounding the high-speed rail system in their jurisdiction. Participating jurisdictions may collaborate with the State Air Resources Board to develop incentives to encourage development while concurrently reducing greenhouse gas emissions, consistent with or pursuant to the California Global Warming Solutions Act of 2006. Jurisdictions adopting a high-speed rail master plan may finance any publicly-owned facility or amenity necessary to implement the master plan.

Anticipated Impact/Discussion

Although this legislation is not expected to have any impact the Authority, it could impact the development of the area surrounding a high-speed rail station in San Diego.

<u>Status:</u> 3/24/10 – Amended and re-referred to the Assembly Committee on Local Government

Position: Watch (2/10/11)

<u>Legislation/Topic</u> AB 58 (Gagliani) – High-Speed Rail

Background/Summary

Existing law provides for appointment of an executive director by the Authority, who is exempt from civil service and serves at the pleasure of the authority. This bill would authorize the Governor to appoint up to six deputy directors exempt from civil service who would serve at the pleasure of the executive director.

Anticipated Impact/Discussion

Although this legislation would have no direct impact on the Authority or SDIA, it could affect the potential connection of high-speed rail to the San Diego region and SDIA.

<u>Status:</u> 3/17/11 – Amended and re-referred to the Assembly Committee on Transportation

Position: Watch (2/10/11)

Legislation/Topic

AB 81 (Beall) – Aircraft Jet Fuel Taxes

Background/Summary

This bill would exempt from state sales and use taxes gross receipts from the sale of, storage, use or consumption of fuel and petroleum products by an air common carrier provided that the gross receipts are in excess of the average spot price per gallon over the previous five years. This bill would also require the State Board of Equalization, beginning on January 1, 2013 to submit a report to the Legislature setting forth the state fiscal impact of the exemption.

Anticipated Impact/Discussion

Although this legislation would not directly impact the Authority or SDIA, it could financially benefit airlines that operating at SDIA.

Legislation/Topic AB 145 (Gagliani/Levanthal) – High-Speed Rail Governance

Background/Summary

This bill would limit the High-Speed Rail Authority policy decisions relative to implementation of high-speed rail consistent with Proposition 1A. The bill would also create the Department of High-Speed Trains within the Business, Transportation and Housing Agency, transferring certain powers and responsibilities of the Authority to the Department. The director of the Department would be appointed by the Governor, who would serve at the pleasure of the Authority, and the Governor would be authorized to appoint up to ten officers of the Department who would be exempt from civil service and serve at the pleasure of the director. The bill would also provide for acquisition and disposition by the Department of rights-of-way for the high-speed rail project.

Anticipated Impact/Discussion

Although this legislation would have no direct impact on the Authority or SDIA, it could affect the potential connection of high-speed rail to the San Diego region and SDIA.

<u>Status:</u> 3/17/11 – Amended and re-referred to the Assembly Committee on Transportation

Position: Watch (2/10/11)

Legislation/Topic

AB148 (Smyth) – Local Government Ethics Training Disclosure

Background/Summary

Existing law defines the term "ethics laws" to include, among others, laws relating to government transparency. This bill would expand the term "ethics laws" to also include compensation setting guidelines as established by specified organizations or a local agency. It would also require ethics training records for officials to be posted to the agency's website, and to submit a copy of such records to the State Controller. In addition, it requires local agencies to post their written attendance compensation policy or written reimbursement policy to the agency's website.

Anticipated Impact/Discussion

If passed, this legislation would require the Authority to post ethics training records and attendance compensation/reimbursement policy information on the Authority's website.

<u>Legislation/Topic</u> SB 22 (La Malfa) – High-Speed Rail

Background/Summary

Existing law, pursuant to the "Safe, Reliable High-Speed Passenger Train Bond Act for the 21st Century," provides for the issuance of \$9.95 billion in general obligation bonds for high-speed rail and related purposes. This bill would reduce the amount of high-speed rail general obligation debt to the amount contracted as of January 1, 2012.

Anticipated Impact/Discussion

Although this legislation would have no direct impact on the Authority or SDIA, it could affect the potential connection of high-speed rail to the San Diego region and SDIA.

<u>Status:</u> 3/3/11 – Referred to the Senate Committee on Transportation and Housing

Position: Watch (2/10/11)

Legislation/Topic

SB 186 (Kehoe) – State Controller Audit and Investigation Authority

Background/Summary

Existing law authorizes the State Controller to appoint a qualified accountant to make an investigation and to obtain the information required for the annual report of financial transactions. This bill would expand the Controller's authority, authorizing the Controller to exercise discretionary authority to perform an audit or investigation of any county, city, special district, or redevelopment agency, in order to ensure compliance with state law, grant agreements, local ordinances, and to determine fiscal viability. This bill would require the Controller to prepare a report of the results of an audit or investigation and to file a copy with the local legislative body.

Anticipated Impact/Discussion

This legislation was introduced in response to last year's controversy with the City of Bell official's salaries. Since the Authority is not considered a "special district" this legislation would have no direct impact on the Authority.

This bill was amended to delete the provision that costs incurred by the Controller shall be borne by the county, city, or redevelopment agency.

<u>Legislation/Topic</u> AB 16 (Perea) – High-Speed Rail Authority

Background/Summary

Existing law, pursuant to the "Safe, Reliable High-Speed Passenger Train Bond Act for the 21st Century", authorizes \$9.95 billion in general obligation bonds for high-speed rail development and other related purposes. The Federal American Recovery and Reinvestment Act of 2009 (ARRA) also provides funding for highspeed rail projects. This bill would require the High-Speed Rail Authority to make every effort to purchase high-speed train rolling stock and related equipment manufactured in California, consistent with federal and state laws.

Anticipated Impact/Discussion

Although this legislation would have no direct impact on the Authority or SDIA, it could affect the potential connection of high-speed rail to the San Diego region and SDIA.

Legislation/Topic

SB 49 (Strickland) – Local Government Emergency Response Fees

Background/Summary

Existing law authorizes public agencies to hold liable any person who is under the influence of an alcoholic beverage, any drug, or the combination of an alcoholic beverage and any drug, whose negligent operation of a motor vehicle, a boat or vessel, or a civil aircraft caused by that influence proximately causes any incident resulting in an appropriate emergency response, and any person whose intentionally wrongful conduct proximately causes an incident resulting in an appropriate emergency response, for the expense of that emergency response. This bill would prohibit a city, including a charter city, county, district, municipal corporation, or public authority from charging a fee to any person, regardless of residency, for the expense of an emergency response, as specified, except where a fee is otherwise authorized.

Anticipated Impact/Discussion

Under this legislation the City of San Diego and Harbor Police would be prohibited from recovering any expenses from an individual during an emergency response.

AB 23 (Smyth) – Prohibition of Simultaneous Local Agency Meetings

Background/Summary

The Brown Act requires each legislative body of a local agency to provide the time and place for holding regular meetings and requires that all meetings of a legislative body be open and public and all persons be permitted to attend unless a closed session is authorized.

This bill would prohibit the members of a legislative body, during a meeting of that legislative body, from convening simultaneous or serial order meetings of any other legislative body for which the members of the convened legislative body constitute at least a quorum.

Anticipated Impact/Discussion

If passed, this legislation would prohibit the Authority Board from holding joint committee meetings or from meeting as the Airport Land Use Commission following a Board meeting.

H.R. 1586 (King) Expanding Airport Security Screening Opt-Out Programs

Background/Summary

This bill could expand the use of private screeners at US airports that choose to hire a commercial company rather than rely on the Transportation Security Administration (TSA).

In January, TSA Administrator John Pistole curtailed the Screening Partnership Program (SSP), under which 16 airports had chosen to hire private screening companies rather than use TSA screeners.

The bill would compel TSA to act on the applications of US airports to hire private screeners within 120 days of their request. TSA must approve the application unless it can demonstrate that doing so would hurt the effectiveness of screening or otherwise harm aviation security.

Anticipated Impact/Discussion

This legislation would give SDIA the option to apply for the private screening program in the future.

H.R. 386 (Lungren) Securing Cockpits Against Lasers Act of 2011

Background/Summary

This Act amends the federal criminal code to prohibit the aiming of the beam of a laser pointer at an aircraft or in its flight path, and imposes a fine and/or prison term of up to five years. Exempts from such prohibition:

- Individuals conducting research and development or flight test operations for an aircraft manufacturer or the Federal Aviation Administration (FAA)
- Department of Defense (DOD) or Department of Homeland Security (DHS) personnel conducting research, development, operations, testing or training; or
- An individual using a laser emergency signaling device to send a distress signal.

Anticipated Impact/Discussion

Although this legislation would have no direct impact to the Authority or SDIA, it could enhance aviation safety by protecting pilots from laser interferences.

<u>Legislation/Topic</u> H.R. 674/S.89 (Herger/Vitter) IRS Code Amendment, Vendors

Background/Summary

Beginning January 1, 2012 federal, state, and local governments with total expenditures of \$100 million or more are required to withhold 3 percent from all payments for goods and services to guard against possible business tax evasion.

This bill would amend the Internal Revenue Code to repeal the imposition of the 3 percent withholding of payments.

Anticipated Impact/Discussion

This could negatively affect construction companies and could potentially force many small businesses out of the government market, increase the costs of performing public works contracts, and increase taxpayer costs.

H.R. 235 (Brady) Cut Unsustainable and Top-Heavy Spending Act of 2011

Background/Summary

This bill eliminates several federal programs including grants to large and medium hub airports under the Airport Improvement Program (AIP). This bill also rescinds any unobligated funds made available for such grants.

Anticipated Impact/Discussion

SDIA relies on AIP funding for its capital improvements program and the elimination of this funding could limit the Authority from moving forward on many projects.

<u>Legislation/Topic</u> S. 223 (Rockefeller)/ H.R. 658 (Mica) - FAA Reauthorization Act

Background/Summary

House Version:

The House is currently considering a four-year FAA Reauthorization Bill with the following provisions:

- Passenger Facility Charge (PFC) cap stays at \$4.50
- Airport Improvement Funding (AIP) cut from \$3.5 to \$3.17 billion in FY 2011 and \$3 billion annually for FY 2012-2014
 - Essential Air Service Program for most communities phased out over three years
- Creates a pilot program allowing up to 5 airports to use PFC revenue for intermodal ground access projects

Senate Version:

The Senate is currently considering a two-year Reauthorization Bill with the following provisions:

- Passenger Facility Charge (PFC) cap stays at \$4.50, but pilot program introduced for up to 6 airports where airports may impose a PFC without regard to dollar amount limitations if the airport collects the charge directly from passengers, and if approved by the Department of Transportation
- AIP funding at \$4 billion in FY 2010, and \$4.1 billion in FY 2011 (up from current \$3.5 billion)
- Increases minimum amount for discretionary AIP from \$148 million to \$520 million

<u>Status:</u> 2/17/11 – Passed in the Senate by a vote of 87 to 8 4/1/11 – Passed in the House by a vote of 223 to 196

H.R. 1473 (Rogers) The Full Year Continuing Appropriations Act of 2011

Background/Summary

The purpose of this legislation is to fund the federal government - including the programs and operations of DOT, FAA, DHS and TSA - for the remainder of the current fiscal year (2011) that runs through the end of September

Anticipated Impact/Discussion

AIP funding is proposed at its current level of \$3.5 billion.
