Subject:

Award a Contract to SOLPAC Construction, Inc. dba Soltek Pacific Construction Company to Expand Terminal 2 East Facilities: Terminal Building at San Diego International Airport

Recommendation:

Adopt Resolution No. 2011-0133, awarding a contract to SOLPAC Construction, Inc. dba Soltek Pacific Construction Company, in the amount of \$5,958,000, for Project No. 104056, Expand Terminal 2 East Facilities: Terminal Building at San Diego International Airport.

Background/Justification:

The project will expand the Terminal 2 East building between Gates 24-Gates 28 and between Gate 25-Gate 27 to increase holdroom capacity, create new concessions, provide necessary infrastructure for future use of passenger transport vehicles and relocate the existing tenant clubroom to allow for the buildout of the adjacent roof area above the American Airlines (AA) baggage make up area and create a new post-security concession area. The existing pre-security food court area will also be reconfigured to increase ticket counter queuing and passenger circulation area and to provide for new concessions.

The project has been divided into three (3) separate contract packages:

- 1. Expand Terminal 2 East Facilities: Terminal Building
- 2. Expand Terminal 2 East Facilities: Gate 24- Gate 28
- 3. Expand Terminal 2 East Facilities: Gate 25- Gate 27

This contract is for the Terminal Building work only (Item 1, above).

The Scope of Work for the contract to SOLPAC Construction, Inc., includes relocation of the clubroom, creation of the new post-security concessions area and the reconfiguration of the existing pre-security food court area.

A RESOLUTION OF THE BOARD OF THE SAN DIEGO COUNTY REGIONAL AIRPORT AUTHORITY, AWARDING A CONTRACT TO SOLPAC CONSTRUCTION, INC., DBA SOLTEK PACIFIC CONSTRUCTION COMPANY, IN THE AMOUNT \$5,958,000.00, FOR PROJECT OF NO. 104056. EXPAND TERMINAL 2 EAST FACILITIES: TERMINAL BUILDING, AT SAN DIEGO INTERNATIONAL AIRPORT

WHEREAS, the Project will expand the Terminal 2 East building between Gates 24-28 and between Gate 25-Gate 27 to increase holdroom capacity, create new concessions and provide necessary infrastructure for future use of passenger transport vehicles and relocate the existing tenant clubroom allow for the buildout of the adjacent roof area above the American Airlines (AA) make up area, to create for a new post security concession area; and

WHEREAS, the existing pre-security food court area will be reconfigured to increase ticket counter queuing and passenger circulation area and to provide for new concessions; and

WHEREAS, the Project has been divided into three separate contract packages, and the award of a contract to SOLPAC Construction, Inc., dba Soltek Pacific Construction Company is for the terminal building work only; and

WHEREAS, the Scope of Work for this contract includes for the relocation of the clubroom, creation of the new post security concessions area and the reconfiguration of the existing pre-security food court area; and

WHEREAS, the San Diego County Regional Airport Authority ("Authority") issued a Bid Solicitation Package for this contract on August 12, 2011; and

WHEREAS, on September 13, 2011, the Authority opened Sealed Bids received in response to the Bid Solicitation Package; and

WHEREAS, the apparent low bidder, SOLPAC Construction Company, Inc., dba Soltek Pacific Construction Company, submitted a bid of \$5,958,000.00, and the Authority's staff has duly considered SOLPAC Construction Company, Inc., dba Soltek Pacific Construction Company's bid, and has determined SOLPAC Construction Company, Inc., dba Soltek Pacific Construction Company is responsible, and that its bid is responsive in all material respects; and

WHEREAS, the San Diego County Regional Airport Authority Board ("Board") believes that it is in the best interest of the Authority and the public that it serves, for the Board to award SOLPAC Construction Company, Inc., dba Soltek Pacific Construction Company, the contract for Project No. 104056, Expand Terminal 2 East Facilities: Terminal Building, upon the terms and conditions set forth on the Bid Solicitation Package. NOW, THEREFORE, BE IT RESOLVED that the Board hereby awards a contract to SOLPAC Construction Company, Inc., dba Soltek Pacific Construction Company, in the amount of \$5,958,000.00, for Project No. 104056, Expand Terminal 2 East Facilities: Terminal Building at San Diego International Airport, upon the terms and conditions set forth on the Bid Solicitation Package; and

BE IT FURTHER RESOLVED that the Authority and its officers, employees, and agents are hereby authorized, empowered, and directed to do and perform such acts as may be necessary or appropriate in order to effectuate fully the foregoing resolutions; and

BE IT FURTHER RESOLVED that the Board of the San Diego County Regional Airport Authority finds that this Board action is for a project determined not to have a significant effect on the environment (Section 15301, Existing Facilities – Class 1) and a categorical exemption was prepared in accordance with the California Environmental Quality Act; and the California Coastal Commission issued a Notice of Permit Waiver Effectiveness (Waiver Number 6-11-036-W) effective on July 14, 2011, in accordance with the California Coastal Act.
