1. Welcome and Introductions

Jennifer Lilley, Facilitator, began the meeting and asked ANAC members introduce themselves.

2. Approval of Minutes

A quorum was established. A motion was made and seconded to approve both the January 2, 2015 and April 15, 2015 minutes. Both minutes were unanimously approved with no discussion.

3. Information Items

Metroplex Project Update – Sjohnna Knack, Program Manager had asked the FAA SoCal Metroplex Project Team (Team) members to introduce themselves. The Team gave a brief introduction of the project and then the floor was opened for questions.

Question by ANAC: Victoria White, City of San Diego, asked the Team to give an overview on what the changes may entail in regards to the flight route, the noise contours, and if the noise will increase with these changes.

Rob Henry, FAA SoCal Metroplex Project Manager indicated the noise analysis identified no significant increase in the noise levels. He mentioned more information on the noise analysis can be found on the website.

Question by ANAC: Referenced a recent article read in the newspaper which indicated significant changes that may occur. The member asked the Team to elaborate more on what changes could be expected.

Rob Henry, FAA SoCal Metroplex Project Manager stated the general public will not see a change outside of the existing flight tracks.

Ms. Lee Steuer, Rep. for Susan Davis, noticed by looking at the website that there is more general traffic at the east county area.

Mr. Henry pointed out the current procedures and compared them to the proposal. He also added that if a more detailed presentation is needed of the Metroplex to either call or email him.

Airport Authority Update – Keith Wilschetz, Director of Airport Planning and Noise Mitigation, gave an airport update. He reported that operations at the airport are doing quite well. In June passenger enplanements were 6.5% higher than last year and operations are about 3% higher than last year.

The Rental Car Center (RCC) project at the north side of the airport is going well and is scheduled to open in January of 2016, traffic to Harbor Dr. will be switched to Sassafras, and the terminal link road will be completed in late August.

Mr. Wilschetz gave a brief presentation on the Airport Development Plan showing the planned projects for 20-25 years from now and potential changes for future terminals at the airport. He presented five alternative plans and explained each plan. He also had pointed out that the concept of building the terminal is for it to be efficient and cost effective for both the public and for Authority staff. Mr. Wilschetz stated they would present the alternatives to the Board for direction. Once Board approval for a single concept is obtained, the environmental analysis will occur in 2017.

*Question by ANAC: W*hat is meant by the end of the life span of the airport?

Mr. Wilschetz explained that with continued increase of operations at approximately 1.8-2% per year, the runway could reach its capacity by 2035-2040.

Question by ANAC: With this new plan, would it affect international flights and the need to add a new runway?

Mr. Wilschetz reiterated that a new runway will not be built.

Quieter Home Program (Program) Update –Craig Mayer, Deputy Program Manager, provided the committee an update on the Program status. Mr. Mayer stated that currently there are 746 applicants on the waiting list, which equates to 1,200 units. He estimated the Program will complete approximately 225 homes by the end of this calendar year, which is slightly down from previous years due to completing more single-family homes. There are about 75 homes completed in this second quarter of 2015; and total completed to date is just over 3,200 homes.

Mr. Mayer gave an update on the acoustical test plan. The FAA has requested the Airport make modifications and with those modifications, they provided a verbal acknowledgement that the plan will be approved.

Mr. Mayer also stated his intent to continue doing the customer service survey that was discussed last meeting. He indicated that the survey shows the majority of the homeowners who had participated in the Program are happy with the decision to participate. However there are still negative responses received, especially in regard to scheduling, the length of time to complete and process a home, appointment settings, either time is too restrictive.

Flight Operation Statistics – Steve Cummings, Noise Mitigation Specialist, presented flight operation statistics. Total missed approaches for June 30, 2015, was 341 which is the very similar to last year at this time when there was 346. As of June 30th, the early turns are 109 as oppose to last year's 103. Mr. Cummings explained what a missed approach is in response to the definition of a missed approach.

Complaint Statistics - Steve Cummings, Noise Mitigation Specialist, presented an update on Noise Complaints. For the first six months as of June 30th, a total of 52 complaints occurred for the year which is quite low from last year's 83 complaints.

Curfew Violation Review Panel (CVRP) Statistics - Mr. Nicholas Montgomery, Airport Noise intern, informed the committee that there was 11 curfew violations this past quarter, which is a total of 23 for the year, compared to 28 last year. The next CVRP is on August 5th.


- Two-step eligibility process Acoustical Test Plan includes pre-testing 100% of diverse and 20% of uniform housing stock. Approximately 8% tested under 45 dB.
- Increased review and scrutiny of program treatment packages has resulted in delay to projects not in construction prior to September 30th.
- Ongoing dialogue with FAA regarding allowable treatments, Modification to Standards and Neighborhood Equity.




FLIGHT OPERATIONS STATISTICS



2015 Early Turns by Month




