<p>In compliance with Transportation Security Administration (TSA) and San Diego International Airport (SDIA) Regulations, applicants for a SAN ID Badge must successfully complete an Access Investigation involving a ten (10) -year criminal history records check and possibly an employment history verification before a SAN ID Badge allowing unescorted access to the Security Identification Display Area (SIDA) is granted. If an applicant has been convicted of one or more of the following crimes in the last 10 years, the SAN ID Badge application will be denied.</p>
