
- Neighborhood Equity plan approved, moving forward with homes tested below 45 dB (ventilation, weather stripping windows/doors)

# **Missed Approaches by Month**



# **Definition: Early Turns**




The Authority has defined early turns to the right as those aircraft that turn prior to FAA Noise Dot #1 at the 295-degree heading to the right.

Left early turns are defined as those aircraft that turn prior to the FAA Noise Dot #3 at the 265-degree heading to the left.

Causes for early turns can be similar to missed approaches and are often due to weather or separation.



Departures that turn before reaching the FAA Noise Dots or turn back over the peninsula are considered Early Turns.





# **Common Flight Ops Concerns**




# **Noise and Operations Monitoring System**

- Airport Noise and Operations Monitoring System-ANOMS
  - 23 permanent noise monitoring locations
  - Noise data integrated with FAA radar data
  - Software solution to analyze flight tracks, noise complaints and noise levels
  - Public facing solutions



- Replace all noise monitoring equipment
- Integration of SWIM FAA radar feed
- Software solution upgrade for advanced analysis tools
- Upgrade to public facing solutions










  - Interactive Reporting







# San Diego Community Inquiry — Phone App

# AIRCRAFT NOISE COMPLAINT PROCESS

THE STEP BY STEP PROCESS OF WHAT HAPPENS WHEN YOU FILE A COMPLAINT WITH SDCRAA



### 1. File

The initial complaint is filed and sent to the airport noise staff.



## 2. Review

Staff reviews the complaint to determine if further research is necessary.



# 3. Research

Research is conducted and staff responds, as necessary, to answer questions from the complaint.



#### 4. ANAC

At the bi-monthly Airport Noise Advisory Committee, complaints are presented including total number of complaints, number of households filing complaints, common concerns addressed in complaints, and location of complaints.
