CALL TO ORDER: AAC Committee Chair Indra Gardiner called the meeting of Arts Advisory Committee to order at 3:30 p.m. on Friday, May 22, 2019 at the San Diego International Airport, Administration Building, Tuskegee Conference Room, 3225 N. Harbor Drive, San Diego, CA 92101.

NON AGENDA PUBLIC COMMENT:

Authority Board Member Johanna Schiavoni attended the meeting and thanked staff for their efforts to inform Board members about the Arts Program, in addition to their and the Committee's work on the new Arts Master Plan.

NEW BUSINESS:

 <u>ACTION – APPROVAL OF THE MINUTES</u>: Committee Member Robert Gleason moved to approve the minutes of the October 26, 2018 meeting. Committee Member Gail Roberts seconded, and it passed unanimously. Committee Member Kate Nordstrum was absent.

2. ACTION – APPROVAL OF TEMPORARY EXHIBITION THEME:

Joey Herring shared a proposal for the 2020 temporary exhibition theme, titled *Make Yourself at Home*. There was extended discussion about the types of exhibitors featured in the annual exhibition. Gleason asked staff to ensure there is representation from not only visual artists, but also a diverse range of community groups and suggested that staff be proactive in recruiting these groups to participate. Roberts moved to approve the action, Committee Member Indra Gardiner seconded, and it passed unanimously. **Committee Member Nordstrum was absent.**

3. ACTION - APPROVAL OF AAC LIAISON FOR ARTIST SELECTION PANEL:

Lauren Lockhart presented an overview of the Airline Support Building (ASB) Public Art Opportunity and requested a volunteer from the Committee to serve on the artist's selection panel as a liaison. Roberts volunteered to serve as the liaison. Gleason made the motion to approve, Indra seconded, and it passed unanimously. **Committee Member Nordstrum was absent.**

Committee Member Gleason inquired about why the public art component of the project was initiated after design had begun on the facility. Staff shared that when the project was initially reviewed it was not deemed an Eligible Project for the Two-Percent for public art contribution, but that the recommendation was made at a later date to incorporate art given the public-facing nature of the site. Gleason also inquired about the source of funding for the project and staff advised that it was pulled from the Public Art Fund, rather than the ASB project budget. Staff agreed to work with General Counsel and Finance to provide the AAC with more information about the review and budgeting process for new public art opportunities.

4. PRESENTATION: ARTS MASTER PLAN UPDATE AND DRAFT IMPLEMENTATION:

Chris Chalupsky gave an update on the newly Board-approved Arts Master Plan and passed hard copies of the Plan to committee members. Chalupsky presented staff's updated Implementation Matrix based on the recommendations made in the Arts Master Plan. Gardiner inquired about whether the Matrix would be brought back to the Committee, and Chalupsky answered that staff would use this as a tool to keep the committee informed on any changes and their progress on the recommendations moving forward. Committee Member Jennifer Easton inquired about whether the Arts Program has current or planned evaluation metrics as a result of the Arts Master Plan. Chalupsky indicated that to date no evaluation metrics have been implemented but that staff will follow the Master Plan recommendation to begin to evaluate projects and programming.

5. Staff Updates:

• Public Art:

Lockhart provided a brief overview of recently completed public art projects including *Oh Lovely Desert* by Adriene Hughes and *The Best Way Out is Always Through* by Ball-Nogues Studio.

• Temporary Exhibitions:

Herring presented an overview of the new 2019 Forces of Nature exhibition.

• Performing Arts Program:

Herring presented an overview of the current performing arts residency group, San Diego Dance Theater. He also informed the committee about new meditative concerts taking place in the Reflection Room.

• Community Outreach:

Lockhart gave an update on the DesignAHEAD program and the new partnership with USD Professor Matt Rich and his students. Lockhart also shared that staff had initiated a tour program and will be training a group of volunteer Airport Ambassadors to facilitate tours.

Chalupsky shared that the Arts Program will begin a new partnership with the University Club through an exhibition at their site beginning in July.

Arts Advisory Committee Appointees June 2019

CARMEN VANN

As Project Executive at Suffolk Construction, Carmen Vann has over 20 years of construction experience. Carmen's track record includes the successful management of numerous complex and prolific construction projects with fast track schedules, most notably, leading the construction of the San Diego New Central Library. Many of her recent projects, such as the Central Library, required the coordinated integration of permanent public artworks. Vann was also with Turner Construction during San Diego International Airport's Green Build.

Vann has served on advisory groups for cultural and educational groups throughout the region including the boards of the Balboa Park Conservancy and the San Diego Architectural Foundation, and an artist selection panel for San Diego International Airport for the Palm Street Park Public Art Opportunity. In 2014 she earned the Engineering News Record (ENR) California website's prestigious Top 20 under 40 Award for 2011, San Diego Metro Magazine's Top 40 Under 40 Award and was named among San Diego's 2011 Women Who Mean Business by the San Diego Business Journal.

LARRY BAZA

Larry Baza is a professional arts administrator with more than three decades of experience in advocating for the arts at the local, state and national level. He is the immediate past Chair of the San Diego Arts Commission. Baza has served on the boards of various nonprofit arts organizations and provided his expertise as a panelist for arts commissions and foundations. In his professional career, he has directed and managed San Diego arts organizations and businesses including Centro Cultural De La Raza, Sushi Performance and Visual Arts, Fingerhut Gallery, and Community Arts of San Diego. His wealth of knowledge and experience includes affiliations, consultancies, site visits and panel participation with multiple arts organizations including the National Endowment for the Arts, California Arts Council, California Association of Local Arts Organizations, Chicano Federation of San Diego County, National Association of Latino Arts and Culture, and the San Diego Community Foundation.

Baza was appointed to the California Arts Council by Assembly Speaker Toni Atkins in February of 2016. On January 25, 2018, he was elected Vice Chair of the Council. His term expires January 1, 2020.

Background: The Authority issued the Request for Qualifications for the Airline Support Building (ASB) Public Art Project on April 23. The RFQ was published on Submittable.com and a flyer directing interested applicants to Submittable was posted on PlanetBids. Public Notices were sent to 900 potential Respondents in addition to being distributed through prominent public art channels including the California Arts Council, PublicArtist.org, the Public Art Network Listserv and the Public Art Coalition of Southern California (PACSOCAL) site. 79 responsive statements of qualifications were received on May 22, 2019. Five finalist candidates were interviewed on June 18, 2019.

Description of the Candidates:

- 1) Adam Frank New York City-based artist Adam Frank has created a body of work noted for its investigation of light and the perception of nature. Frank uses varied media including video, projection, and light, and his projects often feature a participatory element. The panel found Frank to be a highly competent and innovative artist and appreciated the consideration that he gives to the public's experience of his work. Ultimately, though the panel felt Frank was a strong candidate, they found that his body of work was not the most compatible with this specific site and opportunity, and may be better suited for alternate locations.
- 2) Cliff Garten and Associates, Inc Cliff Garten, based in Venice, California, has developed an extensive body of work that aspires to engage the public visually, kinesthetically and functionally and which are

conceived in response to the unique qualities and activities of their context. The panel noted that Garten's interview demonstrated a high degree of professionalism, technical skill, and an ability to respond and adapt to stakeholder feedback. Despite a strong resume, the panel argued that Garten's body of work was not as innovative in its approach as other candidates.

- 3) Nova Jiang Los Angeles-based artist Nova Jiang has developed a diverse body of work that engages the viewer in playful, participatory experiences, and which gives careful consideration to the historical, emotional, and functional aspects of a site. The panel praised Jiang's careful consideration of the historical and environmental context of a site, her collaborative spirit, and her ability to distill complex ideas and narratives into highly accessible artworks for diverse audiences. The panel was confident in Jiang's ability to create a site-responsive, iconic artwork for the site, and resolved that she was the most qualified candidate.
- 4) Erwin Redl New York City and Bowling Green, Ohio-based artist Erwin Redl has a technology driven art practice with a strong consideration of ecological concerns and an interest in placemaking and memory. The panel was impressed with the technical proficiency and elegance of Redl's work as well as his flexibility in collaborating with the community on recent projects. Despite this, they felt that he had limited experience in creating works with a strong daytime presence, and therefore lacked compatibility with the project scope.
- 5) Skunk Control The Australia-based artist team of Skunk Control is composed of a team of artists, engineers and scientists led by Nick Athanasiuo. The group seeks to fuse technology and art through their temporary and permanent artworks, and they often draw inspiration from nature. While the panel admired Athanasiuo's educational emphasis and interest in engaging especially young viewers, they argued that the body of work his team had created lacked strong site-specificity and depth with regards to content, and expressed concern over their limited experience in permanent, outdoor artwork commissions.

Recommendation: Approve the Panel's recommendation for Nova Jiang to receive a commission for the Airline Support Building public art opportunity.
