2020 Performing Arts Residency Selection Panel Nominations

David Bennett

David Bennett is the General Director of San Diego Opera. Under his leadership since 2015, the Company has embarked on a series of community based initiatives including a citywide Listening Tour series, free public performances, and family friendly operas to better serve the diverse San Diego region. In 2016, the Company debuted its wildly popular detour Series, which explores the expressive nature of opera with the potency of intimate theater. Prior to San Diego Opera, David was Gotham Chamber Opera's Managing Director and Executive Director, and prior to that was at Dance New Amsterdam (DNA), Lower Manhattan's center for dance education, creation, and performance, where he served as Managing Director. While at DNA, he led a \$5.7 million capital campaign for DNA's new home and oversaw the organization's emergence as a significant producer of modern dance in New York City. Mr. Bennett was a Senior Consultant with Arts Resources International, where he provided a range of advisory services to non-profit arts organizations, including project feasibility studies, financial operating estimates, economic impact and market analyses, and fund-raising feasibility studies. Before working in Arts Administration, he enjoyed a successful career in opera, appearing as a baritone with a number of companies and orchestras throughout the United States, including The Dallas Opera, the Dallas Symphony, Skylight Opera Theater, and Florentine Opera of Milwaukee. Mr. Bennett holds both an M.B.A. and an M.A. in Arts Administration from Southern Methodist University in Dallas, TX and is Vice-Chair of the Board of Directors of OPERA America.

Molly Clark

Molly Clark is the Associate Director of Artistic Planning & Education at ArtPower at UC San Diego, the university's premier performing arts presenter. She oversees the programming and planning of an eclectic and respected performing arts season. She also connects artists with the campus and community to spark dialogue, discovery, and active participation in the arts through a robust engagement program. Molly holds a Master's degree in Nonprofit Leadership and Management and has a passion for providing access to the arts for all communities. Molly is a classically trained cellist and a non-classically trained hip hop DJ.





Ben Johnson

Ben Johnson is currently the Director of Performing Arts for the Los Angeles Department of Cultural Affairs. In this position, he is tasked with relaunching the Performing Arts Division of the City of Los Angeles, which includes overseeing six city-owned theaters, relaunching a festival platform for the city, and advocating on behalf of LA artists on a national and international level. Previously, he was the Program Manager at the Center for the Art of Performance at UCLA (CAP-UCLA) in Los Angeles and Director of Programs at United States Artists Foundation. He was also the Director of Northrop Concerts and Lectures at the University of Minnesota – Minneapolis, and he was Director of Education and Audience Development at the University Musical Society at the University of Michigan – Ann Arbor (MI). He has worked at the Ordway Music Theater (St. Paul) as part of the Planet Ordway Series, and interned at the American Dance Festival (NC) and Walker Art Center (MN) in the Performing Arts Department. Ben is an experienced and seasoned multi-disciplinary performing arts presenter and curator. He is affiliated with many artists, foundations, funders and national and international peer institutions.

Terry Wilson

Terry Wilson is a Lecturer in Dance at UC San Diego. She has been performing, choreographing and teaching in San Diego for the past 21 years. Terry has enjoyed a long career as a modern dancer, performing mostly with Jean Isaacs' San Diego Dance Theater as well as with many other local, national and international artists. Terry also currently teaches at San Diego City College as an Associate Professor in Dance and co-chairs the Environmental Stewardship Committee with Terri Hughes-Oelrich. In 2000, Terry received the best female performer "Tommy Award", presented by San Diego Area Dance Alliance. Terry earned an MFA in Dance from the University of Michigan.







2020 Temporary Exhibition Selection Panel Nominations

Lauren Siry

Lauren Siry founded 1805 Gallery as an artist studio and exhibition space in Little Italy that encourages critical conversations, creative thinking, community growth and development through exhibitions and artist residencies. In support of a sustainable cultural network, the gallery extends programming to off-site locations establishing partnerships with local organizations and small businesses. The gallery curates exhibitions, artist residencies and events that feature emerging and mid-career artists who explore unique concepts through painting, drawing, sculpture, installations and digital work. Lauren Siry holds a Masters in Contemporary Art from Sotheby's Institute of Art in London and a BFA from Tufts University and the School of the Museum of Fine Arts in Boston. As a practicing studio artist, Siry has completed studio fine art programs at the San Francisco Art Institute in California and the Studio Arts College International in Florence, Italy.

Lynn Susholtz

Lynn Susholtz is an artist, community activist, educator and founder of Art Produce and Stone Paper Scissors, public art/education studio. Her art practice has a participatory, social engagement/community collaboration focus. Recent public projects include digital video documentary and crowd sourced interactive installations.

An advocate for increased access to arts and culture, Lynn works locally to develop educational, social and environmental resources for youth and families. Engaging youth and adults in the process of creative problem-solving, she teaches classes and workshops throughout the county in schools, cultural centers and at her Stone Paper Scissors studio. She has been a California Arts Council Artist in Residence, and is an arts education consultant for UCSD's Education Studies Department and the San Diego Unified School District.

Lynn's public art commissions range from the design of educational playgrounds and school campuses to sculptural video installations. She has exhibited her work at the Athenaeum Arts and Music Library, City Gallery at San Diego City College, Mesa College Art Gallery and was selected the State Assembly District 39 representative for the "California





Contemporary Artists 2007" exhibit at the State Capitol in Sacramento. Some of her community engagement work at Art Produce was featured in the 2012 issue of Public Art Review, "Food For Thought".

Matt Rich

Artist Matt Rich is the Assistant Professor of Visual Arts at the University of San Diego. He received an MFA from the School of the Art Institute of Chicago, a BA from Brown University, and attended the Skowhegan School of Painting and Sculpture. Rich's work has been exhibited at the Museum of Contemporary Art San Diego, Institute of Contemporary Art Boston, BravinLee Programs in New York City, VOLTA NYC and VOLTA Basel, DODGEGallery in New York City, Kemper Museum of Contemporary Art in Kansas City, and Columbus College of Art + Design, among other venues. His solo exhibitions include: Project Row Houses in Houston, devening projects in Chicago, Samsøn in Boston, and The Suburban in Oak Park, IL.

Sasha Koozel Reibstein

Sasha K. Reibstein is currently an Associate Professor of Art and Head of the Ceramics Program at Palomar College in San Marcos, CA. She received her MFA in Sculpture from Massachusetts College of Art in 2005 and her BFA from the University of Michigan, Ann Arbor in Ceramics and Painting in 2000. In recent years, Sasha has traveled extensively, working and exhibiting in China, Denmark, Hungary and Germany. During these residencies abroad and working in her home studio, she has created sculptural works and installations that have been featured in over 50 national and international exhibitions including a solo exhibition in Berlin entitled, "New World." In 2008, she won the National Council for the Education of Ceramic Artist's Award for International Resident Artist. Sasha is also part of a collaborative team called The Jonestein Thought Factory, which produced a permanent public art installation, "Oak Idyll" at the Elfin Forest Recreational Reserve in Escondido, CA. Since 2010, her curation and work has been highlighted at numerous venues including the Mutter Museum, the International Mingei Museum, ART San Diego, White Box Contemporary, the California Center for the Arts, Escondidio Museum, the American Museum of Ceramic Art, The Attelboro Museum and the Morris Graves Museum.

- Support and help guide design team to develop iconic, uniquely-San Diego terminal façade design and larger entry experience into airport.
- Design in collaboration with architect to budget.
- Participate in all relevant design charrettes and workshops during validation phase and beyond.
- Artist(s) may influence the massing, textures, materials, colors, and form of the terminal building.
- Once a conceptual façade design is approved, artist(s) may also assist design team in translating façade into thematic treatments that carry on throughout the terminal.
- Successfully executed, it will not be possible to separate the artist's contribution to the design process from the architect's.
- The artist will be viewed as one member of a multidisciplinary team who share authorship of the façade design.
- What is the artist *NOT* responsible for in this role? Creating an isolated public art commission.
- Next steps: Draft EIR proposed to be released mid-September; Lead Artist opportunity to be aligned with procurement of Design-Builder.
