

Parking

NEW BUSINESS:

1. ACTION – APPROVAL OF THE MINUTES:

Mary Casillas Salas made a motion for approval and Cat Chiu Phillips seconded the motion. The motion passed unanimously.

2. STAFF UPDATES:

- Staff Departure

Katie Norman reported that Chris Chalupsky has left the Authority and thanked him for his efforts during his tenure.

- Transition to the new Administration Building

Norman shared with the committee that the team reformatted and repurposed two of Miki Iwasaki's pieces – Astralgraph and Signalscape for the New Administration Building. Another piece, Guillermo was relocated as well.

- Public Art and Conservation

Norman briefed the Committee on the progress with ongoing conservation efforts for Dazzle, The Living Wall, and the Journey. A Request for Proposals was recently released for Conservation Services as the contract with RLA has ended. The new contract will include responsibility for assisting with technical upgrades as several of the pieces are in need of the upgrades.

- Temporary Exhibitions

Daniel Dennert updated the committee on the selection of artists for the upcoming exhibit *Espacios & Lines*, which will be connected to World Design Capital 2024. Fifty percent of the artists work binationally. He shared visuals of the artists' work with the committee.

Dennert then discussed the importance of starting to plan for the 2025 Temporary Exhibitions and encouraged the committee to provide their input on possible themes. Chair Gleason shared Board perspectives and what is currently happening with World Design Capital with the new committee members for their background knowledge. Committee members asked questions for consideration and clarification and provided possible ideas with the team. The committee also discussed possibilities for including science and technology in future exhibitions.

- Performing Arts Program

Daniel Dennert briefed the Committee on the internally-produced successful summer series and the current concerts. The team recently completed interviews with respondents from the RFP for the new performing arts producer. The Committee will be briefed at the next meeting. The Performing Arts residency contract is progressing, Dennert provided more information on their program and an update will also be provided to the Committee at the next meeting.

- Social Media Engagement

Katie Norman provided an update on recent Social Media postings on multiple areas including public art and temporary exhibitions at the Rental Car Center. KPBS aired video segments and shared articles in the Arts and Culture newsletter. Upcoming Walter Hood workshops are prompting some coverage as well.

- USO remodel Significant changes in the use, character or design of the site have occurred which affect the integrity of the Artwork
 - Poor Condition The Artwork has been damaged or has deteriorated
 - Excessive Conservation Costs The Artwork requires excessive maintenance or has faults of design or workmanship
 - Safety Concerns The Artwork's physical or structural condition poses a threat to public safety

Dear Jayne,

I hope this message finds you well. I would like to address a matter concerning the 8 hanging artwork pieces in the interior and 6 standing pieces at the exterior displayed at our Neil Ash Airport Center.

As you may be aware, we have just started a major renovation of our center that is scheduled to be completed by the end of this year. The purpose of this renovation is to upgrade the aesthetics of the space to provide a more comfortable and modern look and feel, much more like you might find in an airline lounge.

Our primary clients are members of the military and their families. Being a member of the military, although highly rewarding, is also very stressful and typically involves significant travel, multiple relocations, and periodic deployments into dangerous and/or conflict zones.

As such, we strive to make our centers as comfortable and home-like as possible. Current design guidance suggests open spaces that take advantage of all available ceiling space and the use of warm and organic colors and materials.

I want to start by emphasizing that we greatly appreciate the effort put into curating the artwork within our center. Art can be a powerful and inspiring addition to any environment, contributing positively to the overall atmosphere. However, it is very important that as we complete our current upgrade process, we ensure that any installed artwork aligns with our design guidance and enhances our goal of maintaining a pleasant and comfortable environment for our military guests and their families. The artwork currently hanging from the ceiling and exterior standing art pieces are proving to be outside of our design guidance due to the constriction it makes on the ceiling space and exterior space where our service members gather, as well as the industrial nature of the design and materials used.

Additionally, we have heard from multiple patrons that they find the size of hanging artwork overbearing, as if something foreboding is hanging over their heads. The size and number of the objects serves to make the space seem smaller and darker. Some patrons even went as far to say that they find it scary having these big objects hanging over their head and are either puzzled or "slightly creeped out" by the objects suspended inside the fixtures. The outside standing pieces have, at some point, been broken several times and have posed a safety risk as they stand in areas where large volume of patrons gather and are welcomed.

In this spirit, we would like to respectfully request the permanent removal or replacement of these pieces while our project is under way and the space is empty and easily accessible. Our understanding is that any removal needs to be both approved and executed by your department.

However, we are happy to do the removal ourselves if you so authorize.

We would be happy to engage in a discussion or provide further feedback on this matter if it would be helpful. Ultimately, I trust your review of this request will be made with the best interests and comfort of our military members as the guiding force.



Beyond the Frame or Ink-credible (working titles)

The craft of illustrating stories and experiences, whether rooted in reality or the realm of imagination, emerges as an ancient art form with its origins in parietal art, offering one of our earliest glimpses into the essence of humanity. Situated amidst the vibrant backdrop of San Diego, a city that has evolved into a nexus for artistic exploration, particularly as the proud host of Comic-Con, this showcase aims to underscore the city's pivotal role in shaping the styles and purposes of illustration over time. Our rich artistic heritage has cultivated an environment where creators in diverse fields, spanning traditional drawing and animation to cutting-edge digital design, converge and influence the trajectory of visual storytelling. Collectively, they realize what San Diego artist Maurice Braun (1877 - 1941) spoke of nearly a century ago, a "great number of artists who will take part in marking here a culture which is not yet imagined."



Beyond the Frame or Ink-credible (continued)

In contemplating the historical trajectory of illustration and technological advancements in creative techniques, this exhibition invites artists to reflect on how San Diego has elevated this art form, at times perhaps overlooked as a distinct realm of fine art. Contemporary practitioners are asked to analyze how they draw inspiration from these foundations, ultimately weaving captivating visual tales, and pushing the boundaries of this timeless and ever-evolving art form.



Mirror, Mirror (working title)

Within San Diego's idyllic landscape, a realm of artistic innovation has unfolded, shaped by creators whose contributions resonate within the hall of visual art history. Encompassing movements such as *Light and Space*, *Pattern and Decoration*, and explorations at the crossroads of Mexican and American cultures, these artists have become embodiments of the region's inherent natural and human beauty. This exhibition beckons creators to engage in a profound dialogue with the past, charting the course of San Diego's impact on the global art scene.



Mirror, Mirror (continued)

Contemporary artists are invited to reflect on the pioneering figures and movements native to our region that have left an indelible mark on the world of art. Who among our local visionaries dared to offer a glimpse of the unprecedented? What catalytic spirit did they bring to the art world, and why does their contribution hold enduring significance? In navigating this inquiry, we implore participants to explore the intricate threads connecting their own artistic endeavors to the luminaries and movements that preceded them. This exhibition is a tribute to the trailblazers of San Diego's artistic narrative, while showcasing how present-day artists are contributing new layers to the unfolding story of San Diego's profound impact on the arts.



Lifeways (working title)

Embark on an artistic odyssey through the fecund landscapes of San Diego and Tijuana, where floodways intertwine with agricultural fields, giving rise to a narrative rich in life and nourishment. This exhibition uses food as a metaphor and invites artists to explore the intersections of nature, labor, and culture, visually capturing the vibrant flavors that animate our communities and the tales of those whose hands tend to the earth, ensuring our sustenance.

Artists are encouraged to reflect on the multifaceted lives of all who work toward our collective nourishment. The featured work will question how we gather around food, and how it is used to perpetuate cultural tradition. It asks what reciprocal responsibility exists between inhabitants and the land that sustains us and answers with possible individual points for beginning.






