#### 6. UPDATE ON LICENSE HOLDER DELIVERABLES

Dr. Clarke presented information highlighting the deliverables provided to each of the World Trade Center San Diego licensees (Port of San Diego, the Airport, and the City of San Diego) during 2019.

#### 7. DISCUSS 2019 ANNUAL REPORT

The Board discussed the draft annual report and had no initial changes. Dr. Clarke requested that the Board send their comments to her by the end of November.

#### 8. REVIEW AND ADOPT 2020 WORKPLAN

Dr. Clarke presented the proposed 2020 work plan highlights. The Board had no suggested changes to the work plan.

Dr. Clarke informed the Board that the development of the 2025 Go-Global Strategic plan will begin in 2020. Dr. Clarke added that she envisions that this would be part of the World Trade Center San Diego workplan and asked the Board how they would like to participate.

Chairman Gleason responded that he would like to participate as a Board, and in keeping with the Brown Act, he suggests the World Trade Center San Diego Board conduct a dedicated workshop for the 2025 Go-Global Strategic Plan.
