### **GO GLOBAL STRATEGY**

## IRELAND IS LOOKING TO SAN DIEGO FOR CYBERSECURITY TALENT SOLUTIONS

According to the Center for Strategic and International Studies (CSIS), the global cybersecurity workforce shortage is projected to reach 1.8 million unfilled positions by 2022. As a hub for cybersecurity companies and research, San Diego has been piloting programs to address talent shortages that are plaguing this ubiquitous industry. San Diego's collaborative efforts, combined with its unique concentration of academic, private sector, government, and non-profit industry, have attracted the attention of global technology markets.



In late February, WTC San Diego – EDC's international economic development arm – and the Cyber Center of Excellence (CCOE) hosted 15 delegates from Ireland-based government and academic intuitions. The delegation was touring San Diego to learn about the region's cybersecurity industry and efforts to support its ongoing growth.

San Diego companies that attended the roundtable discussed technologies they were developing and strategies for addressing talent shortfalls. San Diego's cybersecurity industry, anchored by the presence of NAVWAR, has become a hub for cybersecurity companies. Based on research conducted by San Diego Regional EDC and the CCOE, San Diego's cyber industry generated \$2.2 billion in economic impact in 2018, with more than 8,450

employees working directly for cybersecurity firms San Diego companies in attendance also had a lot to learn.

## WTCSD ASSISTS IN PORT BUSINESS DEVELOPMENT

Securing container shipments through the Port of San Diego can often be challenging due to its close proximity to the major commercial ports of LA and Long Beach. The Port of San Diego has developed superior capabilities geared toward specialty cargos, like roll-on-roll-off commodities. This has allowed for a focus on importing, exporting, handling, and processing autos at the National City Marine Terminal. It has become an important revenue source for the Port of San Diego and cultivating it is a strategic priority.

During its Germany Trade Mission in October 2019, WTCSD leveraged the participation of U.S. Congressman Scott Peters to secure meetings with BMW, Daimler, and Porsche to facilitate new business and increase the frequency of existing business through the aforementioned terminal. BMW inquired about a spot shipment for 300 transshipped automobiles, and sent representatives from its China team to assess the capabilities of the terminal. Pasha Automotive Services (the Port's auto terminal operator) has benefited from closer relations with the Porsche team, as it embarks upon a \$7M project to improve the original equipment manufacturer's (OEM) Port of San Diego facilities. This year, approximately 50 percent of all West coast electric Porsche units will enter the United States through this facility.

# **CORPORATE TRAVEL SURVEY**

WTC's Corporate Travel Survey In support of SAN's efforts, WTC launched a corporate travel survey to gauge business sentiment related to future travel behavior.

### Key takeaways:

- 52% of companies have not cut travel budgets for 2021
- 64% anticipated increased support in local businesses and economy
- 76% of companies expect for domestic U.S. travel to resume within the next 6 months
- 3% of companies expect for international travel to Europe to resume within the next 6 months
