What is Go Global?

- Initially released in 2015, alongside the City of San Diego, JPMorgan Chase, and the Brookings Institution
- Part of the Global Cities Initiative, which analyzed how globally integrated regional economies were and what could be done to grow export opportunities
- Led to the launch of World Trade Center San Diego, under the purview of the San Diego Regional EDC
- Findings informed the creation of MetroConnet export accelerator
