Pursuant to California Public Utilities Code §§ 21670-21679.5, the Airport Land Use Commission ("Commission") is responsible for coordinating the airport planning of public agencies within San Diego County. The Commission has the legal responsibility to formulate airport land use compatibility plans ("ALUCPs") that will (a) provide for the orderly growth of each public airport and the areas surrounding the airport within the County and (b) safeguard the general welfare of the inhabitants within the vicinity of each airport and the public in general. Pursuant to §21670.3, the San Diego County Regional Airport Authority serves as the Commission.

This Agenda contains a brief general description of each item to be considered. The indication of a recommended action does not indicate what action (if any) may be taken. *Please note that agenda items may be taken out of order.* If comments are made to the Commission without prior notice or are not listed on the Agenda, no specific answers or responses should be expected at this meeting pursuant to State law.

Staff Reports and documentation relating to each item of business on the Agenda are on file in the Office of the Authority Clerk Department and are available for public inspection.

NOTE: Pursuant to Authority Code Section 2.15, all Lobbyists shall register as an Authority Lobbyist with the Authority Clerk within ten (10) days of qualifying as a lobbyist. Failure to submit a speaker slip shall not preclude testimony, if permission to address the Board is granted by the Chair.
- 2) The Public Comment Section at the beginning of the agenda is reserved for persons wishing to address the Board, ALUC, and Committees on any matter for which another opportunity to speak is not provided on the Agenda, and on matters that are within the jurisdiction of the Board.
- 3) Persons wishing to speak on specific items listed on the agenda will be afforded an opportunity to speak during the presentation of individual items. Persons wishing to speak on specific items should reserve their comments until the specific item is taken up by the Board, ALUC and Committees.

Testimony by members of the public on any item shall be limited to three (3) minutes per individual speaker and five (5) minutes for applicants, groups and referring jurisdictions.
- 5) Pursuant to Authority Policy 1.33 (8), recognized groups must register with the Authority Clerk prior to the meeting.

After a public hearing or the public comment portion of the meeting has been closed, no person shall address the Board, ALUC, and Committees without first obtaining permission to do so.

Report of Determinations of Consistency with Airport Land Use Compatibility Plans

Pursuant to Airport Authority Policy 8.30 and acting in its delegated capacity as the Airport Land Use Commission (ALUC) for San Diego County, Airport Authority staff has issued the following consistency determinations per their respective Airport Land Use Compatibility Plans (ALUCPs). Authority Policy 8.30(3)(f)(2) states that any determination made by Authority staff in its delegated capacity shall be placed on the ALUC agenda for the next available meeting and shall be considered final if no further action is taken by the ALUC.

Gillespie Field ALUCP:

Construction of Warehouse at 9520 Pathway Street, City of Santee

Deemed Complete and Consistent on April 3, 2025

<u>Description of Project</u>: The project involves the construction of a warehouse of 1,152 square feet on a property of 9,499 square feet with an existing 8,347 square foot office, warehouse and distribution building to remain.

<u>Noise Contours</u>: The proposed project lies within the 65-70 decibel Community Noise Equivalent Level (dB CNEL) noise exposure contour. The ALUCP identifies warehouse uses located within the 65-70 dB CNEL noise contour as compatible with airport uses.

<u>Airspace Protection Surfaces</u>: The maximum height of the proposed project structure will be approximately 375 feet above mean sea level (20 feet above ground level). The proposed project is in compliance with the ALUCP airspace protection surfaces because the project sponsor has certified that notice of construction is not required to the Federal Aviation Administration (FAA) because the project is located within an urbanized area, is substantially shielded by existing structures or natural terrain, and cannot reasonably have an adverse effect on air navigation. <u>Safety Zones</u>: The proposed project is located within Safety Zone 2. The ALUCP identifies warehouse uses located within Safety Zone 2 as compatible with airport uses.

<u>Overflight Notification</u>: The proposed project is located within the overflight notification area but does not involve any new residential use subject to overflight notification requirements.

<u>Interest Disclosure</u>: The property is owned by Kore Essentials, Inc. of Santee, whose contact is disclosed as Karl Kozak. The architect is Matthew Ellis of San Diego. The civil engineer is Excel Engineering of Escondido. The certified pre-engineered building systems is Empire Steel Buildings of Salem, Oregon. The electrical engineer is Summit Electrical, Inc., of San Diego.

Establishment of Office and Outdoor Equipment Sales and Rental Yard at 10527 Prospect Avenue, City of Santee

Deemed Complete and Consistent on April 3, 2025

<u>Description of Project</u>: The project involves the establishment of an outdoor equipment sales and rental yard and the conversion of an existing garage to an office of 608 square feet on a property of 0.56 acres.

<u>Noise Contours</u>: The proposed project lies within the 60-65 decibel Community Noise Equivalent Level (dB CNEL) noise exposure contour. The ALUCP identifies office and outdoor storage uses located within the 60-65 dB CNEL noise contour as compatible with airport uses.

<u>Airspace Protection Surfaces</u>: The maximum height of the proposed project structure will be approximately 395 feet above mean sea level (12 feet above ground level). The proposed project is in compliance with the ALUCP airspace protection surfaces because the project sponsor has certified that notice of construction is not required to the Federal Aviation Administration (FAA) because the project is located within an urbanized area, is substantially shielded by existing structures or natural terrain, and cannot reasonably have an adverse effect on air navigation.

<u>Safety Zones</u>: The proposed project is located within Safety Zone 6. The ALUCP identifies office and low-intensity or outdoor-oriented retail or wholesale trade uses located within Safety Zone 6 as compatible with airport uses.

<u>Overflight Notification</u>: The proposed project is located within the overflight notification area but does not involve any new residential use subject to overflight notification requirements.

<u>Interest Disclosure</u>: The property is owned by Wellsprospective LLC, whose owner is disclosed as Jared Wells. The architect is Coston Architects Incorporated of La Mesa. The tenant is Aerco of San Diego. The landscape architect is Wynn-Smith Landscape Architecture of Poway.

Construction of Residential Unit at 8765 Via de Victoria, City of Santee

Deemed Complete and Conditionally Consistent on April 3, 2025

<u>Description of Project</u>: The project involves the construction of an attached accessory dwelling unit with the existing residence to remain.

<u>Noise Contours</u>: The proposed project lies within the 60-65 decibel Community Noise Equivalent Level (dB CNEL) noise exposure contour. The ALUCP identifies residential uses located within the 60-65 dB CNEL noise contour as conditionally compatible with airport uses, provided that the accessory dwelling unit is sound attenuated to 45 dB CNEL interior noise level. Therefore, as a condition of project approval, the accessory dwelling unit must be sound attenuated to 45 dB CNEL interior noise level.

<u>Airspace Protection Surfaces</u>: The maximum height of the proposed project structure will be approximately 376 feet above mean sea level (16 feet above ground level). The proposed project is in compliance with the ALUCP airspace protection surfaces because the project sponsor has certified that notice of construction is not required to the Federal Aviation Administration (FAA) because the project is located within an urbanized area, is substantially shielded by existing structures or natural terrain, and cannot reasonably have an adverse effect on air navigation.

<u>Safety Zones</u>: The proposed project is located within Safety Zone 6. The ALUCP identifies residential uses located within Safety Zone 6 as compatible with airport uses.

<u>Overflight Notification</u>: The proposed project is located within the overflight notification area. The ALUCP requires that a means of overflight notification be provided for new residential land uses. Therefore, as a condition of project approval, a means of overflight notification must be provided for the residential unit.
