Subject:

Authorize the Rejection of Claim of TDY Industries, LLC

Recommendation:

Adopt Resolution No. 2013-0004, authorizing the Rejection of the Claim of TDY Industries, LLC.

Background/Justification:

On December 6, 2012, TDY Industries ("TDY") filed a claim (Attachment A) with the Authority alleging that during a recent cleanout of the Stormwater Conveyance System on the former Teledyne Ryan Leasehold, the Airport twice suddenly discharged large volumes of water into the 54" storm sewer during its project. TDY claims damages in the amount of \$8,660 to cover the cost of collecting, treating and discharging the excess water.

TDY alleges in its claim that during a recent, properly noticed period of maintenance to the Stormwater Conveyance System two separate incidents of excess water discharge occurred, causing run off into the 54" storm sewer. TDY believes the San Diego County Regional Airport Authority is responsible for the two discharges of water and TDY's costs of treatment and discharge.

TDY's claim should be denied. An investigation into the incident revealed no discharge of water by the Authority into or near the 54" storm sewer during the Stormwater Conveyance System cleanout project. An investigation into the sources responsible for the discharged water is ongoing.

Dear Mr. Manasjan:

As you may be aware, during the recent cleanout of the Stormwater Conveyance System at the former Teledyne Ryan Aeronautical facility, the Airport suddenly discharged a large volume of water to the 54" storm sewer. The discharge happened twice despite advance notice of TDY's work and repeated reminder to the Airport about the ongoing work. Approximately 55,000 gallons of water were discharged during two events. The water had to be collected, treated and discharged since the SWCS was plugged for cleaning. TDY incurred \$8,660 in handling the water discharged by the Airport.

TDY requests reimbursement for these costs that it would not have incurred if the Airport had not discharged during the cleanout efforts.
