The Commission has the legal responsibility to formulate airport land use compatibility plans ("ALUCPs") that will (a) provide for the orderly growth of each public airport and the areas surrounding the airport within the County and (b) safeguard the general welfare of the inhabitants within the vicinity of each airport and the public in general. Pursuant to §21670.3, the San Diego County Regional Airport Authority serves as the Commission.

This Agenda contains a brief general description of each item to be considered. The indication of a recommended action does not indicate what action (if any) may be taken. *Please note that agenda items may be taken out of order.* If comments are made to the Commission without prior notice or are not listed on the Agenda, no specific answers or responses should be expected at this meeting pursuant to State law.

Report of Determinations of Consistency with Airport Land Use Compatibility Plans

Meeting Date: March 23, 2020

Pursuant to Airport Authority Policy 8.30, and acting in its delegated capacity as the Airport Land Use Commission (ALUC) for San Diego County, Airport Authority staff has issued the following consistency determinations per their respective ALUCPs:

San Diego International Airport ALUCP

Construction of a Detached Dwelling Unit at 1616 Glenwood Drive

Deemed Complete & Conditionally Consistent on March 2, 2020

<u>Description of Project</u>: The project involves the construction of a detached dwelling unit.

Noise Contours: The proposed project lies within the 65-70 decibel Community Noise Equivalent Level (dB CNEL) noise exposure contour. The ALUCP identifies residential uses located within the 65-70 dB CNEL noise contour as conditionally compatible with airport uses, provided that the building is sound attenuated to 45 dB CNEL interior noise level. The ALUCP requires that an avigation easement for aircraft noise and height be recorded with the County Recorder. Therefore, as a condition of project approval, the building must be sound attenuated to 45 dB CNEL interior noise level and an avigation easement for aircraft noise and height be recorded with the County Recorder.

<u>Airspace Protection Surfaces</u>: The maximum height of the proposed project structure will be 26 feet above ground level (138 feet above mean sea level). The proposed project is located outside the SDIA Threshold Siting Surface (TSS). The proposed project is in compliance with the ALUCP airspace protection surfaces because the project is located within an urbanized area, is substantially shielded by existing structures or natural terrain, and cannot reasonably have an adverse effect on air navigation.

<u>Safety Zones</u>: The proposed project is located outside all Safety Zones.

<u>Overflight Notification</u>: The proposed project is located within the overflight notification area. The ALUCP requires that a means of overflight notification be provided for new residential land uses. In instances when an avigation easement is required, the overflight notification requirement is satisfied.

Gillespie Field Airport ALUCP

Construction of Manufacturing Building at 10351 Lunar Lane

Deemed Complete & Consistent on March 2, 2020

<u>Description of Project</u>: The project involves the construction of a single-story manufacturing building of 9,606 square feet on a property of 20,602 square feet.

<u>Noise Contours</u>: The proposed project lies outside the 60 dB CNEL noise exposure contour. The ALUCP identifies manufacturing uses located outside the 60 dB CNEL noise contour as compatible with airport uses.

<u>Airspace Protection Surfaces</u>: The maximum height of the proposed project structure will be 25 feet above ground level (384 feet above mean sea level). The proposed project is in compliance with the ALUCP airspace protection surfaces because a determination of no hazard to air navigation has been issued by the Federal Aviation Administration (FAA).

<u>Safety Zones</u>: The proposed project is located within Safety Zone 2. The ALUCP identifies manufacturing uses located within Safety Zone 2 as conditionally compatible with airport uses, provided that the project complies with a floor area ratio (FAR) of 0.48 and lot coverage of 50 percent. The project proposes a FAR of 0.36 and a lot coverage of 36 percent and therefore complies with the Safety Zone 2 limitations.

<u>Overflight Notification</u>: The proposed project is located within the overflight notification area, but does not involve any new residential use subject to overflight notification requirements.

Brown Field Municipal Airport, Gillespie Field, Montgomery-Gibbs Executive Airport, Marine Corps Air Station Miramar, and San Diego International Airport ALUCPs

12th Update, Phase 2 of Land Development Code, City of San Diego

Deemed Complete & Consistent on March 2, 2020

<u>Description of Project</u>: The project proposes three amendments to the City of San Diego Land Development Code in distance measurement and permitting process matters associated with cannabis outlet and cannabis production facilities. None of the amendments has a direct bearing upon airport related matters and do not include any physical improvements.

<u>Noise Contours</u>: The proposed project does not involve any actual development and thus does not impact any noise exposure contours of any airport.

<u>Airspace Protection Surfaces</u>: The proposed project does not involve any actual development and thus does not impact any airspace protection surfaces of any airport.

<u>Safety Zones</u>: The proposed project does not involve any actual development and thus does not impact any safety zones of any airport.

<u>Overflight Notification</u>: The proposed project does not involve any actual development and thus does not impact any overflight notification requirements of any airport.
