# Subject:

Award a Contract to Stronghold Engineering, Inc. to Upgrade Gates in Terminal 2 East: Gate 24-Gate 28 Holdrooms, at San Diego International Airport

#### **Recommendation:**

Adopt Resolution No. 2012-0008, awarding a contract to Stronghold Engineering, Inc. in the amount of \$13,997,127 for Project No. 104056, to upgrade Terminal 2 East Facility: Gate 24-Gate 28 Holdrooms, at San Diego International Airport.

## **Background/Justification:**

The Project will upgrage the Terminal 2 East building between Gate 24 and Gate 28 and between Gate 25 and Gate 27 to increase holdroom capacity, create new concessions, provide necessary infrastructure for future use of passenger transport vehicles, relocate the existing tenant clubroom to allow for the buildout of the adjacent roof area above the American Airlines baggage make-up area, and create a new post security concession area. The existing pre-security food court area will also be reconfigured to increase ticket counter queuing and passenger circulation area and to provide for new concessions.

The project has been divided into three (3) separate contract packages:

- Upgrade T2E Facilities: Terminal Building (Approved November 3, 2011 Board Meeting)
- 2. Upgrade T2E Facilities: Gate 24-Gate 28
- 3. Upgrade T2E Facilities: Gate 25-Gate 27

This contract is for the Gate 24-Gate 28 work only (Item 2, above).

The Scope of Work for this contract includes the expansion between Gate 24 and Gate 28 to increase holdroom capacity, create new concessions and provide the necessary infrastructure for future use of the passenger transport vehicles.

This contract was advertised on October 28, 2011, and bids were opened on December 2, 2011. The following bids were received: (See Attachment A)

WHEREAS, the San Diego County Regional Airport Authority ("Authority") issued a Bid Solicitation Package for this contract on October 28, 2011; and

WHEREAS, on December 2, 2011, the Authority opened Sealed Bids received in response to the Bid Solicitation Package; and

WHEREAS, the apparent low bidder, Stronghold Engineering, Inc. submitted a bid of \$13,997,127 and the Authority's staff has duly considered Stronghold Engineering, Inc's bid, and has determined Stronghold Engineering, Inc. is responsible, and that its bid is responsive in all material respects; and

WHEREAS, the San Diego County Regional Airport Authority Board ("Board") believes that it is in the best interest of the Authority and the public that it serves, for the Board to award Stronghold Engineering, Inc., the contract for Project No. 104056, Expand Terminal 2 East Facility: Gate 24-Gate 28, upon the terms and conditions set forth on the Bid Solicitation Package.
