Update - San Diego International Airport – Airport Land Use Compatibility Plan

Recommendation:

Accept the report.

Background/Justification:

ALUC staff is currently engaged in the public outreach component of the SDIA ALUCP process. Recent outreach efforts included:

- On April 28, 2011, the third SDIA Steering Committee meeting was held, focusing on how noise impacts future land use planning around SDIA. Policy direction on noise policies and matrix will be sought from the ALUC at the July 7, 2011 meeting.
- On April 28, 2011, an Open House for the noise compatibility factor was held in the evening. Seven people attended.
- On April 29, 2011, the third in a series of SDIA Environs tours was conducted for interested members of the public. The tour educated the public about the SDIA environs, particularly the impact of obstructions on the runway. Four people participated.

The next Steering Committee meeting is scheduled for June 16, 2011, and will focus on how future land use could be impacted by airspace protection needs for SDIA. The remaining Steering Committee meetings are scheduled as follows:

- July 21, 2011 - Safety
- August 18, 2011 - Safety (Part 2, if needed)
- September 22, 2011 - Wrap-up
