**CALL TO ORDER:** AAC Chair Van Huis called the meeting of the Art Advisory Committee to order at 9:05 a.m. on Friday, August 8, 2014, at San Diego International Airport, Commuter Terminal Board Room, 3225 N. Harbor Drive, San Diego, CA 92101.

**PLEDGE OF ALLEGIANCE:** AAC Chair Van Huis led the pledge of allegiance.

**NEW BUSINESS:**

1. **ACTION – APPROVAL OF MINUTES:** Committee Member Gleason moved to approve the minutes of the May 9, 2014 meeting. The Motion was seconded by Committee Member Gardiner. **Motion Passed unanimously.**
  
2. **PRESENTATION – AIRPORT DEVELOPMENT PROGRAM OVERVIEW:** Ted Anasis, Regional Planning Manager, gave an overview of the Airport Development Program, which included the airport’s current foot print and plans for a new parking plaza. He also presented three renderings of Terminal 1 and Terminal 2 East’s remodel and covered the next steps and schedule for the remodel and parking plaza.
  
8. **OLD BUSINESS: PRESENTATION – UPDATE ON INTERIM AIRPORT ART PLAN:** Constance Y. White, Art Program Manager, gave an overview of the recently completed Art

Master Plan, established in 2008, and provided international public art examples related to opportunities in the Interim Art Plan.

**AAC Chair Van Huis called for a recess at 9:50 a.m.; meeting reconvened at 10:13 a.m.**

3. **PRESENTATION – NEW ART.SAN.ORG:** Jon Graves, Webmaster gave a presentation on the new art.san.org site which included new features and an interactive map. Committee Member Soriano recommended including hyperlinks to artists' website. Chair Van Huis praised the new interface and design and inquired about an opportunity for a docent-led virtual tour. Committee Member Gleason echoed her remarks for the use of multimedia content.
4. **ACTION – ART PROGRAM SOLICIATION PROCESS:** After providing an overview of the Airport's Procurement Department's procedures to conduct solicitations for artists through formal and informal Requests for Qualifications and Requests for Proposals for Public Art Opportunities, Lauren Lockhart, Airport Art Program Coordinator II, recommended the use of a web-based platform designed specifically to manage artists' submissions. Chair Van Huis inquired if the change would increase the amount of entries of the solicitation process. Lockhart and Committee Member Soriano had positive feedback that a change would attract more artists and echoed comments regarding the current system being challenging for artists to use. Committee Member Gleason moved to approve a web-based platform. The motion was seconded by Committee Member Soriano. **Motion Passed unanimously.**
5. **ACTION – APPROVE CHANGING EXHIBITS THEME: BORDERS AND BOUNDARIES:** Lockhart asked the AAC to approve *Borders and Boundaries* as the theme for the 2016 exhibition calendar year (February 2016 – January 2017). Committee Member Soriano recommended using terms to encourage unification, and less about division. Committee Member White moved to approve the theme of the exhibition. The motion was seconded by Committee Member Gardiner. **Motion Passed unanimously.**
6. **ACTION – APPOINT ARTIST SELECTION PANEL MEMBERS:** Committee Member Gleason moved to approve a new list of recommended panelists for the Parking Plaza Public Art Project. The motion was seconded by Committee Member Soriano. **Motion Passed unanimously.**

Committee Member Soriano will serve as the committee representative on the panel.

7. **ACTION – APPROVE NEW LOCATION FOR CEILING NODE PROJECT:** Lockhart recommended a new site for the Ceiling Node Project, the upper level Terminal 1 exterior rotunda. Committee members made positive comments regarding the new proposed location, but had reservations regarding the budget to retrofit the proposed site to accommodate the yet to be re-fabricated artwork. Committee Members recommended that staff conduct further research with the Facilities Development Department regarding the budget necessary to retrofit the proposed space and to consult with legal counsel to see if the issue may need to be brought to the Board.

**Rental Car Center**

**Background:** The Authority issued the Request for Qualifications for the third Rental Car Center public art opportunity on March 17, 2014. As usual, notice of the business opportunity was posted in the *Daily Transcript* and the Authority’s website. Public Notices were sent to 700 potential respondents. A pre-submittal meeting was held on March 21, 2014 and attended by 6 artists. A total of 33 statements of qualifications were received on April 7, 2014.

### Description of the Candidates:

- 1) **Cliff Garten** is the founder of Cliff Garten Studio in Venice, California. His practice integrates architecture, landscape and engineering as a means of positioning his sculpture in the public realm. The panel recognized him as a highly experienced artist and landscape architect, but after interviewing him, found him to be less than enthusiastic about the RCC opportunity as his efforts of late are directed at public infrastructure projects.
- 2) **Haddad Drugan** is a Seattle-based artist team consisting of Laura Haddad and Tom Drugan. Haddad Drugan’s work strives to create environments that encompass people in holistic artistic experiences. The panel was highly impressed with their extensive collaborative experience and desire for community outreach and engagement. Ultimately the panel felt that this team’s work at sites similar to that of the RCC were less successful than their other projects, raising concerns about their ability to respond to the site effectively.
- 3) **Donald Lipski** is an artist based in New York City. He is best known for his installation work and large-scale public art projects. While the panel acknowledged Lipski’s extensive experience in the public art field, and genuine enthusiasm for the opportunity, they agreed that his approach in past work was inconsistent with regard to a successful integration into a site.



- 4) **R & R Studios** is a Miami-based artist team whose multidisciplinary practice involves visual arts, exhibition design, architecture and urban design. The panel appreciated that the team had produced a number of highly successful, engaging works, but they expressed concerns about the dearth of recent production from the pair, and also felt that they lacked examples of work that demonstrated a strong responsiveness to site or region.
- 5) **Ueberall International** is a Southern California-based artist team that fuses state of the art media design, graphics and architecture to develop work that merges the physical with the virtual into location-based experiences. The panel was impressed with the team's extensive experience incorporating technology into successful public artworks, as well as their interest in creating work that is interactive, fluctuating, and responsive to audience. After having interviewed this artist team, the panel resolved that they are the most qualified and highly recommended for this project.

**Recommendation:** Approve the Panel's recommendation for Ueberall International to receive a commission for the Rental Car Center public art opportunity.

## Rental Car Center Public Art Opportunity

**Background:** The location of the Rental Car Center (RCC) demarcates a transition between downtown and the burgeoning midtown business districts. The RCC will be situated on the northernmost edge of the airfield facing the Mission Hills neighborhood, Pacific Highway and Interstate 5, stretching about 1600 feet between Washington and Sassafras Streets. This new facility will occupy 17 acres and will have a four-level structure accommodating 5000 vehicle spaces, a Customer Service Building (“CSB”) and a new restaurant facing the airfield.

This facility will consolidate all rental car operations and provide a long-term facility for the rental car agencies that now serve the Airport. An Airport shuttle will transport customers along a new terminal link roadway between the RCC and Airport terminals. Two artists are currently creating work for the site, one artist for the CSB conveyance cores and one in the landscape/bioswale facing the airfield side of the building.

**Estimated Budget:** \$800,000

### Project Description:

This wayfinding project is a significant opportunity which impacts not only airport travelers but also the surrounding neighborhood, vehicular traffic and pedestrians. Artists or artist teams are invited to collaborate with the design team to create an integral engaging experience using light and sculpture. This experience should function as an intuitive wayfinding feature extending the entire length of the new Rental Car Center site (Pacific Highway between Washington Avenue and Sassafras Street). The feature should be visually engaging during the day and at night.

The bioswale in front of the building is the siting for the wayfinding project. This offers an intriguing opportunity to provide indicators about the environment, the site and the location (across from the bay). It is further envisioned that this feature should invite diverse interpretations while exploring a range of interactive media including, but not limited to: modular, large scale, dynamic, interactive, kinetic, time-based and/or web-based. This project will be highly visible for not only airport travelers but also the general public functioning as a symbolic portal to the Airport proper.

The selected artist/artist team(s) must take into consideration specific site conditions including but not limited to a bioswale, fire lane, and bike path. All considered media must be durable, low maintenance, and of a permanent nature.


**[A] LETTER OF INTEREST** | San Diego Rental Car Center

In our artistic endeavor we are passionate about creating experiences that engage people's curiosity by providing insights into the human condition. We are inspired by what is special and unique about a place, and we develop our highly site-specific artworks to reflect this in a universal way. This work always feels different and resonates deeply with audiences both intellectually and emotionally. Translating complexity into tangible experiences makes our work unique; we accomplish our goal to fill people with wonder for the enchanting world we live in.

San Diego is a nexus of movement and exchange whose natural harbor and proximity to the border, ideal weather and signature beaches make it a destination for so many. The concept of dynamic motion struck us as a key story point for the proposed artwork. We see great potential in weaving together a compelling narrative of various modes of transportation, referencing nautical, aeronautical and car travel. We envision visual parallels of the three modes that echo each other: the wakes left behind planes, boats and cars, as they move along. Seen from a plane, a boat's wake is visually similar to a plane's contrail as seen from the ground. Cars leave their own wake of sorts, visible as long streaks of lights, when captured through long exposure photography. The proximity of the airport to the bay helps to punctuate this story by providing a clear view of land, bay and sky and all of the "wakes" left from other travels. These visual similarities could lend themselves to long sculptural patterns of dynamic activity, spanning the length of the Rental Car Center. The installation will be seen during the day reflecting the sunlight, and glowing in intriguing ways at night. These wakes could be driven by real time data from the airport, the Rental Car Center, or the sea, and seen on a web site by people around the world. While these concepts are preliminary, we see them as fertile ground for a piece that would be unique and grounded in the essence of your locale.

As an artist team, we bring a wide range of creative skills and expertise in large-scale installations that will make this project successful. Through our backgrounds working at NASA and at Art Center College of Design we are exposed to the newest materials, fabrication methods, and brightest engineering minds. We also appreciate the spirit of collaboration and mutual respect that is required to create an artwork of this nature. We have collaborated with many architects, federal and city officials, public art panels, and engineers to create one-of-a-kind experiences. We work intimately with architects and general contractors to develop plans that ensure durability over time as well as ease of installation and maintenance.

Our artist platform ueberall INTERNATIONAL combines the flexibility of a nimble enterprise with the strength of an international network: ueberall artists and technologists work with clients in a flexible milieu, creating and fulfilling large-scale projects in professional alliances. We envision, design and create artwork that turns complexity and abstraction into highly tangible experiences that touch the mind and stir the soul. 





**01 + 02 eCLOUD** | 2010 | San José International Airport | City of San Jose Public Art Program | Budget: \$649,000.00

A dynamic sculpture inspired by the volume and behavior of an idealized cloud. The sculpture consists of thousands of small square panels of electrically switchable "Smart Glass" performing as pixels. This liquid crystal material progressively changes opacity with an electrical charge: in its neutral state the panel is opaque, and when electrified the material transitions to visually transparent. The animations moving through eCloud are based on real-time weather data from different destination airports. The National Oceanic and Atmospheric Administration provides these data. A monolithic Dynamic Display communicates the current dataset to the viewers. **AWARDS:** 2011 IDEA Award, IDSA, 2011 AIGA 365 Design Effectiveness Award. **03 AirFIELD** | 2012 | Hartsfield-Jackson International Airport, Atlanta GA | MHJIT Art Program | Budget: \$900,000.00

A dynamic sculpture synched to real-time flight data reflecting the heartbeat of the world's busiest airport. Suspended in the center of the International terminal, the data-driven art piece comprised of two intersecting sweeping forms evokes the wonder of flight. Each flight departure and landing (as many as 2500 daily) is echoed by a ripple effect throughout the sculpture, dynamically generated by a fluid-dynamics physics engine. Planes traveling a short distance create small ripples in the sculpture, while planes traveling a longer distance cause greater activity. A dynamic display on the mezzanine level of the terminal visualizes the actual flight data, so that travelers can learn more about the sculpture's behavior. **AWARDS:** 2013 SEGD Global Design Award. Solar-powered flexible poles that sway in the wind, topped by a rotating and illuminated bar emitting soft light impulses. Several poles are networked and programmed to create an overall light choreography reminiscent of swarm behavior.

Site-specific art piece that celebrates the dynamism and technical sophistication of BMW automobiles. The technical innovation is a grid of hundreds of programmable mirror elements that electronically morph from an opaque to a reflective state generating dynamic reflections of the show cars.





Approve *Intergalactic* as theme for the 2017 exhibition calendar year (February 2017 – January 2018)

#### **BACKGROUND**

The primary focus of the temporary installations and changing exhibitions program is to present a survey of collections representing a wide range of diversity in visual art and culture. Museums, cultural institutions, arts organizations as well as individual artists are invited to exhibit their collections of wares, artifacts and original artwork. All media is eligible for consideration.

#### **ANALYSIS/JUSTIFICATION**

Though space exploration and the realm beyond earth's atmosphere has long held a fascination for visual artists, recent events such as the Mars rover landing and the launch of private enterprise space ventures has led to a renewed interest in these subjects among the global arts community. This topic is of particular relevance to the Southern California region, which is home to many innovative organizations contributing to the burgeoning space industry including Space X and XCOR Aerospace.

The growing privatization of space travel has made access to space more attainable to the average citizen than ever before. In the coming years, this new field promises to revive notions of outer space within the collective imagination, and has already served as fodder for a number of successful contemporary art exhibitions on the subject.

Artistic responses to these developments range from imagined alien landscapes, to amateur research conducted by citizen scientists. Artists are often invited to explore the newly accessible frontier of space alongside scientists, aerospace experts, and engineers, resulting in pioneering research and educational tools.
