Written information was provided; a representative was present. Unanimous decision based on time of departure being after 11:30 p.m.

Panel Recommendation:

The Panel voted unanimously to assess a penalty in the amount of \$6,000.

**2. jetBlue Flight 530; June 4, 2018 @ 11:42 p.m.**

Panel Recommendation:

The Panel voted unanimously to assess no penalty (*FAA unable to retrieve jetBlue's Flight Plan*).
