The Commission has the legal responsibility to formulate airport land use compatibility plans ("ALUCPs") that will (a) provide for the orderly growth of each public airport and the areas surrounding the airport within the County and (b) safeguard the general welfare of the inhabitants within the vicinity of each airport and the public in general. Pursuant to §21670.3, the San Diego County Regional Airport Authority serves as the Commission.

This Agenda contains a brief general description of each item to be considered. The indication of a recommended action does not indicate what action (if any) may be taken. *Please note that agenda items may be taken out of order.* If comments are made to the Commission without prior notice or are not listed on the Agenda, no specific answers or responses should be expected at this meeting pursuant to State law.

ROGER GRIFFITH, EL CAJON, REPRESENTING COUNTY OF SAN DIEGO, spoke in opposition of the item and requested that the Commission allow at least sixty days for the County to better coordinate and communicate concerns with Commission staff in regard to this consistency determination.

TOM BOSWORTH, SAN DIEGO, REPRESENTING COUNTY OF SAN DIEGO, spoke in opposition of the item and requested an inconsistent determination by the Commission.

Report of Determinations of Consistency with Airport Land Use Compatibility Plans

Meeting Date: March 14, 2019

Pursuant to Airport Authority Policy 8.30, and acting in its delegated capacity as the Airport Land Use Commission (ALUC) for San Diego County, Airport Authority staff has issued the following consistency determinations per their respective ALUCPs:

Montgomery-Gibbs Executive Airport and San Diego International Airport (SDIA) ALUCPs

Mission Valley Community Plan Update, City of San Diego

Deemed Complete & Consistent on February 21, 2019

<u>Description of Project</u>: The proposed project involves the update of a community plan that provides some increased density and intensity allowances and changes of land use, but without any physical construction proposed.

<u>Noise Contours</u>: The proposed project is located outside the 60 dB CNEL noise contours for both airports, and no physical construction is proposed.

<u>Airspace Protection Surfaces</u>: The proposed project is located within the airspace protection boundaries for both airports and proposes to remove previous height limits, but does not propose any physical construction. The proposed project would be conditionally compatible if future construction within the project area complies with the airspace protection policies of the applicable ALUCP, including obtaining and complying with the conditions of a determination of no hazard from the Federal Aviation Administration (FAA) for any project meeting FAA notice criteria.

<u>Safety Zones</u>: The proposed project is located outside all safety zones and no physical construction is proposed.


Overflight Notification: The proposed project is located within the overflight notification area for both airports. The City provides overflight notification to affected properties through the Airport Land Use Compatibility Overlay Zone (ALUCOZ) for Montgomery-Gibbs Executive Airport and through the Airport Environs Overlay Zone (AEOZ) for SDIA, but no physical construction is proposed by this project.
