**NEW BUSINESS:**

**1. ACTION – APPROVAL OF THE SEPTEMBER 12, 2024 MEETING MINUTES**

Matt Rich made a motion for approval and Cat Chiu Phillips seconded the motion. The motion passed unanimously.

**2. ACTION – REVIEW AND APPROVE THE 2025 PERFORMING ARTS RESIDENCY SELECTION PANEL AND DESIGNATE AN ACC LIAISON.**

Tiffany Beres presented Policy 8.5, outlining the required approval of Selection Panels for the Temporary Exhibition and Performing Arts Residency Program. As a best practice, the Arts Program staff compiles a recommendation of panelists with a number of factors in mind. Specifically, the staff look for panelists who have significant local and industry leadership. They bring diverse expertise that may be from their artistic practice, alignment with SAN's DEI Initiatives, familiarity with public engagement and education, and/or direct experience with SAN's Art Program.

For the 2025 Performing Arts Residency Selection Panel, Daniel Dennert presented a proposed roster including Sunny Rey Azzarito, Jacole Kitchen, Colleen Kollar Smith, Christopher K. Morgan, Stephen Salts. The panel would include two members from the roster and an Airport Authority Arts Program staff member, most likely Daniel Dennert.

Lidia Martinez made a motion for approval and Matt Rich seconded the motion. The motion passed unanimously.

Adena Varner was designated as the ex-officio AAC liaison for the panel.

**3. ACTION – REVIEW AND APPROVE THE NT1 TEMPORARY EXHIBITION SELECTION PANEL AND DESIGNATE AN ACC LIAISON:**

For the New Terminal 1 (NT1) Temporary Exhibition Selection Panel, Tiffany Beres presented a proposed roster including Leah Goodwin, Christine Jones, Bob Lehman, Francisco Morales, Felicia Shaw, and Kayla Yap. The panel would include three members from the roster and two Airport Authority staff members, likely Daniel Dennert and Tiffany Beres.

Adena Varner made a motion for approval and Lidia Martinez seconded the motion. The motion passed unanimously.

Cat Chiu Philips will act as the ex-officio AAC liaison for the panel.

**OLD BUSINESS:**

**4. STAFF UPDATES:**

**General Updates**

Tiffany Beres provided an update that the NT1 opening offers a unique opportunity to assess and refine the program, expanding to more than double the current square footage. The team is focusing on two key strategic areas from the master plan: growing the performing arts program and strengthening cultural partnerships through temporary exhibition programming. These efforts aim to build capacity and enhance the program's impact as the terminal opens.

**Public Art**

Tiffany Beres provided an update on the seven public art projects planned for the New T1, along with the progress of each. She discussed the relocation of Artworks from SAN's Collection that will be moved into the new terminal.

**Temporary Exhibitions**

Daniel Dennert discussed the upcoming temporary exhibition, *Mirror Mirror* in Terminal 2. All sixteen artists have completed final concepts for their projects and are in production. Arts team staff are conducting studio visits. The current opening reception is planned for March 27, 2025.

### **Performing Arts**

Daniel Dennert spotlighted a few recent highlights of the ongoing Concert Series. The Arts Team works to collaborate with local organizations to celebrate special holidays and cultural events. Notably, we partnered with Resounding Joy for Veterans Day to present a performance from Veterans who are currently participating in Resounding Joy's music therapy program. Lidia Martinez inquired about feedback regarding the concerts. Daniel Dennert outlined that much of the feedback we receive is anecdotal or qualitative. There has been some historical surveying of audience members who responded well to performance activations. Presently, feedback is typically captured through short video clips or photos of special moments that are often shared on Authority social media channels. The Arts Team is always looking for ways to further document passenger and stakeholder response.

Daneil Dennert outlined that Malashock Dance, the current Performing Arts Resident, is 10 weeks into their 18-week residency. Malashock Dance is developing a project entitled "You Are Here/Usted Esta Aqui," a series of newly choreographed dances based on soundtracks made from traveler interviews conducted by the company over the holidays. The interviews focused on if someone was a San Diego resident or visitor, and the common threads that they feel represent the community. Performances are scheduled for late January and February. Based on feedback about accessibility, interested passengers are provided a program flyer about the work in both Spanish and English.

### **Community Engagement**

Community engagement enriches our Art Program. The Arts team visited the Cheech Marin Center for Chicano Art in Riverside. The Arts Team also hosted the Balboa Arts Conservation Center in October, Tiffany Beres and Daniel Dennert attended the AAAE Workshop, Arts and the Airport, in Philadelphia, PA in November.

### **Media**

Daniel Dennert shared a few examples highlighting ongoing efforts to showcase the Arts Program to the broader public including a special blog post made for Hispanic Heritage Month featuring interviews from artists a part of *Espacios & Lines*. Additional social media engagement statistics were presented, including on a particularly popular post of Octoberfest performances in the terminals.

### **NT1 Arts Strategy Consultants**

Tiffany Beres introduced consultant Gail Goldman of Gail Goldman Associates (GGA). GGA had been contracted earlier in the fall to develop a plan for a sustainable, innovative temporary exhibition program, aligned with the Arts Master Plan to enhance passenger experience and highlight cultural partners. Over the past few months, GGA conducted research, stakeholder interviews with the AAC,

community members, and internal staff, and outlined some initial programmatic options and components to consider for activating the new spaces a part of NT1.

Gail Goldman provided a status update on the project. Following her presentation, a discussion ensued in which several AAC members offered feedback on the exhibition program's overall goals. They expressed a strong desire to prioritize opportunities for local artists and voiced skepticism about the feasibility of implementing such a plan given staff capacity. Concerns were raised about the potential impact on the overall quality of the exhibition and the completeness of the content. AAC Members agreed to schedule an in-person Special AAC Meeting in January 2025 to continue discussions on the temporary exhibition plan.

**NEW BUSINESS:**

**1. REVIEW – Inaugural NT1 Temporary Exhibition Plan**

Jon Graves presented a brief background from the December 12, 2024 AAC meeting conversation that prompted this more in-depth conversation on a curatorial and programmatic strategy for the New Terminal 1 (NT1).

Tiffany Beres presented key findings from the research conducted by Gail Goldman and Associates (GGA). She highlighted elements that aligned well with the vision of AAC Members and Airport Authority staff, as well as components that raised concerns and required further clarification.

Arts Program staff presented a strategy for creating a temporary exhibition that welcomes travelers to the NT1 by celebrating the region's diverse cultural and historical vibrancy. They outlined programming options for the exhibition, focusing on a tiered approach based on the timing of

construction. The discussion also addressed concerns regarding the September deadline and staff capacity.

Two themes were proposed for the new exhibition: *Snapshot San Diego* and *Celebrate San Diego*. After careful consideration, the committee recommended Arts Program staff move forward with *Snapshot San Diego* as the preferred theme. This concept is envisioned as a Polaroid-style exhibition that highlights the region's arts and culture. The goal is to create a curated, authentic experience for travelers, offering a unique glimpse of San Diego beyond their brief stay at the NT1.

AAC Members expressed their support for the rollout of the temporary exhibition, acknowledging external factors that could impact implementation beyond the Arts Team's control. Realistically, Arts Program staff expect the Art Zone to be programmed by the time of opening. Wall-based and free-standing cases will be installed as possible, depending on procurement and operational timelines

Committee Members will be made aware when the call for proposals goes public so they can help advocate for and share the request for submissions to potential exhibitors.

### **BACKGROUND**

The T2E Connector is the approximately 150 feet long pedestrian walkway that connects Terminal One to Terminal Two. The SAN Art Program is seeking to commission a public artwork for this connector that will serve as a visual landmark for both those outside and inside the airport. The artwork should authentically capture the essence of this region while taking full advantage of San Diego's unique light.

The primary material for this public artwork will be glass or a glass treatment, creating an artwork that is dynamic and interactive, changing with the natural light throughout the day and offering an evolving experience for viewers. This artwork will integrate seamlessly into the existing architecture, enhancing both its aesthetic and functional qualities. Through its interaction with light, it will create a visually striking and engaging experience for travelers and airport employees alike.

This project addresses the following Arts Program outcomes as outlined in the Arts Program Master Plan:

- Experiences that are fresh, new, memorable and unforgettable; that are “takeaways.”
- Enhanced wayfinding through visual cues and landmarks.
- Enhanced appearance of airport infrastructure and design elements.
- Enhanced experience of monotonous or generic spaces.
- Environments / features / amenities that elevate the experience of travel and of public space
- Environments / features / amenities that are comforting and calming, mitigating the stress of travel.
- Arts experiences that locals and visitors can access without entering secure areas.

### **ANALYSIS/JUSTIFICATION**

Board Policy 8.5 states that the AAC will 'Approve selection process and Artist Selection and Review Panel composition for public art commissions.' Based on this policy, the Art Team proposes the following selection process, evaluation method and review panel composition:

**1. Selection Process:** The Art Team recommends a two-step selection process using a Request for Qualifications (RFQ) followed by a Request for Proposal (RFP). This process will first pre-qualify artists or artist-led teams for the project, then invite a select group of qualified candidates to submit specific proposals. To encourage local artist participation, there will be no minimum monetary threshold for previous public art commission values. Artists/artist-led teams will be required to demonstrate prior experience with public art commissions and a history of working with fabricators.

**2. Evaluation:** Given the anticipated strong participation, the Arts Team suggests that the evaluation process occur in three stages:

**Stage 1:** An Initial RFQ Review Panel will ensure that all applicants meet required experience. Evaluators will review and rank all applications to reach a desired pool of 50 qualified applicants.

- **Panel Composition:** Three (3) airport staff members, and two (2) members of the AAC.
- **Panel Responsibilities:** Based on the rankings, 50 candidates will be advanced to the next stage.

**Stage 2:** RFQ Review Panel Evaluation to review and rank candidates. To ensure community representation and feedback from arts industry experts, evaluators will be drawn from the Public Art Selection Panel nominations below.

- **Panel Composition:** Four (4) members from the Public Art Selection Panel, three (3) airport staff members, and one AAC member who will serve in an ex-officio capacity.
- **Panel Responsibilities:** Evaluate the RFQ submissions and shortlist up to four (4) finalists. These finalists will be invited to develop a conceptual proposal and interview, for which they will receive a fee.

**Stage 3:** RFP Review Panel Evaluation to select finalist. The same Public Art Selection Panelists who participated in Stage 2 will be invited to participate in Stage 3. If any of these panelists are unavailable, alternate members from the list of nominations will be invited to fill their place.

- **Panel Composition:** Four (4) external members from the Public Art Selection Panel, three (3) airport staff members, and one AAC member who will serve in an ex-officio capacity.

- **Panel Responsibilities:** Interview finalists, evaluate their proposals, and recommend one artist or artist-led team for the commission. The panel may also recommend an alternate.

### 3. Public Art Review Panel Nominations:

The Arts Team proposes eight nominations of community arts and culture representatives for the T2E Connector Public Art Review Panel, which includes additional nominations for contingency.

*Below are the biographies for the non-staff proposed members of the T2E Connector Public Art Review Panel:*

---

**Teddy Cruz** is a Professor of Public Culture and Spatial Practice at the UC San Diego, where his research focuses on urban issues in the Tijuana-San Diego region. Known for his work on border neighborhoods, Cruz explores the intersection of political economy, public space, and social practice. He co-directs the UC San Diego Center on Global Justice, addressing topics like migration, climate change, and urban informality. Cruz has received multiple prestigious awards, including the Rome Prize in Architecture and the Ford Foundation Visionaries Award. His exhibitions have appeared in prominent venues such as the Museum of Modern Art and the Venice Biennale.

**Carmen Cuenca** is an experienced arts professional and the Executive Director of INSITE Proyectos de Arte AC, where she has been instrumental in the development of INSITE since 1993. She has held key roles such as Director of the Tamayo Museum of Contemporary Art in Mexico City (2011-2014) and Subdirector for Visual Arts at the Centro Cultural Tijuana, where she oversaw the construction of EL CUBO. Cuenca has worked extensively with artists on both sides of the U.S.-Mexico border and coordinated several notable inSight art projects. She holds a degree in Art History from the Universidad Iberoamericana in Mexico City.

**Miki Iwasaki** is an artist and designer based in San Diego, originally from Southern California. With a passion for architecture, Iwasaki studied at California State Polytechnic University, Kyushu Institute of Design in Japan, and the Harvard Graduate School of Design. His career includes architectural work in various cities, spanning residential, office, and retail designs. Dedicated to personal art projects and furniture design, Iwasaki continuously explores new materials, methods, and creative ventures in architecture and design.

**Lynda Forsha** is an independent curator and the principal of Arts Advisory Services, where she advises private, corporate, and non-profit clients on contemporary art projects. Previously, she served as curator and head of the curatorial department at the Museum of Contemporary Art San Diego (MCASD), originating over 30 major exhibitions and commissioning numerous works of art. In 1993, she became director of inSITE, a collaborative project that commissioned 78 temporary installations and site-specific works across the San Diego/Tijuana region. Forsha also served as the public art program director for the City of San Diego from 2002 to 2005,

overseeing all phases of public art projects. She recently stepped down as Executive Director of Murals of La Jolla, a project aimed at enhancing the community through public art.

**Deborah Klochko** is the former Executive Director and Chief Curator of the Museum of Photographic Arts in San Diego. A leader in Visual Literacy, she is an expert in understanding how people see. Klochko has curated over 30 exhibitions and founded *Speaking of Light: Oral Histories of American Photographers*. She authored *Picturing Eden* and co-authored *Moment of Seeing: Minor White*. Klochko has held roles at The Friends of Photography, California Museum of Photography, and the Library of Congress. She holds an MA in Museum Education from George Washington University and an MFA in Photography from the Visual Studies Workshop.

**Lauren Lockhart** is an arts administrator with over 15 years of experience, currently serving as Executive Director of the La Jolla Historical Society. Previously, as Arts Program Manager for San Diego International Airport, she spearheaded major public art installations. Lockhart is committed to advancing public art and supporting emerging artists. She has held positions at the Museum of Contemporary Art San Diego, The New Children's Museum, and the National Gallery of Art. Lockhart holds degrees in Art History from UC San Diego and UC Riverside and is Co-Chair of the Public Art Coalition of Southern California.

**Jess Berlanga Taylor** is the Director and Curator of the Stuart Collection at UC San Diego, where she has commissioned over 40 artworks, many for public spaces in Mexico City. A bilingual, bicultural art professional, Berlanga Taylor has curated numerous exhibits and published over 100 essays and articles. She leads educational initiatives to promote public art and inclusion, enhancing the visibility of the Stuart Collection. Berlanga Taylor's leadership extends to advisory roles and collaborations with arts organizations locally and internationally.

**Sally Yard** is a Professor at University of San Diego and scholar specializing in 20th- and 21st-century art, with a particular focus on abstract expressionism and art's public engagement. Yard authored *Christo: Oceanfront* and has contributed to numerous exhibitions, including *Robert Irwin* and *Museum as Muse*. She has written extensively on postwar artists such as Willem de Kooning and Francis Bacon. Yard is the founding director of CoTA and has curated exhibitions across the United States. She is currently collaborating with artist Robert Irwin on a forthcoming book.

### **BACKGROUND**

The SAN Temporary Exhibition Program primarily focuses on showcasing a diverse range of visual art and culture, representing the broad spectrum of the region's creative landscape. Each year, the Arts Program selects a relevant theme for San Diego and the Airport, inviting museums, cultural institutions, educational groups, arts organizations, and individual artists to submit proposals related to that theme. Collectively, these exhibitions provide the traveling public with meaningful and imaginative perspectives.

The theme for the 2026 Temporary Exhibition will center on AI-created art, celebrating the intersection of evolving technology and human creativity, while highlighting San Diego's role as a hub for AI art production and innovation. With the decommissioning of the freestanding cases in Terminal 2 in preparation for their replacement, this exhibition will feature 6–10 artists. The works will primarily be displayed on terminal walls and within the built-in display cases, with a focus on 2-dimensional artworks. To ensure efficient use of staff resources, only pre-existing artworks will be included in the exhibition.

### **ANALYSIS/JUSTIFICATION**

Board Policy 8.5 states that the AAC will 'approve selection panels for Performing Arts Residency and Temporary Exhibition programs.' Based on this policy and following best practices for forming selection committees as outlined in the December 12, 2024, SAN Arts Advisory Committee Meeting Presentation, we propose seven nominations for the Terminal 2 Temporary Arts Selection Panel 2026, which include additional nominations for contingency. Additionally, two members of the Arts Program Staff will serve as voting members of the selection panel, and one AAC member will serve in an ex-officio capacity.

**Blanca Lucia Bergman** is a business consultant and founder and event producer for Art Unites, a resource for San Diego artists and art supporters, boasting partnerships with over 100 community leaders across various industries. In 2024, Bergman curated "AI ART REFANA," an online exhibition featuring representatives from San Diego's AI Art community.

**Ceci Moss** is the Director and Chief Curator of the Mandeville Art Gallery at UC San Diego, where she also serves as a Professor of Practice in the Department of Visual Arts. Moss has organized numerous exhibitions, performances, and public programs in museums and galleries. She has held previous positions as Director of Gas, Assistant Curator at Yerba Buena Center for the Arts, Senior Editor at Rhizome, and Special Projects Coordinator at the New Museum. She is the author of *Expanded Internet Art: Twenty-First Century Artistic Practice and the Informational Milieu*.

**May-ling Martinez** is a visual Artist and Educator was born and raised in San Juan, Puerto Rico, who currently lives and works in San Diego. She holds an MFA degree from San Diego State University (2007) and BA in Communications and Visual Arts from San Juan's Sacred Heart University (1996). May-ling Martinez was the recipient of the 2007-2008 San Diego Art Prize in the Emerging Artist category. May-ling Martinez is currently participating in *Mirror Mirror*, the current Terminal 2 temporary exhibition focusing on contemporary interpretations of light and space.

**Joe Nalven**, holds a Ph.D. in cultural anthropology and was co-director of SDSU's Institute for Regional Studies of the Californias, and a research associate at the Institute of Chicano Studies (Barrio Logan). Nalven is also a digital artist and co-author of *Going Digital: The Practice and Vision of Digital Artists* (Thompson Press 2005). He has also written numerous art blogs for the SDUT on San Diego artists as well as curated, juried and participated in many art shows in San Diego.

**Eun Jung Park** is a professor of art history at Southwestern College where she teaches art history survey courses in Asian Art as well as Modern and Contemporary Art. Park is a seasoned curator and specializes in transnationally, theory and methodology with interest in contemporary digital art. An advocate for public art, she has served as a member of the Commission for Arts and Culture Public Art Committee for the City of San Diego and on Port of San Diego's Arts, Culture & Design Committee.

**Elizabeth Rooklidge** is an art historian, curator, and writer based in San Diego who is currently an instructor at the University of San Diego. She previously served as Assistant Curator at the Museum of Contemporary Art San Diego and Associate Curator at the Katonah Museum of Art in New York. In 2020 she founded *HereIn Journal*, an online publication for exchange around contemporary art in San Diego. Elizabeth currently acts as Editor of the journal and frequently contributes writing and interviews.

**Jason Sherry** is a San Diego-based award-winning filmmaker, photographer, artist, writer, lecturer/professor—and, since the early 1980s, a long-time Comic-Con devotee—he is also the founder of MCASD's popular, annual film event, "alt.pictureshows". Jason Sherry is currently participating in *Mirror Mirror*, the current Terminal 2 temporary exhibition focusing on contemporary interpretations of light and space.






# Key Facts

- The connector structure is a narrow, sunlight-filled walkway
- It will be in a highly visible location, easily seen by people in vehicles leaving the Terminal One curbside pickup area and by those arriving at Terminal Two.
- Glass or a glass treatment is the preferred material for this public artwork, activating both the interior and exterior windows facing the roadway.
- Preliminary Project Art Budget for T2E Connector estimated at \$780k
- Construction to begin in 2027.






# RFQ to RFP Selection Process

- **Stage 1:** An Initial RFQ Review Panel will ensure that all applicants meet required experience.
  - **Panel Composition:** 3 airport staff members, and 2 members of the AAC.
  - **Panel Responsibilities:** Based on the rankings, 50 candidates will be advanced to the next stage.
- **Stage 2:** RFQ Review Panel Evaluation to review and rank candidates.
  - **Panel Composition:** 4 members from the Public Art Selection Panel, 3 airport staff members, and 1 AAC member who will serve in an ex-officio capacity.
  - **Panel Responsibilities:** Evaluate the RFQ submissions and shortlist up to 4 finalists. These finalists will be invited to develop a conceptual proposal and interview, for which they will receive a fee.
- **Stage 3:** RFP Review Panel Evaluation to select finalist.
  - **Panel Composition:** 4 external members from the Public Art Selection Panel, 3 airport staff members, and 1 AAC member who will serve in an ex-officio capacity.
  - **Panel Responsibilities:** Interview finalists, evaluate their proposals, and recommend 1 artist or artist-led team for the commission. The panel may also recommend an alternate.




# AI-Inspired Art

The origins of artwork incorporating the use of Artificial Intelligence (AI) can be traced back to 1968 when San Diego-based artist and professor Harold Cohen created *AARON*, one of the first AI programs designed for artmaking. This early project marks the genesis of human-machine collaboration, and today, AI is being embedded into the creative process more than ever before. Artists today use AI tools such as DALL-E, Midjourney, and Stable Diffusion, collaborating with algorithms and neural networks to generate artwork that is at once innovative and thought-provoking.

This proposed thematic exhibition will present a groundbreaking showcase of AI-created art, celebrating the evolution of technology as it intersects with human creativity. This exhibition explores the unique collaboration between artists and AI, highlighting how cutting-edge technology enhances the artistic process, rather than replacing it. The show will feature regional artists who embrace AI tools in their creative practice, further cementing San Diego as a central hub for the exploration of AI's role in contemporary art.
