| Background/Justification: | | | |
| On January 7, 2013, Judy Mohney ("Mohney") filed a claim (Attachment A) with the Authority alleging that on December 16, 2012, she sustained a fractured ankle while using a stairway in Terminal Two at San Diego International Airport. Mohney claims damages in an unknown amount to cover the cost of medical treatment. | | | |
| Mohney alleges in her claim that she was descending a stairway in Terminal Two in order to meet her daughter at baggage claim and using the railing. She states that she ended up on the floor about halfway down but is unsure if she missed a step because it was rather dark. | | | |
| Mohney's claim should be denied. An investigation into the incident revealed sufficient lighting required to see the entire stairway and escalator area including safety markings on the final step of each flight. The Authority received no notice of an unsafe condition of the stairway prior to the incident. | | | |
