#### CLAIM AGAINST SAN DIEGO COUNTY REGIONAL AIRPORT AUTHORITY

TO: SAN DIEGO COUNTY REGIONAL AIRPORT AUTHORITY 3225 N. Harbor Drive, San Diego, CA 92101

1. Name and address of claimant:

Arlene LaPlante 4828 Seda Drive; San Diego, CA 92124

2. Arlene LaPlante hereby asserts a claim against the San Diego County Regional Airport Authority (hereinafter "the Authority") for personal injuries and other related damages. The date, place, and circumstances of the occurrence that gave rise to this claim are as follows:

In the course of the management of the day-to-day operations of the San Diego International Airport, the Authority, via the fictitious business name of SAN PARK, operates and maintains off-site, long-term parking lots, including a lot located at 3302 Pacific Highway in the City of San Diego. In order to provide transportation for the lots' patrons to and from the airport, the Authority operates and maintains a fleet of vans with drivers. The fleet includes a certain Ford E-450, License # 8Y57523, designated as SAN PARK No. 97, which services the Pacific Highway lot.

On or about August 7, 2012, at approximately 5:40 a.m., after having parked her car at the Pacific Highway lot, Arlene LaPlante and other patrons of the lot were being transported to the airport in Van No. 97, which was then being operated by its uniformed driver, Eugene. As the van approached the curbside check-in counter for Southwest Airlines, the driver unexpectedly and suddenly accelerated the vehicle, and Ms. Laplante's seat, including its back, flew off its pedestal. As a result, Ms. Laplante and the seat crashed to the floor thereby injuring Ms. LaPlante's spine. An immediate inspection of the detached seat by the driver revealed that it had not been properly attached to its pedestal; therefore, the van was then taken out of service.

- 3. It is the claimant's contention that the Authority, through its authorized agents and employees, is legally responsible for the claimant's injuries as a result of the driver's negligent operation of the van, and as a result of the Authority's negligent maintenance of the vehicle, and as a result of the incidental dangerous condition of public property.
- 4. The amount of damages claimed, as of the date of presentation of this claim, is a sum that would require the filing of a civil suit of unlimited jurisdiction.
