Rescission of Resolution No. 2010-0036 ALUC

Recommendation:

Adopt Resolution No. 2012-0002 ALUC, rescinding Resolution No. 2010-0036 ALUC, making a determination that a project involving the construction of two office and research and development buildings located at 7475 Lusk Boulevard, City of San Diego was consistent with the Marine Corps Air Station (MCAS) Miramar Airport Land Use Compatibility Plan (ALUCP) in effect at the time of the determination.

Background/Justification:

On July 1, 2010, the San Diego County Regional Airport Authority, acting in its capacity as the Airport Land Use Commission (ALUC) for San Diego County, pursuant to Section 21670.3 of the Public Utilities Code, adopted Resolution No. 2010-0036 ALUC making a determination that a project involving the construction of two office and research and development buildings located at 7475 Lusk Boulevard, City of San Diego was consistent with the Marine Corps Air Station (MCAS) Miramar Airport Land Use Compatibility Plan (ALUCP) in effect at the time of the determination.

On November 10, 2011, ALUC staff received an application for a consistency determination from the City of San Diego for an amendment to the project previously found consistent by the ALUC pursuant to Resolution No. 2010-0036 ALUC. The amended project involves a single office and research and research & development building.

On December 2, 2011, ALUC staff, pursuant to the provisions of the MCAS Miramar ALUCP allowing for staff-level consistency determinations for projects that are compatible in all respects, issued a consistency determination regarding the amended project finding that the amended project is compatible with noise, safety, and airspace compatibility factors. ALUC staff's consistency finding on the amended project was reported to the ALUC at its meeting of January 5, 2012.

The amended project, determined to be consistent by ALUC staff on December 2, 2011, supersedes the project reviewed by the ALUC and found consistent by Resolution No. 2010-0036 ALUC. Therefore, Resolution No. 2010-0036 ALUC is no longer accurate and must therefore be rescinded.

A RESOLUTION OF THE AIRPORT LAND USE COMMISSION FOR SAN DIEGO COUNTY RESCINDING RESOLUTION NO. 2010-0036 ALUC, MAKING A DETERMINATION THAT A PROJECT INVOLVING THE CONSTRUCTION OF TWO OFFICE AND RESEARCH AND DEVELOPMENT BUILDINGS LOCATED AT 7475 LUSK BOULEVARD, CITY OF SAN DIEGO WAS CONSISTENT WITH THE MARINE CORPS AIR STATION (MCAS) MIRAMAR AIRPORT LAND USE COMPATIBILITY PLAN (ALUCP) IN EFFECT AT THE TIME OF THE DETERMINATION
