Subject:

Authorize the Rejection of the Claim of Bobby Fikes

Recommendation:

Adopt Resolution No. 2012-0026, authorizing the rejection of the claim of Bobby Fikes.

Background/Justification:

On January 19, 2012, Bobby Fikes ("Fikes") filed a claim (Attachment A) with the Authority alleging that on July 21, 2011, his daughter Mekeda injured her foot as they rode down the escalator in Terminal One at San Diego International Airport. Fikes claims damages in an unknown amount that exceeds ten thousand (\$10,000) dollars.

Fikes alleges in his claim that on July 21, 2011, he and his daughter were riding the escalator in Terminal One when his daughter's foot became caught between the escalator step and the stationary side wall, requiring the response of the San Diego Fire Department and their Heavy Rescue group to free her foot. Fikes claims his daughter was transported to the Emergency Room at Rady Children's Hospital where she was released the next day.

Fikes's claim should be denied. An investigation into the incident revealed no unsafe condition nor any notice to the Authority of an unsafe condition of the escalator. Video retrieved of the incident appears to show the claimant and his daughter on the escalator with the daughter alternately facing forward and facing sideways, situating her opentoed sandals up against the stationary side as the steps descend. The claimant is holding her hand but faces forward and is completely unaware that his daughter has her feet on the side of the escalator. As they near the bottom of the escalator where the steps proceed to collapse into one another to create a flat walking surface, the upward motion of the step against the stationary side pulls the daughter's sandal into the miniscule space between the steps and the wall. At this point, the escalator safety feature triggers a complete stop of the escalator and rescue efforts ensue. Once her foot was released, paramedics found a minor cut under a toe and she was able to move and wiggle her toes.
