


# SAN DIEGO COUNTY REGIONAL AIRPORT AUTHORITY STAFF REPORT

# Subject:

Approve and Authorize the President/CEO to Execute an Architect and Engineering Consultant Services Agreement supporting the CONRAC Development Project

## **Recommendation:**

Adopt Resolution No. 2012-0068, approving and authorizing the President/CEO to execute a Consolidated Rental Car Facility ("ConRAC") Development Architect and Engineering Consultant Services Agreement with Demattei Wong Architecture, Inc., for a term of four years, with the option for a one-year extension, in an amount not-to-exceed \$10,000,000, in support of the ConRAC Development Project, at San Diego International Airport.

# **Background/Justification:**

The San Diego County Regional Airport Authority's ("Authority") ConRAC Development Project will provide a long-term facility for rental car facilities at San Diego International Airport "("SDIA") located on the northerly portion of the Airport, from which all rental car companies serving SDIA will operate. A single, common bussing operation will transport the traveling public utilizing rental car services between the passenger terminals and the ConRAC. The ConRAC site is comprised of 17 acres on the north east quadrant of SDIA and the facility will have 4 levels and 5,000 vehicle spaces. The facility consists of 127,780 square feet ("SF") of Customer Service Area; 1,308,190 SF of Ready/Return and Storage Area; and, 291,015 SF of Quick Turn-Around Area, for a total building area of 1,726,975 SF. The facility will be accessed by a dedicated elevated roadway.

On March 12, 2012, a Request for Qualifications ("RFQ") was issued to obtain Statements of Qualifications ("SOQs") from qualified firms, to provide ConRAC Development Architect and Engineering Consultant Services, for the Authority.

A Selection Panel ("Panel") was comprised of key representatives from the Authority's Finance and Development Divisions, together with two external representatives from the rental car industry.

On April 10, 2012, the Authority received six SOQs from prospective consultant firms. The Panel conducted a thorough review of the SOQs and determined that one firm was uniquely qualified to perform the requested services.

The Panel interviewed and ranked the short-listed firms as follows:

- 1. Demattei Wong Architecture, Inc.
- 2. Fentress Architects
- 3. RJC Architects, Inc.
- 4. Transystems
- 5. Tucker Sadler Architects, Inc./Pierce Goodwin Alexander & Linville (PGAL)
- 6. Walter P. Moore and Associates, Inc.

The Evaluation Criteria used to rank the firms was the firm's proposed project manager experience, project team and prior experience, ConRAC project and professional background; organization structure; proposed work plan and approach/methodology; understanding of the scope of work, and work plan and approach to effectively accomplish the scope of work. Also, Authority Policy 5.12 for Small Business was utilized for the selection.

The Panel determined that based on the ranked score, Demattei Wong Architecture, Inc. ("DWA") was the top firm. DWA demonstrated the best work plan and approach, most experienced Project Manager and Project Team, and previous experience for successfully designing previous projects of similar size and complexity. A brief background of the firm is provided:

#### Demattei Wong Architecture, Inc.

Demattei Wong Architecture, Inc. (DWA) has been an existing architectural and engineering consultant since 1981. DWA has specialized knowledge combining numerous years of SDIA project experienced with over 47 years of rental car experience, including over 600 Rental Car projects and 39 ConRAC's around the nation. DWA headquarters are located in Dallas, TX, with an office in Burlingame, CA. Of the DWA team and Sub-Consultants, 10 of the 15 team members are with firms located in San Diego. Some of the representative project experiences are:

- Phoenix Sky Harbor International Airport ConRAC
- Seattle-Tacoma International Airport ConRAC
- Nashville International Airport ConRAC
- Miami International Airport ConRAC
- Fort Lauderdale-Hollywood International Airport ConRAC
- Honolulu International Airport ConRAC

In order to enter into an On-Call ConRAC Development Architect and Engineering Consultant Services Agreement with the top ranked firm, Authority Staff ("Staff") will negotiate the scope of work and billing rates. If Staff cannot reach an agreement with the top ranked firm, Staff will then enter into negotiations with the next ranked firm. Under the proposed resolution, the President/CEO would then have the authority to award an agreement to the next ranked firm and establish an agreement with that firm.

# **Fiscal Impact:**

Funds for the Architect and Engineering Consultant Services Agreement will be provided by Customer Facility Charges or Special Facility Debt, which are the funding sources identified for the approved ConRAC project. To date, the Authority Board has approved the use of \$60,000,000 for the ConRAC design and enabling project.

A RESOLUTION OF THE BOARD OF THE SAN DIEGO COUNTY REGIONAL AIRPORT AUTHORITY APPROVING AND AUTHORIZING THE PRESIDENT/CEO TO EXECUTE A CONSOLIDATED CAR FACILITY ("CONRAC") RENTAL DEVELOPMENT ARCHITECT AND ENGINEERING CONSULTANT SERVICES AGREEMENT WITH DEMATTEI WONG ARCHITECTURE, INC., FOR A TERM OF FOUR YEARS, WITH THE OPTION FOR A ONE-YEAR EXTENSION, IN AN AMOUNT NOT-TO-EXCEED \$10,000,000, IN SUPPORT OF THE CONRAC DEVELOPMENT PROJECT, AT SAN **DIEGO INTERNATIONAL AIRPORT**

WHEREAS, the Panel interviewed and ranked short-list firms; and

Also, Authority Policy 5.12 for Small Business was utilized for the selection; and

WHEREAS, the Panel conducted a thorough review of the SOQs and determined that Demattei Wong Architecture, Inc., was the most qualified to perform the requested Consultant Services for the Consolidated Rental Car Facility ("ConRAC") Development Project; and
