Subject:

Approve and Authorize the President/CEO to Execute a First Amendment to the On-Call Survey and Civil Engineering Consulting Services Agreement with Nolte Associates, Inc.

Recommendation:

Adopt Resolution No. 2012-0098, approving and authorizing the President/CEO to execute a First Amendment to the Agreement with Nolte Associates, Inc., extending the term of the agreement by one (1) year, to expire on October 1, 2013, to provide on-call professional survey and civil engineering consulting services for Capital Improvement, Tenant Improvement, and Major Maintenance projects.

Background/Justification:

The San Diego County Regional Airport Authority ("Authority") currently has an agreement with Nolte Associates, Inc. ("Nolte") to provide professional survey and civil engineering consultant services for Capital Improvement, Tenant Improvement, and Major Maintenance projects. The existing agreement commenced in May 2010 and will expire on October 1, 2012. Staff proposes extending the term of the existing agreement by one year in order to complete a Federal Aviation Administration ("FAA") required obstruction study of the airport and to maintain consistency in the surveying of large, ongoing airport and tenant construction projects.

Nolte recently prepared, and submitted to the FAA, a comprehensive elevation survey (obstruction study) of the airport and its surroundings. The survey was prepared in accordance with the latest FAA Airport Geographic Information Systems ("AGIS") Advisory Circular Requirements. The FAA review of the survey is expected to take six months or more. Extending the agreement will allow Nolte to support the Authority by answering questions about the survey and to make any corrections which may be required.

Also, Nolte is the Surveyor of Record for various airport and tenant property and easement legal maps. Extending the existing agreement by one year will allow Nolte to provide the necessary surveying support for the Authority's ongoing Capital Improvement, Concession Development, and Major Maintenance Projects. In addition, extending the agreement will allow Nolte to assist the Authority in ensuring consistency of surveys through the completion of the Green Build project.

The existing agreement has a maximum on-call capacity of \$2,500,000. Because approximately 56% of the total funding for this existing agreement remains, no additional funds are requested for the extended term of the agreement. Also, the compensation terms and conditions will remain the same.

Fiscal Impact:

Funds for the On-Call Survey and Civil Engineering Consultant Services Agreement is contained within the budgets of projects included in the San Diego County Regional Airport Authority ("Board") approved FY2012-2017 Capital Improvement Program and annual Major Maintenance allocation. The funding source for capital projects is dependent on the project utilizing the on-call services and includes, but is not limited to, Federal Entitlement and Discretionary Grants, Passenger Facility Charges, Commercial Paper, and General Airport Revenue bonds. The financing source for Major Maintenance projects is the Facilities Development operating budget.

RESOLUTION NO. 2012-0098

A RESOLUTION OF THE BOARD OF THE SAN DIEGO COUNTY REGIONAL AIRPORT AUTHORITY, APPROVING AND AUTHORIZING THE PRESIDENT/CEO TO EXECUTE A FIRST AMENDMENT TO THE AGREEMENT WITH NOLTE ASSOCIATES, INC., EXTENDING THE TERM OF THE AGREEMENT BY ONE (1) YEAR, TO EXPIRE ON OCTOBER 1, 2013, TO PROVIDE ON-CALL PROFESSIONAL SURVEY AND CIVIL ENGINEERING CONSULTING SERVICES FOR CAPITAL IMPROVEMENT, TENANT IMPROVEMENT, AND MAJOR MAINTENANCE PROJECTS

WHEREAS, in May 2010, the San Diego County Regional Airport Authority ("Authority") awarded an agreement to Nolte Associates, Inc. ("Nolte") to provide on-call professional survey and civil engineering consultant services; and

WHEREAS, the agreement with Nolte provides for professional on-call survey and civil engineering consultant services for Capital Improvement, Tenant Improvement, and Major Maintenance projects; and

WHEREAS, the existing agreement will expire on October 1, 2012; and

WHEREAS, Nolte recently prepared, and submitted to the Federal Aviation Administration ("FAA"), a comprehensive elevation survey (obstruction study) of the airport and its surroundings. The survey was prepared in accordance with the latest FAA Airport Geographic Information Systems ("AGIS") Advisory Circular Requirements. The FAA review of the survey is expected to take six months or more. Extending the agreement will allow Nolte to support the Authority by answering questions about the survey and to make any corrections which may be required, and

WHEREAS, Nolte is the Surveyor of Record for current on-going design and construction projects, and support for these projects will be required through August 2013. Extending the existing agreement by one year will allow Nolte to provide the necessary support for the Authority's Capital Improvement, Concession Development, and Major Maintenance Programs. In addition, extending the agreement will allow Nolte to assist the Authority in ensuring consistency of surveys through the completion of the Green Build project; and

WHEREAS, approximately fifty-six percent (56%) of the funding in the agreement remains unexpended; therefore, no additional funds are requested for the extended term of the existing agreement; and

WHEREAS, the agreement's compensation terms and conditions will remain the same; and

WHEREAS, this request is to extend the term of the existing agreement by one year, to continue to provide on-call professional survey and civil engineering consultant services to support Capital Improvement, Tenant Improvement, and Major Maintenance projects.

NOW, THEREFORE, BE IT RESOLVED that the Board hereby approves and authorizes the President/CEO to execute a First Amendment to the agreement with Nolte Associates, Inc., extending the term of the agreement by one (1) year to expire on October 1, 2013, to provide on-call survey and civil engineering consulting services for Capital Improvement, Tenant Improvement, and Major Maintenance projects.

BE IT FURTHER RESOLVED that the Authority and its officers, employees, and agents hereby are authorized, empowered, and directed to do and perform all such acts as may be necessary or appropriate in order to effectuate fully the foregoing resolutions; and

BE IT FURTHER RESOLVED that the Board of the San Diego County Regional Airport Authority finds that this Board action is not a "project" as defined by the California Environmental Quality Act (CEQA) Pub. Res. Code Section 21065; and is not a "development" as defined by the California Coastal Act Pub. Res. Code Section 30106.
