Award a Contract to SOLPAC Construction, Inc., d.b.a. Soltek Pacific Construction Company to Expand Terminal 2 East: Gate 25-Gate 27 Holdrooms at San Diego International Airport

Recommendation:

Adopt Resolution No. 2012-0124, awarding a contract to SOLPAC Construction, Inc. d.b.a. Soltek Pacific Construction Company in the amount of \$11,941,000 for Project No. 104056, to expand Terminal 2 East Facility: Gate 25-Gate 27 Holdrooms at San Diego International Airport.

Background/Justification:

The Project will upgrade the Terminal 2 East building between Gate 25 and Gate 27 and between Gate 24 and Gate 28 to increase holdroom capacity, create new concessions, provide necessary infrastructure for future use of passenger transport vehicles, relocate the existing tenant clubroom to allow for the buildout of the adjacent roof area above the American Airlines baggage make-up area, and create a new post-security concession area. The existing pre-security food court area will also be reconfigured to increase ticket counter queuing and passenger circulation areas and to provide for new concessions.

The project has been divided into three (3) separate contract packages:

- Upgrade T2E Facilities: Terminal Building (Approved November 3, 2011 Board Meeting)
- Upgrade T2E Facilities: Gate 24-Gate 28 (Approved January 5, 2012 Board Meeting)
- 3. Upgrade T2E Facilities: Gate 25-Gate 27

This contract is for the Gate 25-Gate 27 work only (Item 3, above).

The Scope of Work for this contract includes expansion between Gate 25-Gate 27 to increase holdroom capacity; create new concessions and new food court area; fabrication of new fixed bridge section for Gate 27 Passenger Boarding Bridge; and replacement of existing rolled carpet in the existing T2E concourse, holdrooms, security checkpoint, and ticket lobby areas with terrazzo tile and carpet tile.

WHEREAS, the Scope of Work for this contract includes expansion between Gate 25-Gate 27 to increase holdroom capacity; create new concessions and new food court area; fabrication of new fixed bridge section for Gate 27 Passenger Boarding Bridge; and replacement of existing rolled carpet in the existing T2E concourse, holdrooms, security checkpoint, and ticket lobby areas with terrazzo tile and carpet tile; and

WHEREAS, the San Diego County Regional Airport Authority ("Authority") issued a Bid Solicitation Package for this contract on August 30, 2012; and

WHEREAS, on October 2, 2012, the Authority opened sealed bids received in response to the Bid Solicitation Package; and

WHEREAS, the apparent low bidder, SOLPAC Construction Company, Inc. dba Soltek Pacific Construction Company, submitted a bid of \$11,941,000 and the Authority's staff has duly considered Soltek Pacific Construction Company's bid, and has determined Soltek Pacific Construction Company is responsible, and that its bid is responsive in all material aspects; and

WHEREAS, the San Diego County Regional Airport Authority Board ("Board") believes that it is in the best interest of the Authority and the public that it serves, for the Board to award SOLPAC Construction Company, Inc., d.b.a. Soltek Pacific Construction Company, the contract for Project No. 104056, Expand Terminal 2 East Facility: Gate 25-Gate 27, upon the terms and conditions set forth on the Bid Solicitation Package.

NOW, THEREFORE, BE IT RESOLVED that the Board hereby AWARDS a contract to SOLPAC Construction, Inc., d.b.a.
