TO THE AIRPORT LAND USE COMPATIBILITY PLANS FOR BROWN
FIELD MUNICIPAL AIRPORT, GILLESPIE FIELD, MARINE CORPS AIR
STATION MIRAMAR, MONTGOMERY FIELD, AND OCEANSIDE
MUNICIPAL AIRPORT:

Keith Wilschetz, Director, Airport Planning, provided a presentation on Possible Amendments to Airport Land use Compatibility Plans, which included the Purpose of Requested Amendments, Safety Clarification for Three Land Uses, Upgrades for Non-Conforming Structures, Quantifying "Ancillary" Uses, Method of Calculating Maximum Use of Site for Mixed-Use Projects, Evaluating New Uses Within Existing Structures, ALUC Review for Review Area 2 Projects, Threshold of Change for ALUC Review, ALUCP Applicability to Amended Projects, and ALUC Review of Projects that are Entirely Consistent.

In regards to slide 7 regarding Upgrades for Non-Conforming Structures, Board Member Finnila suggested that the statement "increased only if necessary" be changed to "increased only to the extent necessary". She also suggested that approvals from the jurisdictions be added, and reminded the Commission that the most important factor is safety.

Chair Gleason noted that, in regards to whether or not an ALUC review would be required, that a 10% change would be acceptable if it does not otherwise make the project inconsistent.

Board Member Robinson suggested that language be added in regards to any increase in the total building area that the changes would be cumulative.

Board Member Desmond requested that the ALUC receive a report of all consistency determinations that do not require Commission approval.

TAIT GALLOWAY, SAN DIEGO, City of San Diego, spoke in support of the recommended changes.

Chair Gleason requested that the Board receive the City's comments regarding this issue in advance of the December meeting.

Board Member Finnila stated that the definition of infill needs to be very clear. She requested that staff gather comments from the jurisdictions prior to the next ALUC meeting.

MARCELA ESCOBAR-ECK, CARLSBAD, Atlantis Group Land Use Consulting Team, spoke in support of staff's recommendations.

RECOMMENDATION: Direct staff to prepare amendments to Airport Land Use Compatibility Plans along with associated environmental documentation for future consideration.

ACTION: The Commission provided direction to staff, but no action was taken.
