Sandi Sawa, Manager, Airport Planning, provided a presentation on the Status Update on the Preparation of Airport Land Use Compatibility Plans.

PRESENTATION AND POSSIBLE POLICY DIRECTION ON AIRPORT LAND USE COMPATIBILITY PLANS AND ENVIRONMENTAL DOCUMENTATION FOR BROWN FIELD, GILLESPIE FIELD, MCCLELLAN-PALOMAR AIRPORT, MONTGOMERY FIELD, AND OCEANSIDE MUNICIPAL AIRPORT: Sandi Sawa, Manager, Airport Planning, provided a presentation which included the Urban Airport Land Use Compatibility Plans (ALUCP) Process; Public Comment Process; and a detailed summary of staff recommendations regarding the following areas of concern:
 - Negative Declaration or EIR Economic Considerations
 - Cost-Benefit/Economic Analysis
 - Intensity Numbers; Risk Reduction Measures
 - Avigation Easements in Safety Zones 2-5
 - Infill Policy
 - Safety Zone Delineation
 - 55-60dB Noise Contour

BARRY BARDACK, EL CAJON, spoke in support of requesting avigation easements, and staff's recommendation.

JOHN RIESS, BONITA, spoke in support of having an Environmental Impact Report (EIR).

MELANIE KUSH, SANTEE, urged the Commission to move forward with conducting an EIR.

CHUCK COLLINS, CARLSBAD, spoke in support of requiring avigation easements.

WILLIAM ANDERSON, SAN DIEGO, recommended that existing local conditions should be considered when establishing the safety limitations, the risk reduction measures should be replaced with a policy framework, and the mandatory risk reduction measures for Safety Zone 2 should be replaced with a policy intent. NEIL HYYTIVEN, SAN DIEGO, spoke in opposition to finalizing the Urban Airports ALUCP's until cost benefits analyses are completed.

ANDREW POAT, SAN DIEGO, spoke in opposition to finalizing the Urban Airports ALUCP's until cost benefits analyses are completed, along with an EIR.

ANGELIKA VILLAGRANA, SAN DIEGO, spoke in opposition to finalizing the Urban Airports ALUCP's until cost benefits analyses are completed.

JERRY LIVINGSTON, SAN DIEGO, spoke regarding the need for a cost benefit analyses and EIR.

JOHN ZIEBARTH, SAN DIEGO, urged the Commission to complete an EIR, and cost benefit analysis.

MEL INGALLS, SAN DIEGO, spoke in opposition to staff's recommendation.

MICHAEL GRIM, CARLSBAD, spoke regarding the minimum level of development and People Per Acre (PPA) intensity levels.

ROBIN MUNRO, SAN DIEGO, spoke in opposition to finalizing the Urban Airports ALUCP's until an EIR, and related reports are completed.

TED SHAW, SAN DIEGO, urged the Commission to do a cost benefit analyses.

Board Member Panknin suggested that Urban Airports Plans be divided and submitted to each jurisdiction that is impacted, and that the Authority work with the local jurisdictions to address specific conditions, and to tailor the Plans using the cost benefit and safety analyses.

Board Member Boland stated that staff has done a good job with the general guidelines, and that it is up to the jurisdictions to address the concerns specific to their area.

Board Member Finnila requested that staff provide their definition of avigation easements and their use, and suggested addressing each policy issue separately.

The Board concurred to direct staff to report back at the October Board meeting with its plan on how to address outstanding policy issues.

Board Member Young stated that it is his opinion that the plan should include some type of interaction with Airport Technical Advisory Group (ATAG).
