MEETING SUMMARY

COMMITTEE COMMENTS

After the presentations, GTAC members had the opportunity to ask questions of each expert and note findings that are beneficial to the committee's efforts. The following comments were made, grouped by general topic:

Apps

- eDispatch (virtual hold lot) in San Diego app-based, text messaging more information is desired
- Controlling communication of vehicle location
- The use of apps requires a common platform best managed by a non-governmental entity
- It is beneficial to try out competitors' apps to understand opportunities

Transit

- Public transit is well suited to serve this region's transportation needs; trolley needed
- Transit options should provide flexibility to improve airport accessibility; decided by the region
- Transit 992 Bus modify to allow for better storage of luggage
- Transportation Research Board reports on ground transportation are beneficial
- Congestion-based/demand-based pricing should be considered

Fees

- Tolling mechanisms and universal processing, and shared, multi-mode auto dispatch are trends
- Level playing field consider the cost to customer first, as well as convenience to customer
- Every commercial operation could pay a trip fee

TNCs

- Each state has different policies for TNCs
- TNCs are impacting parking needs create flexibility in parking options
- At Los Angeles International Airport, 75% of TNC trips are re-match

Parking

 Terminal 1 Parking & Terminal 2 Parking: plaza versus garage options, right number of spaces

Data

- There is a need for better inter-agency cooperation
- Data at airports is the focus on major new initiatives around the country, focus is on TNCs
- A clearing house of data would be of value
