## Subject:

Award a Contract to Flatiron West, Inc., to Construct Washington Street Access Improvements, at San Diego International Airport

#### **Recommendation:**

Adopt Resolution No. 2012-0066, awarding a contract to Flatiron West, Inc., in the amount of \$2,873,776.00, for Project No. 104124, Washington Street Access Improvements at San Diego International Airport.

## **Background/Justification:**

In June 2010, the San Diego County Regional Airport Authority Board ("Board") approved the 2011-2015 Fiscal Year Capital Improvements Program ("CIP"). Included within the CIP is a project to improve airport access at Washington Street, to serve the Central Receiving and Distribution Center ("CRDC"), which is currently under construction. This project will improve traffic circulation and provide unimpeded access to the CRDC and Air Cargo facilities.

These improvements comply with the agreements with the U.S. Marine Corps Recruit Depot ("MCRD") approved by the Board on January 25, 2012.

This contract was advertised for bids on April 11, 2012. Sealed bids were opened on May 15, 2012, and a detailed bid tabulation of all bids is shown in Attachment "A". The following is a summary of all bids received:

The engineer's estimate for this project was \$3,674,861.

After evaluation of bids, Built Pacific, Inc., the apparent low bidder, had numerous mathematical errors, which resulted in an adjustment to its total bid amount from \$2,798,970.83 to \$2,930,643.00.

As such, the lowest bid submitted by Flatiron West, Inc., in the amount of \$2,873,776.00, is considered responsive and award to this responsible bidder is recommended. Authority Policy 5.14, Small Business, Local Business and Service Disabled Veteran Owned Small Business Goal and Preference Program, was applied in the selection process and it allowed Flatiron West, Inc., to maintain its low bid status.

## **Fiscal Impact:**

Adequate funds for the contract with Flatiron West, Inc., are included within the FY2012-FY2016 Capital Budget in Project No. 104124, Washington Street Access Improvements. Sources of funding for this project included Airport Revenue Bonds and Customer Facility Charges (CFCs).

## **Environmental Review:**

This Board action is not a "project" subject to CEQA, Pub. Res. Code §21065.
- B. This Board action is not a "development" as defined by the California Coastal Act. Cal. Pub. Res. Code §30106.

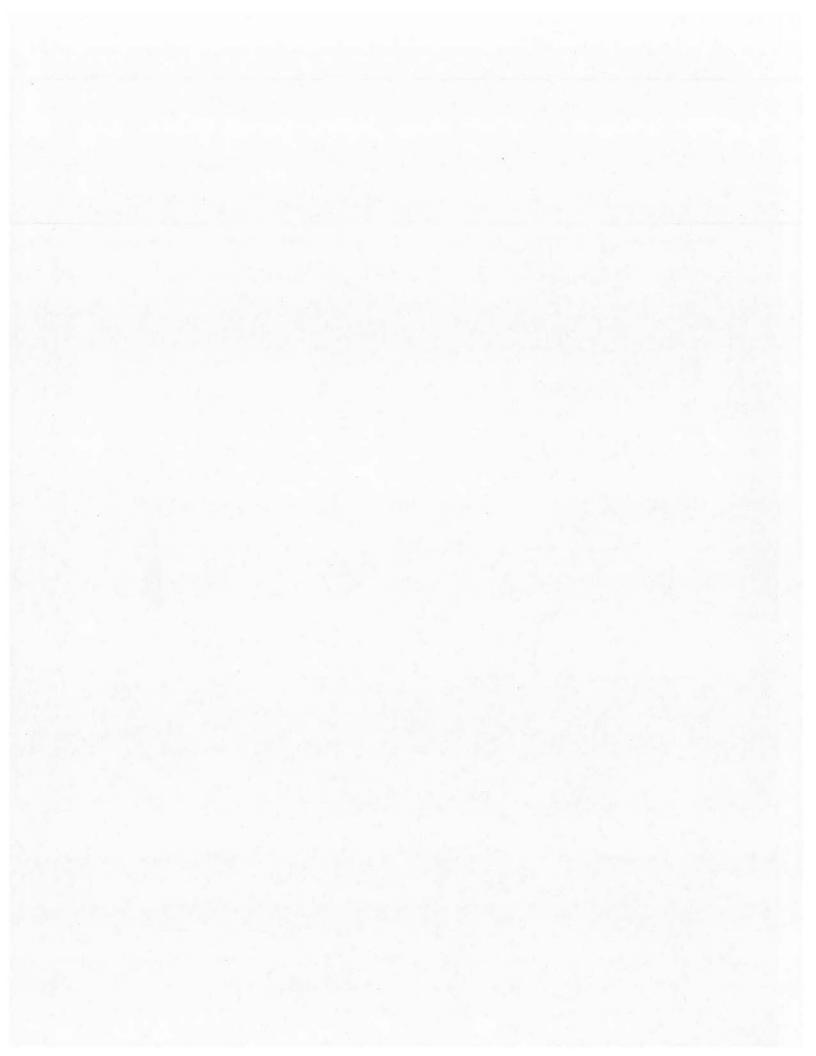
This project does not utilize federal funds; therefore, it will not be applied toward the Authority's over-all DBE goal.

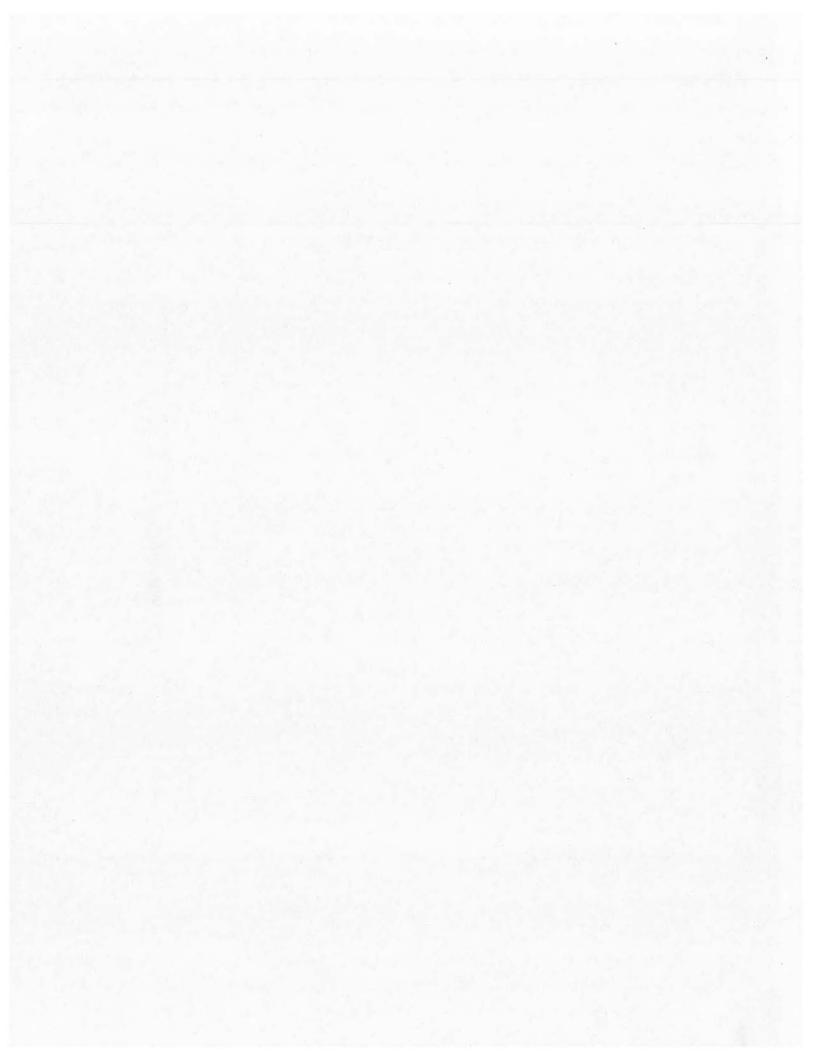

A RESOLUTION OF THE BOARD OF THE SAN DIEGO COUNTY REGIONAL AIRPORT AUTHORITY AWARDING A CONTRACT TO FLATIRON WEST, INC., IN THE AMOUNT OF \$2,873,776.00, FOR PROJECT NO. 104124, WASHINGTON STREET ACCESS IMPROVEMENTS, AT SAN DIEGO INTERNATIONAL AIRPORT

WHEREAS, in June 2010, the San Diego County Regional Airport Authority Board ("Board") approved the 2011-2015 Fiscal Year Capital Improvement Program ("CIP"); and

WHEREAS, included within the CIP is a project to improve airport access at Washington Street, to serve the Central Receiving and Distribution Center ("CRDC"); and

WHEREAS, this project will improve traffic circulation and provide unimpeded access to the CRDC and Air Cargo facilities; and

WHEREAS, these improvements comply with agreements with the U.S. Marine Corps Recruit Depot ("MCRD") approved by the Board on January 25, 2012; and

WHEREAS, the San Diego County Regional Airport Authority ("Authority") issued a Bid Solicitation Package for Project No. 104124 on April 11, 2012; and

WHEREAS, on May 15, 2012, the Authority opened sealed bids received in response to the Bid Solicitation Package; and

WHEREAS, after evaluation of bids, Built Pacific, Inc., the apparent low bidder, had numerous mathematical errors, which resulted in an adjustment to its bid amount from \$2,798,970.83 to \$2,930,643.00; and

WHEREAS, the lowest bid, submitted by Flatiron West, Inc., in the amount of \$2,873.776.00 is considered responsive; and

WHEREAS, Authority 5.14, Small Business, Local Business and Service Disabled Veteran Owned Small Business Goal and Preference Program, was applied in the selection process and it allowed Flatiron West, Inc., to maintain its low bid status; and

WHEREAS, Flatiron West, Inc., submitted a bid of \$2,873,776.00 and the Authority's staff has duly considered the bid, and has determined Flatiron West, Inc., is responsible and that its bid is responsive in all material respects; and

WHEREAS, the Board believes that it is in the best interest of the Authority and the public that it serves, for the Board to award Flatiron West, Inc., the contract for Project No. 104124, Washington Street Access Improvements, upon the terms and conditions set forth in the Bid Solicitation Package.

BE IT FURTHER RESOLVED that the Authority's President/CEO or designee is hereby authorized to execute and deliver such contract to Flatiron West, Inc.; and

BE IT FURTHER RESOLVED that the Authority and its officers, employees, and agents are hereby authorized, and directed to do and perform such acts as may be necessary or appropriate in order to effectuate fully the foregoing resolution; and

BE IT FURTHER RESOLVED that the Board FINDS that this Board action is not a "project" subject to California Environmental Quality Act CEQA ("CEQA"), Pub. Res. Code §21065; and is not a "development" as defined by the California Coastal Act Pub. Res. Code Section §30106.
