4. PRESENTATION AND REQUEST FOR POLICY DIRECTION ON AIRSPACE FACTOR – SAN DIEGO INTERNATIONAL AIRPORT - AIRPORT LAND USE COMPATIBILITY PLAN:

Angela Jamison, Manager, Airport Planning, provided a presentation, which included Compatibility Factors, Coordination Efforts, Purpose of Airspace Protection Policies, Airspace Protection Terms, Airspace Policy – Current ALUCP, City of San Diego Airport Approach Overlay Zone (AAOZ), Proposed Airspace Factor Boundary – Revised, Airspace Protection Boundary Considerations, Proposed Airspace Factor Boundary, Threshold Siting Surfaces, Cross-Section of Runway 27 Approach Airspace, Cross-Section of Runway 9 Approach Airspace, Purpose of Airspace Protection Policies, and Proposed Airspace Policies.

In response to Board Member Boland's concerns regarding the difference between the City of San Diego zones and the ALUCP, Mark Johnson, of Ricardo & Associates, stated that the City must make its local general plan, community plan, and ordinances (including the AAOZ) consistent with the ALUCP and that they may choose to make these more restrictive than the ALUCP, which would still be consistent.

RECOMMENDATION: Receive the report and provide policy guidance on the airspace protection compatibility factor.

ACTION: Moved by Commissioner Robinson and seconded by Commissioner Boland to approve staff's recommendation to move forward with the proposed airspace boundary map and policies as outlined within the staff report on pages 9-16. RECOMMENDATION: Direct staff to prepare amendments to the Agua Caliente Airstrip, Borrego Valley Airport, Fallbrook Community Airpark, Jacumba Airstrip, McClellan-Palomar Airport, Ocotillo Airstrip, and Ramona Airport - Airport Land Use Compatibility Plans, along with associated environmental documentation for Airport Land Use Commission (ALUC) consideration by the end of 2011.
