CALL TO ORDER: AAC Chair Deborah Van Huis called the meeting of the Art Advisory Committee to order at 9:04 a.m. on Wednesday, January 27, 2016, at San Diego International Airport, Administration Building Board Room, 3225 N. Harbor Drive, San Diego, CA 92101.

PLEDGE OF ALLEGIANCE: Van Huis led the pledge of allegiance.

NEW BUSINESS:

- ACTION - APPROVAL OF MINUTES:** Committee Member Chike Nwoffiah moved to approve the minutes of the October 21, 2015 meeting. The Motion was seconded by Committee Member Michael Soriano. **Motion Passed unanimously.**
- ACTION - APPOINT ARTIST SELECTION PANEL MEMBERS:** Art Program Manager Lauren Lockhart gave an overview of the Wind Tunnel Wall Public Art Opportunity. She shared that when last discussed the project was temporarily suspended, but due to the recent rain fall the project has been reinstated. Committee Member Indra Gardiner asked if the project would be at risk of being suspended again due to the state's inconsistent rainfall. Van Huis echoed her comments and asked if other environmental elements are of concern. Lockhart informed the committee that the project would feature drought tolerate plants and would also rely on the Landscape Architect to recommend suitable plants for the site. Committee Member Gleason expressed concerns over the opportunity description; he commented that the artist should drive the project once he or she is selected and recommended that the description be broadened. Lockhart confirmed that the artist would guide the process throughout the project. Committee Member Bolton inquired about the selection process. Lockhart informed the committee that staff would release two Requests for

Qualifications; a living wall expert will be selected by an internal panel, and an artist will be selected by a panel of art and design professionals. Gleason moved to approve the recommended artist selection panel members. The Motion was seconded by Gardiner. **Motion Passed unanimously.**

It was agreed that Soriano would serve as the committee liaison on the panel.

3. **ACTION - APPROVE 2018 TEMPORARY EXHIBITION THEME:** Lockhart gave an overview of the proposed exhibition theme, *Word Play*, for the 2018 exhibition calendar year (January-December 2018). She listed several potential community outreach and performance opportunities related to the exhibition theme. Gleason asked that the draft language for the call to artists be rewritten to reflect the lengthier description with specific examples to encourage artists and organizations to apply. Nwoffiah offered to introduce stakeholders from the Alliance for California Traditional Arts, Aikuma Project, and Sounds of California to the airport's Art Program for potential collaboration opportunities related to the exhibition. Gleason moved to approve the 2018 temporary exhibition, *Word Play*, provided that the description is revised for the call for proposals. The Motion was seconded by Gardiner. **Motion Passed unanimously.**
4. **PRESENTATION - PARKING PLAZA PUBLIC ART PROJECT:** Lockhart presented Ball-Nogues Studio's conceptual design proposal for the Parking Plaza. Gardiner inquired about past projects of a similar design and color variation. Lockhart shared that this concept, to her knowledge, would be the first of its kind and also shared that the artist team has experience in creating optical illusions using similar materials. Nwoffiah inquired about the materials' transparency. Lockhart explained that the materials will not be translucent, but the artists will have openings within the piece to maintain line of sight and has suggested that artist team decrease the density of the material. Van Huis inquired about the attachment method of the material. Lockhart explained that the engineers will work with the artist team to determine the best attachment method. Soriano inquired about additional lighting for evening hours. Lockhart stated that lighting has yet to be determined, but confirmed that additional lighting would illuminate the piece at night. Van Huis expressed concerns regarding exposure of the work to the elements. Lockhart assured the committee that the artist team will treat their materials with protective coating to ensure that they can be maintained at this exterior site. Gleason stated that the proposal does not assist with way finding as described in the project description and that the artwork is not thoroughly integrated into the building. Lockhart stated that she would share the committee's comments with the artist team, who will present a revised conceptual proposal at the March 11 meeting.
5. **PRESENTATION - PALM STREET PARK PUBLIC ART PROJECT:** Lockhart presented Legge Lewis Legge's conceptual design proposal for Palm Street Park. Gardiner inquired about a site for passengers to wait and about safety features such as railings. Lockhart noted that passengers would not be required to pass through the park to arrive at the shuttle stop. She also shared that the landscape will have a gradual ascent/descent with railings for passengers at the lower crest. The artist would like to create an integrated design for the railings. Soriano expressed concerns about line of sight to the shuttle pick up location. Gleason praised the artist team for addressing key elements in the project description and echoed Soriano's comment. He also inquired about parking. Lockhart and Committee Member Bolton asserted that street parking is currently available, but that there are no plans for additional parking at the site. Soriano and Bolton expressed concerns about liability issues. Lockhart stated that she would share the committee's comments with the artist team, who will present a revised conceptual proposal at the March 11 meeting.

- Rental Car Center Public Art Projects: Lockhart announced the completion of Christian Moeller and Amy Landesberg's installations and provided an update on Ueberall International's *Dazzle* project, scheduled to be complete late 2016.

- *Point of Entry*: Lockhart presented the artwork recently installed for the 2016 temporary exhibition *Point of Entry*.

— Performing Arts Program:

- Lockhart provided an overview of recent performing arts programming.

Phase 2: Conceptual Design

Conceptual design

Working in collaboration with the design team, we envision shaping the entire site, approximately 250 x 115 feet, into a dramatic work of land art. The park will act as both a destination for aircraft enthusiasts and an airport gateway for travelers coming by public transit. Clearly visible from the air, this distinct earthwork will also have a strong identity as seen from aircraft landing at the airport.

Lifting off the ground

Our concept involves turning the entire park into a dynamic and engaging spatial experience—serving as both gateway and destination. As a gateway, the park will serve as the northeastern entrance used by travelers coming to the airport via public transit. As a destination, the park will allow visitors a fresh and inviting perspective and vantage point from which to observe aircraft at the San Diego Airport. We begin by exploring how the park itself can elevate people off the ground. This basic concept builds on the simple idea of shifting a person's perspective and position in space to allow both a clear view of the runway and aircraft landing at the airport.

A slope across the width of the site would allow a gentle rise of the landscape high enough to afford a view of the airfield beyond. The rise culminates in a ridge-line at the highest point followed by a slight downslope toward the runway.

We explore various angles to this slope and ridge-line relative to the approach, runway, surrounding infrastructure and the city itself.








We provide an ADA-accessible route up to the ridge-line and viewing area. From the Pacific Highway side, the landscape would be connected with the street edge at grade. From the Admiral Boland side, the park will appear to float above the ground.

The park and slope will be populated with trails, seating, lounging and lighting for both exercise, relaxation and the observation of aircraft on approach and landing, as well as other airport activities.

All accessible spaces will be safe and meet all code requirements for edge protection in areas where there is a drop off of more than 30".





Study model elevation: from Pacific Highway

Magenta indicates the primary circulation pathways. Other pathways will be developed throughout the park.




Plan sketch level 1: footprint

Lighting

At night, soft, recessed lighting within edges of pathways and seating safely lights the way without glare which obstructs views. Lighting built into the underside of the Airside overhang fully illuminates the sidewalk and street below.




