# Report of Determinations of Consistency with Airport Land Use Compatibility Plans

Pursuant to Airport Authority Policy 8.30, and acting in its delegated capacity as the Airport Land Use Commission (ALUC) for San Diego County, Airport Authority staff has issued the following consistency determinations per their respective ALUCPs:

### **San Diego International Airport ALUCP:**

### Construction of Two Attached Residences at 3044 C Street, City of San Diego

Deemed Complete and Conditionally Consistent on August 23, 2021

<u>Description of Project</u>: The project involves the construction of two attached residences on a property with an existing detached residence to remain.

Noise Contours: The proposed project lies within the 65-70 decibel Community Noise Equivalent Level (dB CNEL) noise exposure contour. The ALUCP identifies residential uses located within the 65-70 dB CNEL noise contour as conditionally compatible with airport uses, provided that the residences are sound attenuated to 45 dB CNEL interior noise level. The ALUCP requires that an avigation easement for aircraft noise and height be recorded with the County Recorder. Therefore, as a condition of project approval, the residences must be sound attenuated to 45 dB CNEL interior noise level and an avigation easement for aircraft noise and height must be recorded with the County Recorder.

<u>Airspace Protection Surfaces</u>: The maximum height of the proposed project structure will be 270 feet above mean sea level (40 feet above ground level). The proposed project is located outside the SDIA Threshold Siting Surface (TSS). The proposed project is in compliance with the ALUCP airspace protection surfaces because the project sponsor has certified that notice of construction is not required to the Federal Aviation Administration (FAA) because the project is located within an urbanized area, is substantially shielded by existing structures or natural terrain, and cannot reasonably have an adverse effect on air navigation.

Safety Zones: The proposed project is located outside all Safety Zones.

<u>Overflight Notification</u>: The proposed project is located within the overflight notification area. The ALUCP requires that a means of overflight notification be provided for new residential land uses. In instances when an avigation easement is required, the overflight notification requirement is satisfied.

# Construction of Two Attached Residential Units at 2625-2627 Bayside Lane, City of San Diego

Deemed Complete and Conditionally Consistent on September 14, 2021

<u>Description of Project</u>: The project involves the construction of two attached residential units.

Noise Contours: The proposed project lies within the 60-65 decibel Community Noise Equivalent Level (dB CNEL) noise exposure contour. The ALUCP identifies residential uses located within the 60-65 dB CNEL noise contour as conditionally compatible with airport uses, provided that the residences are sound attenuated to 45 dB CNEL interior noise level. Therefore, as a condition of project approval, each residence must be sound attenuated to 45 dB CNEL interior noise level.

<u>Airspace Protection Surfaces</u>: The maximum height of the proposed project structure will be approximately 38 feet above mean sea level (30 feet above ground level). The proposed project is located outside the SDIA Threshold Siting Surface (TSS). The proposed project is in compliance with the ALUCP airspace protection surfaces because the project sponsor has certified that notice of construction is not required to the Federal Aviation Administration (FAA) because the project is located within an urbanized area, is substantially shielded by existing structures or natural terrain, and cannot reasonably have an adverse effect on air navigation.

Safety Zones: The proposed project is located outside all Safety Zones.

<u>Overflight Notification</u>: The proposed project is located within the overflight notification area. The ALUCP requires that a means of overflight notification be provided for new residential land uses. Therefore, as a condition of project approval, a means of overflight notification must be provided.

# Construction of Detached Residential Unit at 4462 Santa Monica Avenue, City of San Diego

Deemed Complete and Conditionally Consistent on September 16, 2021

Meeting Date: October 7, 2021

<u>Description of Project</u>: The project involves the construction of a detached accessory residence on a property with an existing primary residence to remain.

Noise Contours: The proposed project lies within the 60-65 decibel Community Noise Equivalent Level (dB CNEL) noise exposure contour. The ALUCP identifies residential uses located within the 60-65 dB CNEL noise contour as conditionally compatible with airport uses, provided that the accessory residence is sound attenuated to 45 dB CNEL interior noise level. Therefore, as a condition of project approval, the accessory residence must be sound attenuated to 45 dB CNEL interior noise level.

<u>Airspace Protection Surfaces</u>: The maximum height of the proposed project structure will be approximately 205 feet above mean sea level (25 feet above ground level). The proposed project is located outside the SDIA Threshold Siting Surface (TSS). The proposed project is in compliance with the ALUCP airspace protection surfaces because a determination of no hazard to air navigation has been issued by the Federal Aviation Administration (FAA).

Safety Zones: The proposed project is located outside all Safety Zones.

Overflight Notification: The proposed project is located within the overflight notification area. The ALUCP requires that a means of overflight notification be provided for new residential land uses. Therefore, as a condition of project approval, a means of overflight notification must be provided.

### **Gillespie Field ALUCP:**

## Construction of Detached Residential Unit at 8589 Atlas View Drive, City of Santee

Deemed Complete and Conditionally Consistent on September 1, 2021

<u>Description of Project</u>: The project involves the construction of a detached accessory dwelling unit (ADU) to an existing detached residence on the property.

<u>Noise Contours</u>: The proposed project lies within the 60-65 decibel Community Noise Equivalent Level (dB CNEL) noise exposure contour. The ALUCP identifies residential uses located within the 60-65 dB CNEL noise contour as conditionally compatible with airport uses, provided that the ADU is sound attenuated to 45 dB CNEL interior noise level. Therefore, as a condition of project approval, the ADU must be sound attenuated to 45 dB CNEL interior noise level.

Meeting Date: October 7, 2021

<u>Airspace Protection Surfaces</u>: The maximum height of the proposed project structure will be 402 feet above mean sea level (14 feet above ground level). The proposed project is in compliance with the ALUCP airspace protection surfaces because a determination of no hazard to air navigation has been issued by the Federal Aviation Administration (FAA).

<u>Safety Zones</u>: The proposed project is located within Safety Zone 2. The ALUCP identifies residential uses located within Safety Zone 2 as incompatible with airport uses. However, Policy 2.11.4(b)(1) of the ALUCP provides that construction of a single-family residence including an ADU on a legal lot of record is compatible within Safety Zone 2 provided that the local zoning allows for residential use. The project proposes an ADU on a legal lot of record that is zoned for residential use and is therefore compatible with that policy to be located within Safety Zone 2.

<u>Overflight Notification</u>: The proposed project is located within the overflight notification area. The ALUCP requires that a means of overflight notification be provided for new residential land uses. Therefore, as a condition of approval, a means of overflight notification must be provided.

## Construction of 11 Detached Residential Units at 9463 Slope Street, City of Santee

Deemed Complete and Conditionally Consistent on September 7, 2021

<u>Description of Project</u>: The project involves the construction of 11 detached residential units on a property of 2.46 acres.

Noise Contours: The proposed project lies within the 60-65 decibel Community Noise Equivalent Level (dB CNEL) noise exposure contour. The ALUCP identifies residential uses located within the 60-65 dB CNEL noise contour as conditionally compatible with airport uses, provided that the residences are sound attenuated to 45 dB CNEL interior noise level. Therefore, as a condition of project approval, each residence must be sound attenuated to 45 dB CNEL interior noise level.

<u>Airspace Protection Surfaces</u>: The maximum height of the proposed project structures will be 467 feet above mean sea level (23 feet above ground level). The proposed project is in compliance with the ALUCP airspace protection surfaces because a determination of no hazard to air navigation has been issued by the Federal Aviation Administration (FAA).

<u>Safety Zones</u>: The proposed project is located within Safety Zone 3. The ALUCP identifies residential uses located within Safety Zone 3 as conditionally compatible with airport uses, provided that the project does not exceed a density of 20 units per acre and provides at least 10 percent of a site of more than 10 acres as open land. The project proposes 4.5 units per acre, and the property only comprises 2.46 gross acres. Therefore, the project complies with the Safety Zone 3 limitations, and no open land is required.

<u>Overflight Notification</u>: The proposed project is located within the overflight notification area. The ALUCP requires that a means of overflight notification be provided for new residential land uses. Therefore, as a condition of project approval, a means of overflight notification must be provided.
