Total passengers were up 6.5% in February on a 5.1% increase in seats and a 0.5 percentage point decrease in load factor. February 2020 was a leap year with 29 days, an additional 3.6% in capacity was due to the increase in days.

International Cargo tons are up 15.7% due to increased tonnage reported by Japan Airlines. However, overall cargo was down 7.9% primarily due to FedEx reporting a 9.3% decrease in total cargo and Hawaiian reporting significant decline as they moved some operations to a smaller aircraft.










5-Year Monthly Passenger Trend
