Total passengers were down 55.0% in March on a 1.3% increase in scheduled seats and an estimated 40.6 percentage point decrease in load factor. Traffic in the first couple of weeks of March tended to be on trend with expectations. However, on March 12, 2020, the Mayor of San Diego issued a State of Emergency due to COVID-19 pandemic and on March 19, 2020, a stay at home order was announced by the state of California, further impacting travel and passenger levels.

International Cargo tons were down 2.2% due to reduced operations. Overall cargo was down 12.7% primarily due to FedEx reporting a 12.1% reduction in cargo year over year in addition to overall reduced passenger operations resulting in lower reported belly cargo.





YTD Operations By Type






YTD Revenue Passengers By Terminal Area
