Total passengers were down 67.4% in October on a 58.1% decrease in scheduled seats and an estimated 18.6 percentage point decrease in load factor. Traffic continues to be significantly impacted by the COVID-19 pandemic and some carriers continue to block the middle seats, effectively capping the load factor at 66%. Current international service includes Los Cabos, Mexico and Puerto Vallarta, Mexico.










YTD Revenue Passengers By Terminal Area
