Allegiant Air Begins Seasonal Service to Five Destinations from San Diego International Airport

SAN DIEGO – May 27, 2021 – Today, [Allegiant Air](#) began seasonal nonstop service from [San Diego International Airport](#) (SAN) to Mesa Ariz. via Phoenix-Mesa Gateway Airport (AZA). The airline will begin seasonal nonstop service to Kalispell, Mont. via Glacier Park International Airport (FCA) and Pasco, Wash. via Tri-Cities Airport (PSC) tomorrow, May 28. Flights to all three destinations will be offered until August 16. Beginning June 3, Allegiant Air will offer nonstop service to Bozeman, Mont. via Bozeman Yellowstone International Airport (BZN) through August 15. Beginning July 1, Allegiant Air will offer nonstop service to Des Moines, Iowa via Des Moines International Airport (DSM) through August 15.

“We appreciate Allegiant adding seasonal service just in time for the summer travel season,” said Kimberly Becker, President and CEO of the San Diego County Regional Airport Authority. “These new destinations are gateways to recreational areas like Tonto National Forest, Glacier National Park, the Columbia Valley wine country, and Yellowstone National Park. While many San Diegans may want to explore these hidden gems, we welcome those coming to San Diego to take advantage of our sun, beaches, attractions, and dining offerings.”

The new routes join other seasonal nonstop flights already offered by Allegiant Air to Billings, Mont., El Paso, Texas, Eugene, Ore., Idaho Falls, Ida., Las Vegas, Nevada, and Medford, Ore. To view the latest schedules, fares, and flight times, please visit allegiantair.com.

SAN has achieved [Airports Council International's](#) (ACI) [Airport Health Accreditation](#) for its “Let’s Go Safely” program which prioritizes the health and safety of passengers, employees, and the community through several modifications and improvements at the airport.
