Pursuant to California Public Utilities Code §§ 21670-21679.5, the Airport Land Use Commission ("Commission") is responsible for coordinating the airport planning of public agencies within San Diego County. The Commission has the legal responsibility to formulate airport land use compatibility plans ("ALUCPs") that will (a) provide for the orderly growth of each public airport and the areas surrounding the airport within the County and (b) safeguard the general welfare of the inhabitants within the vicinity of each airport and the public in general. Pursuant to §21670.3, the San Diego County Regional Airport Authority serves as the Commission.

This Agenda contains a brief general description of each item to be considered. The indication of a recommended action does not indicate what action (if any) may be taken. *Please note that Agenda items may be taken out of order.* If comments are made to the Commission without prior notice or are not listed on the Agenda, no specific answers or responses should be expected at this meeting pursuant to State law.

Staff Reports and documentation relating to each item of business on the Agenda are on file in the Office of the Authority Clerk Department and are available for public inspection.

NOTE: Pursuant to Authority Code Section 2.15, all Lobbyists shall register as an Authority Lobbyist with the Authority Clerk within ten (10) days of qualifying as a lobbyist. A qualifying lobbyist is any individual who receives \$100 or more in any calendar month to lobby any Commission Member or employee of the Authority for the purpose of influencing any action of the Authority. Policy for Public Participation in Board, Airport Land Use Commission (ALUC), and Committee Meetings (Public Comment)

Airport Land Use Commission Staff Report

Report of Determinations of Consistency with Airport Land Use Compatibility Plans

Pursuant to Airport Authority Policy 8.30 and acting in its delegated capacity as the Airport Land Use Commission (ALUC) for San Diego County, Airport Authority staff has issued the following consistency determinations per their respective Airport Land Use Compatibility Plans (ALUCPs). Authority Policy 8.30(3)(f)(2) states that any determination made by Authority staff in its delegated capacity shall be placed on the ALUC agenda for the next available meeting and shall be considered final if no further action is taken by the ALUC.

Gillespie Field ALUCP:

Construction of 100 Attached Residential Units at 9506 Mission Gorge Road, City of Santee

Deemed Complete and Conditionally Consistent on September 2, 2025

<u>Description of Project</u>: The project involves the construction of 100 attached residential units.

Noise Contours: The proposed project lies partially within the 60-65 decibel Community Noise Equivalent Level (dB CNEL) noise contour. The ALUCP identifies residential uses located within the 60-65 dB CNEL noise contour as conditionally compatible with airport uses, provided that the residences are sound attenuated to 45 dB CNEL interior noise level. Therefore, as a condition of project approval, each residence within the 60-65 dB CNEL contour must be sound attenuated to 45 dB CNEL interior noise level.

<u>Airspace Protection Surfaces</u>: The maximum height of the proposed project structures will be approximately 374 feet above mean sea level (36 feet above ground level). The proposed project is in compliance with the ALUCP airspace protection surfaces because a determination of no hazard to air navigation has been issued by the Federal Aviation Administration (FAA).

<u>Safety Zones</u>: The proposed project site is located within Safety Zones 4 and 6, but all structures are located within Safety Zone 6. The ALUCP identifies residential uses located within Safety Zone 6 as compatible with airport uses.

<u>Overflight Notification</u>: The proposed project site is located within Safety Zones 4 and 6, but all structures are located within Safety Zone 6. The ALUCP identifies residential uses located within Safety Zone 6 as compatible with airport uses.

<u>Interests Disclosure</u>: The property is owned by BEMG Santee LLC, whose sole managing member is disclosed as Loren Borstein of Los Angeles. The architect is Summa Architecture of Bonsall. The civil engineer is Rick Engineering of San Diego. The landscape architect is Studio Pad of Laguna Hills.

Construction of Accessory Dwelling Unit at 8605 Ellsworth Lane, City of Santee

Deemed Complete and Conditionally Consistent on September 2, 2025

<u>Description of Project</u>: The project involves the construction of an accessory dwelling unit with the existing residence to remain.

<u>Noise Contours</u>: The proposed project lies within the 60-65 decibel Community Noise Equivalent Level (dB CNEL) noise exposure contour. The ALUCP identifies residential uses located within the 60-65 dB CNEL noise contour as conditionally compatible with airport uses, provided that the accessory dwelling unit is sound attenuated to 45 dB CNEL interior noise level. Therefore, as a condition of project approval, the accessory dwelling unit must be sound attenuated to 45 dB CNEL interior noise level.

<u>Airspace Protection Surfaces</u>: The maximum height of the proposed project structure will be approximately 402 feet above mean sea level (12 feet above ground level). The proposed project is in compliance with the ALUCP airspace protection surfaces because the project sponsor has certified that notice of construction is not required to the Federal Aviation Administration (FAA) because the project is located within an urbanized area, is substantially shielded by existing structures or natural terrain, and cannot reasonably have an adverse effect on air navigation.

<u>Safety Zones</u>: The proposed project is located within Safety Zone 4. The ALUCP identifies residential uses located within Safety Zone 4 as conditionally compatible with airport uses, provided that the project complies with a density of 20 units per acre; however, ALUCP Policy 2.11.4(b)(1) provides that, notwithstanding any other ALUCP limitations, construction of a single-family home, including a second dwelling unit as defined by state law or local ordinance, is compatible on a legal lot of record in all safety zones except Safety Zone 1 if such use is permitted by local land use regulations. The project complies with these standards such that Safety Zone 4 density limitations need not be applied.

<u>Overflight Notification</u>: The proposed project is located within the overflight notification area. The ALUCP requires that a means of overflight notification be provided for new residential land uses. Therefore, as a condition of project approval, a means of overflight notification must be provided for the residential unit.

<u>Interests Disclosure</u>: The property is owned by Ace and Theresa Dion of Santee. The designer is Emmanuel Estrada. The home installer is Scott Fears.
