SECTION I

In compliance with San Diego International Airport Rules and Regulations, an access investigation involving a criminal history records check and possible employment history verification, must be completed to receive an airport identification badge (SAN ID Badge) allowing unescorted access to the airport's restricted Security Identification Display Area (SIDA). All information is subject to audit and investigation at any time by the Authority. Please be prepared to present two (2) forms of identification from the list of acceptable documents. **Note:** this form must be typed. Handwritten copies will not be accepted.

Individuals who are not US Citizens must provide:

- Alien Registration Number (ARN); or
- I-94 Arrival/Departure Form Number; or
- Non-immigrant Visa with temporary I-551 notation

Individuals born abroad or naturalized must provide:

- Current US Passport information; or
- Certificate of Naturalization copy of document acceptable; or
- Certificate of U.S. Citizenship copy of document acceptable; or
- Certification of Report of Birth (DS-1350) copy of document acceptable if not being used as identification; or
- Consular Report of Birth Abroad (FS-240, FS-545) copy of document acceptable if not being used as identification
