

LIST OF ACCEPTABLE DOCUMENTS

***Per 49 CFR 1542.209(e)(3) one ID MUST contain the individual's photograph**
Acceptable ID combinations*: List A and B | List A and C | List B and C

ALL documents must be original and unexpired

Born Abroad: If you are **born** outside the United States you are encouraged to provide **one** of the following: 1) current US Passport information; 2) Alien Registration #; 3) Form I-94 #; 4) Non Immigrant Visa # (with I-551 printed notation); or 5) Certification of Birth Abroad (DS-1350, FS-545 or FS-240).

Non-US Citizen: If you are **not a US Citizen** you are required to provide **one** of the following: 1) Alien Registration #; 2) Form I-94 #; or 3) Non Immigrant Visa # (with I-551 printed notation).

Employment Authorization Document that contains a photograph (Form I-766)	Voter's registration card	Native American tribal document
For an individual temporarily authorized to work for a specific employer because of his or her status or parole: a. Foreign passport; and b. Form I-94 or Form I-94A that has the following: (1) The same name as the passport; and (2) An endorsement of the individual's status or parole as long as that period of endorsement has not yet expired and the proposed employment is not in conflict with any restrictions or limitations identified on the form.
