Policy for Public Participation in Board, Airport Land Use Commission (ALUC), and Committee Meetings (Public Comment)

- 1) Persons wishing to address the Board, ALUC, and Committees shall submit a "Request to Speak" form prior to the initiation of the portion of the Agenda containing the item to be addressed (e.g., Public Comment and General Items). Failure to submit a form shall not preclude testimony, if permission to address the Board is granted by the Chair.
- 2) The Public Comment Section at the beginning of the Agenda is reserved for persons wishing to address the Board, ALUC, and Committees on any matter for which another opportunity to speak is not provided on the Agenda, and on matters that are within the jurisdiction of the Board.
- 3) Persons wishing to speak on specific items listed on the Agenda will be afforded an opportunity to speak during the presentation of individual items. Persons wishing to speak on specific items should reserve their comments until the specific item is taken up by the Board, ALUC and Committees.
- 4) If many persons have indicated a desire to address the Board, ALUC and Committees on the same issue, then the Chair may suggest that these persons consolidate their respective testimonies. Testimony by members of the public on any item shall be limited to three (3) minutes per individual speaker and five (5) minutes for applicants, groups and referring jurisdictions.

- 6) After a public hearing or the public comment portion of the meeting has been closed, no person shall address the Board, ALUC, and Committees without first obtaining permission to do so.

Highlights

- 915 community members participated
- 10 security screening checkpoint lanes used (6 primary & 4 flex lanes)
- 270 test bags inducted into Baggage Handling System
- All NT1 airlines and concessionaires involved
- 30 volunteers helped to manage simulation
- Surveys collected feedback from community participants
- Debrief discussions held with stakeholders

Outcomes [partial list]

- Identified passenger congestion or confusion points
- Installed temporary wayfinding in targeted locations
- Adjusted paging system settings
- Modified escalator directions
- Reformatted Flight Information Displays (FIDS)
- Revised some employees' badge access permissions
- Shifted post-opening Customer Support staff locations
- Reinforced operational training content to employees






Late Evening Arrivals (9/22) & Full Operations (9/23)

Transition Command Center (TCC)

- Activated for 26.5 hours over 9/22 & 9/23
- Representatives from key Airport Authority teams
- Hub for communications and decision-making
- Situational awareness thru multiple camera feeds
- Supported in-terminal staff with any response needs
- Most issues elevated to the TCC were relatively minor and/or quickly addressed
- Overall, NT1 building and PAX processing systems functioned as designed and tested










Post-Opening Customer Support











2025/2026 Nonstop Destinations from SAN




87 Nonstop Destinations; 7 New/Resumed in 2025/2026

Average Seats Daily Each way (2025)




